

Henry Osborn, gentleman of Salem, for \$1960 sells to Nathaniel Osgood of Salem, mariner, land and dwelling house at Essex and Pine Sts. (same dimensions.) (abutters to the S. are Edmund Johnson and Ichabod Tucker. To the W. is Benjamin Goodhue.)

William Ward of Salem, mariner, for \$2324 sells to Henry Osborn, gentleman, of Salem that dwelling house I have leased to and which has been improved by Mr. Henry Gardner with land under and adjoining which I bought of Matthew Mansfield Books 161 p. 50, containing about $\frac{3}{4}$ acre bounding NW on Essex St.; NE on land of William Lang, SE on land of Nathaniel Repes dec. and SW on land formerly of James Odell now of Benjamin Goodhue esq. and partly by land hereinafter mentioned and conveyed to said Osborn. Also a piece of land which Mansfield bought of Goodhue Book 152 p. 273 and which Mansfield conveyed to me being all the land which Goodhue owned lying 8" NE from his dwelling house running $18\frac{1}{2}$ ' in from street and adjoining land just described.

161 50 September 16, 1796

Matthew Mansfield merchant, of Salem for \$2000 sells to

William Ward, mariner, of Salem that dwelling house I have here to fore leased to and which has been improved by Capt. Daniel Pierce, together with the land under and adjoining which I bought of Benjamin Gerrish (et al.) by deed Book 98 p. 167 which land contains about $\frac{3}{4}$ acre, bounding NW on Essex St.; NE on land of William Lang; SE on land formerly of Nathaniel Ropes dec.; SW on land formerly of James Odell dec. now of Benjamin Goodhue esq. (also the small piece of land adjoining, 8" from Goodhue's house same as above.)

98 167 May 22, 1753

Benjamin Gerrish esq.; Benjamin Gerrish Jr. merchant, with consent of Margaret his wife for £ 53 6 sh 8 p sells to Matthew Mansfield, cordwainer, a piece of land containing about $\frac{3}{4}$ acre butting NW on the main street; NE on land of John Ropes; SE on land of Nathaniel Ropes; SW on land of James Odell.

TAX RECORDS at City Hall

These records only go back to 1781. As early as 1781 Matthew Mansfield was paying taxes on a "mansion house". These taxes were fairly large compared to other assessment nearby, indicating it was a big house.

Curwin Papers "Houses built in Salem" covers years 1750-1773

There is no mention of Matthew Mansfield. Therefore it seems extremely unlikely that 401 Essex St. was built before 1773.

Joseph Felt - Annals of Salem Vol. I p.414

"down to 1774 our dwellings with very few exceptions were of wood. (early brick houses listed) -- "another in Summer St. erected for Matthew Mansfield as a store in 1768 and since 1800 raised a 3rd story and much altered."

Essex Institute Historical Collection Vol. 6 p.100

"a brick house built 3 years ago by M. Mansfield occupied by Mr. Newhall, a tinman." - from MS. of Col. Benjamin Pickman written in 1793. This building mentioned was a store located on Washington St. near Foodland.

Summary

Although Matthew Mansfield bought the land at 401 Essex St. in 1753, and sold it with a house on it in 1796 it has been difficult to pin the date of the house to a single

year. Finally a last search through Index of the E.I.H.C. (see below) produced the following:

Vol. 21 p. 223 Early Recollections of Upper Essex St. by Oliver Thayer. "The next (house) on the corner of Pine St. opposite was known by the name of the Osborn House, purchased by Capt. Nathaniel Osgood about 1807 or 1808 (deed dated 1814, actually) where he and his family resided for some years. The house was then sold and removed to (Federal) St. Upon the site, Capt. Osgood built a new brick edifice now standing."

Nathaniel Osgood in 1806 married Elizabeth Cowan. Children included Nathaniel H. b. 1807, Charles b. 1809, Elizabeth b. 1812, Lucy Ann b. 1815, and Edward A. b. 1825. His daughter Elizabeth trustee under his will sold the house in 1867.

Guessing according to Oliver Thayer's account, I would surmise that Capt. Osgood and his family rented the Osborn house "for some years". Then in 1814 purchased it, removed the old and built the new one. The style of the house is consistant with the early 1800's. I would place the date of the house as c. 1815
