# Eight Beckford Street Built by 1846 for Martha Derby, Widow

### History of the Property:

There have been at least two, and possibly three, houses on or near the site of the present-day Eight Beckford Street. The seventeenth-century structures that once fronted Beckford Street attest to the fact that it is one of the oldest lanes connecting Essex Street, or the "Main" street or highway, and the North River. It was laid out over a century before Federal Street came into existence, and property records refer to it alternatively as Beckford Lane (1657), the "street from Main Street to the North River" (1680), Kitchen's Lane (1783), Turner's Lane (1793), and finally Beckford or Bickford Street (1797).

The lot on which Eight Beckford Street sits was part of a much larger parcel extending from Essex Street to the North River granted to Thomas Cole, a husbandman, in the seventeenth century. After his death in 1679 and his widow's death the following year, the estate was divided equally between the two Cole sons, Abraham and John. Abraham Cole received the southern half, adjacent to Essex Street. In the same year that he came into his inheritance, Abraham sold a "middle lot", roughly approximate to the present lot of Eight Beckford Street, to Joseph Swasey, who promptly built a house upon it [Essex County Registry of Deeds, Book 5, leaf 103]. After Swasey's death in 1703, his widow and son Samuel continued to occupy the property until 1711, when they sold the house, "other buildings", and land "under and adjoining the same" to John Cook, a Salem mariner [E.C.R.D. Book 24, leaf 111].

Three generations of Cooks owned and occupied the parcel of land on Beckford Street throughout the eighteenth century, though the "old dwelling house" was probably pulled down by John Cook III after he came into possession of the property in 1766. After his death in 1804, his heirs, having inherited considerable properties in Salem, conveyed the Beckford Street estate to James Derby, another Salem mariner [E.C.R.D. Book 176, leaves 277-278]. A shop on the premises was noted in the transaction, indicating that the property was not owner-occupied by Cook and his family. James Derby and his family took up residence immediately but continued to lease out the shop.

James Derby died in 1838. His widow, Martha, continued to

resided in the old Cook house for several years, but in 1842 she moved next door, pulled her former house down, and awaited construction of a new Eight Beckford Street. "Uptown" Salem was then in the process of transformation from mixed-use (commercial and residential) dwellings to an exclusively residential neighborhood and larger Greek Revival and Victorian houses were replacing the smaller Colonial ones with their "shops". Construction of the new Derby house was completed by 1846 and Mrs. Derby resided there until her death in 1862. The new, shopless, Eight Beckford Street is clearly displayed on the 1851 Atlas of Salem. Martha Derby's estate was bequeathed indirectly to her Ross grandchildren through their mother, Martha Derby Ross, who also died about this time. By 1864 James D. Ross, a tanner, and Joseph H. Ross, a painter, had taken up residence at Eight Beckford Street [Salem Directories, 1851-64].

The Ross family owned, and various Ross siblings occupied, Eight Beckford Street until 1893. After 1878, some additions and revisions were made on the house, for which the Ross brothers acquired a mortgage. They also appear to have taken in boarders when there was romm [Salem Directories, 1884-1983]. The individual members of the Ross family sold their quarter shares to Charles Fowler in 1893, and the latter conveyed it to his brother, through a mortgage deed, in the following year [E.C.R.D. Book 1378. pages 248-249, and 1418, pages 88-92]. Arthur Fowler, A Boston insurance broker, owned and occupied Eight Beckford Street until his death in 1925. Another round of additions and/or changes were apparently made on the house with the proceeds of a 1905 mortgage for such purpose [E.C.R.D. Book 1769, page 02]. In the early 1920s, Lucy Fowler, a daughter, held music lessons at the house.

Arthur Fowler's children and heirs conveyed Eight Beckford Street to Elizabeth Lehan and Catherine Heffernan in 1926 [E.C.R.D. Book 2645 page 24]. Lehan and Heffernan, apparently overextended financially, sold the heavily-mortgaged property to William and Mary O'Shea of Salem in the following year [E.C.R.D. Book 2683, page 273]. The O'Sheas owned the property for only two years and never occupied the house. 1928 they sold the still heavily-mortgaged property to Ethel R. Gauss of Salem [E.C.R.D. Book 2757, pages 483-484]. Ethel Gauss and her husband John, President and co-owner of Newcomb & Gauss Company, book and commercial printers at One City Hall Avenue in Salem, owned and occupied the house until 1950. After her husband's death, Ethel Gauss sold Eight Beckford Street and other properties for a nominal sum to an apparent relative, Nathalie H. Gregware of Salem [E.C.R.D. Book 3788, page 2921, though Mrs. Gauss continued to reside in the house. her death in 1960, Miss Greqware conveyed Eight Beckford Street to Roger and Virginia L'Heureux of Salem, who bought an adjacent lot from Elizabeth Kiernan in 1983 [E.C.R.D. Book 4711, page 308 and Book 5125, Mr. L'Heureux, an engineer at Sylvania Company, and his wife owned and occupied Eight Beckford Street until 1977, when they conveyed it in two parcels to its present owners [E.C.R.D. Book 6363, page 5481.
