SUMMARY

Thomas Needham was, in his time, a well known Salem cabinet maker and builder. For a few years, he was paying taxes on eight different buildings on various Salem streets.

In 1823 he purchased, in four pieces, a lot of land about 59 ft. along the south side of Essex Street and 80 ft. deep. This land was bounded on the east by land of Thomas West, and on the west by land of Gideon Tucker. The eastern section, approximately 21 ft. along Essex Street by 80 ft. along West's land was the last piece Needham acquired, the deed being recorded on October 3, 1823. The three other parcels Needham had bought in March of 1823. On the same day he bought that last segment, however, he mortgaged the entire lot of land "with a two story shop" on it. No buildings were mentioned in any of the deeds, so it can be concluded that he had erected the shop on the western portion since purchasing those pieces in March. The house #125 is on the eastern half of the lot adjacent to property of Thomas West. By 1845 when Thomas Needham sold the whole property to James Kimball, it had "two wooden buildings thereon".

Tax records fill in the story. For three years, 1827, 1828, 1829 Needham isn't listed as paying any taxes on that property on Essex Street between Thomas West and Gideon Tucker. In 1830 Thomas Needham was assessed for three houses on LibertyStreet (one was his home), a house on WilliamsStreet, a "store" and an "unfinished house" both on Essex Street.

In 1831 these buildings were still listed as "store" and "unfinished house" on Essex Street, but in the subsequent years, Needham was assessed for "house" and "store" on Essex Street. All his other assessments were on other streets.

It seems evident from these tax records that 1830 was the year that #125 Essex Street was built, and the attractive wooden structure shows architectural detail consistent with this period.

Book 233, Page 26 March 8, 1823

Gideon Tucker, merchant, of Salem, for \$650 sells to Thomas Needham land in two pieces. The first one bounded N. on Essex Street 19', on E. by an 8½' way, for 25'-3"; on S. by land of heirs of Nathaniel Phippen 19'; and on W. by land of same heirs 25'-3" to Essex Street. The other piece situated up the common way, beginning at the S.W. corner, bounded on S. by land of J. Richardson 37½'; on W. by land of grantor 11'; on N. by land of heirs of Phippen 20½'; on W. again by Phippen heirs 12'; N. again on land of same heirs and said common way 17'; and E. on land Phippen bought of Fisk's heirs to beginning.

Book 230, Page 275 March 11, 1823

Joseph J. Knap of Salem and wife Abigail (Phippen) for \$550 sell to Thomas Needham, cabinet maker, of Salem, land bounded on W. by Gideon Tucker "on which his house stands" (a jagged lot more or less 10' to 20' wide along a common way). This land having descended from her mother the widow Abigail Phippen and subject to her dower.

Book 230, Page 276 March 11, 1823

Abigail Phippen, widow, of Salem, for \$1.00 releases right of dower in same land described above, to Thomas Needham.

Book 232, Page 270 May 10, 1823

Nancy and Mary Brown for \$800 sell land (described below) to brother Nathaniel Brown.

Book 232, Page 272 October 3, 1823

Nathaniel Brown, of Salem, for \$800 sells to Thomas Needham, of Salem, cabinet maker, a lot of land on Essex Street bounded: beginning on Essex Street and running S. by land of Capt. Thomas West 80' more or less to land of Josiah Richardson; then W. by land of Richardson 11'-6"; then N. partly by land of said Needham and partly by a common passageway about 80' to Essex Street; then E. on Essex Street 21' to beginning; being same premises conveyed to me by my sisters, Nancy Brown and Mary Brown, deed May 10, 1823 and entered just before this.

Book 232, Page 272 October 3, 1823

Thomas Needham. of Salem, mortgages for \$800 to Amos Choate a lot of land on Essex Street bounded on N. by Essex Street 58'-6"; on E. by land of Thomas West 80'; on S. by land of Josiah Richardson about 49'; on W. by land of Gideon Tucker about 80'; being land held by virtue of four deeds, one from Joseph J. Knap and wife, one from Abigail Phippen, both recorded in Book 230, Page 276, and one from Gideon Tucker, Book 233, Page 26, and one from Nathaniel Brown entered just before this, together with a two story wooden shop thereon.

(Mortgage was dicharged in 1826).

Book 351, Page 77 January 28, 1845

Thomas Needham, of Salem, for \$3600 sells to <u>James Kimball</u>, of Salem, a lot of land in Salem with two wooden buildings thereon (same description as above), being all the land I hold by virtue of four deeds (same as above).

Book 1580, Page 259 June 1, 1899

Harriet P. Tyler, of New Bedford, Mary F. Safford, of Washington, Alice B. Smith, of East Orange, N.J., for \$3100 sell to Arthur Feenan, of Salem, land and buildings at 125 Essex Street bounded as follows:

On N. by Essex Street 29.7'; on E. by land formerly of Thomas West 80'-10"; on S. by land formerly of Tucker 20.2'; and on W. on land formerly of Elizabeth Farley 80.1' to said Essex Street, being the premises marked as the estate of James Kimball on plan of estates of James Kimball and Elizabeth Farley made by Chas. A. Putnam Aug. 19, 1868 and copied from a survey of J. H. Nichols Feb. 25, 1846, and being a portion of premises conveyed to the late James Kimball by deed of Thomas Needham, Book 351, Page 77, and devised to us under will of said Kimball, Probate Number 44347.

Book 3146, Page 453 May 27, 1938


Probate Partition under will of <u>Arthur Feenan</u>. Set off to <u>Mary A. McDermott</u>: 125 Essex Street bounded on N. by Essex Street approximately 30'; on E. by land of Arthur M. Feenan about 80'; on S. by other land of Feenan approximately 26'; on W. by land now or late of Perkins estate about 80'.

Book 5728, Page 364 October 16, 1970

Confirms deed Book 5719, Page 322. William V. McDermott, Jr. adm. of estate of Mary A. McDermott, late of Salem, sells to Douglas H. Haley, of Salem, and Richard B. Winick, of Marblehead, land and buildings thereon at 125 Essex Street bounded on N. by Essex Street 29.7'; on E. by land now or late of Thomas West 80'-10"; on S. by land now or late of Tucker 20'-2"; and on W. by land now or late of Elizabeth Farley 80.1'.
