





Summary

On or near the site of the present house at 18 Turner St. there stood a very early house sold by Samuel and Elizabeth Foot in 1747 to John Batten. John married Mary Masury in 1758 and she was left a widow in 1785. She lived on in the Turner St. house which her husband had willed her for her use in her lifetime. Her married daughter and husband bought the cost half of the house and lived in it. We learn from various references that Mary Bateman's husband Michael was not a very satisfactory husband: apparently he ran up a lot of debts. Mary Batten carefully worded her will in 1809 to keep the property which she intended for her daughter's use out of Michael's hands. Mary Batten and her son-in-law both died in 1813. The daughter Mary Bateman, who taught school, died in 1819 and probably her spinster daughter Sarah lived on in the Turner St. house. The other surviving Bateman children were grown and scattered.

In 1829 the four surviving children of Mary Bateman, heirs of their grandmother Mary Batten's homestead sold the property for \$230 to Moses Goodhue, a housewright. Thr explication tax record in which Goodhue's name appears is in 1830 when he was assessed for a house on Carlton St. valued at \$900. The next year, 1831, he was assessed for a house on Turner St. valued at \$1500. (a year later this was noted in the assessor's book as "high" and lowered to \$1000) I

could find no earlier assessed valuation of the property under any Batemans so do not know who was paying the taxes previous to the sale. However the selling price of \$230 in 1829 and the valuation of the house and land in 1831 at \$1500 indicate that substantial changes were made. Moses Goodhue was a carpenter and the earliest City directory lists him and two males (boarders probably) living at 10 Turner St. (old numbering) by 1831. He was already married and had two babies die young. In subsequent years he and his wife raised two daughters who ultimately inherited the property. Moses Goodhue lived on at 10 Turner St, until his death (between 1852 and 1853) and his widow until her death (between 1855 and 1857)

In 1859 Benjamin F. Robinson, a sea captain, purchased one undivided half of the property from the Goodhues' daughter Catherine Cloutman. He was married (his second marriage) to the other Goodhue daughter Abby Ann, who in her right had inherited a undivided half. The Robinsons lived on at 10 Turner St. even after they had sold the property to Mary Flynn in 1877.

Getting back to the origen of the house: the style is hipped roof, front door originally in the center of the long side. (short side to the street) There were originally two chimneys positioned symmetrically, and nearer the back side. Unfortunately these have been completely removed. The windows on both floors, front and street side all have the original inside folding shutters in excellent condition. The trim on the windows and doorframes is of a style popular in the 1830 period. There is nothing in the house either in architecture or construction that would be consistent with a house standing in the 1740s when the Batten family acquired it. By this architectural evidence as well as the tax records, we can safely assume that Moses Goodhus built this house in 1831, the older one having been removed. He probably lived on carlton St. while he was building the Turner St. house and moved in in 1831 when it was completed.
