



NOTES:

As shown, Ephraim Woods purchased this property on December 2, 1854. At that time there was an old house on the lot, formerly the home of Elias Grant. Elias purchased the land and dwelling house from John and Elizabeth Woodbury in March of 1797. It is probable that Mr. Woodbury built the house shortly after his purchase, of the land, in April 1796.

For reasons unknown, Ephraim Woods removed the old house and built the house now known as 164 North St. in its place. This is substantiated by the tax records:

120 North (renumbered in 1877 to 164)
1854 Anna Grant value \$600 not taxed
1855 Ephraim Woods <u>new house</u> - value \$1,000
(Mr. Woods also owned the property adjoining at 122, now 166)
1856 Ephraim Woods #120 house value \$1,000; land \$200
