inventory includes house and 11 poles of land. In 1766 1/3 of the property is set off to the widow for the rest of her life. The rest of the property was judged not "admitting" of further division and valued at £84 10s. She received: the lower room in the east end of the house, the NW corner of the cellar (an area 7' x 8'-7") also that part of the garret which is over the chamber entranceway with privilege of stairs also of the well and the "little house". Also a piece of land in the garden beg. at SW corner, running as fence stands E. 35½', then W. through well 16', then W. 35½' to land late of Robert Stone, and S. 16'.



This also was a part of Edward Woolin's lot, and Hugh Pasco fisherman of Salem had built a house upon it before 1679. Mr. Pasco conveyed

house and lot to Francis Neale sr. (1683) For 135 Mr. Neale conveyed the house and land to Aaron Messervy fisherman of Salem in 1695. Mr. Messervy died in 1706 leaving his widow Susannah and children William, Aaron, John, Mary and Abial. Mr. Messervy made his will in Charles County Maryland and devised all to his wife Cusannah. She subsequently married John Batten and they conveyed the "old dwelling house" and land around it to son Aaron in 1724.


## SUMMARY

The story of this charming 18th Century home is fairly clear from reading the legal documents. Sidney Perley's research shows how Aaron Messervy (sometimes spelled Meserve) who died in 1706 left a widow and five children probably living in their home built in 1679 by Hugh Pasco. After her marriage to John Batten (date unknown) and after her children were grown, Susannah Messervy Batten may have left the old house to live in John Batten's house. At any rate, she and the new husband sold the old Messervy property; the north part with the house to son Aaron, the south part of the lot to son William who had married Ann Wellman only a year or two before. The son Aaron had died by 1742; Mrs. Batten again a widow, went back to live in the old house. (abutters list "land of widow Batten" in later deeds.)

It is likely that William built the house soon after, but we have no evidence until the probate records of his death in 1739. There is no record of any children except his son William whose marriage in 1747 and death at sea are documented. My guess is that after William sr's death, Abigail Messervy continued to live in the house at 20 Turner St. William jr. a mariner, and his wife Ann with the brood of seven children apparently all lived there too. (see 1761 document mentioning his "mansion house") There must have been financial problems: William jr. in 1761 mortgaged the house including his mother's dower rights. Then the next year he was lost at sea. It may have been creditor attempts to evict the family now two widows and the children that prompted the 1766 additional probate document to define the elder widow's dower rights in the house for the


remainder of her life. One wonders if the younger widow remained there: she still had chiliren as young as 6, 8, and 10. My guess is that she did live there too until her death in 1796. Because of the complicated rights of all the Messervy descendents, it wasn't until 1802 that Thomas Barker finally bought up all the rights to 20 Turner St. and it went out of the original family after 3/4 of a century.
