18 Orne St Salem, Mass. This house was built in 1835 by Deacen Joshua Upham, Salem "chemist." At that time, Mr Upham (1784-1858) was superintendent of the Salem Chemical Works on the North River in North Salem, and resided at 70 Federal Street (#70 became #148; St James Church stands on its site). Apparently he never lived at Orne Street, & probably built it for one of his children or as investment property. According to Salem property tax records, Joshua owned just one house (70 Federal St) in 1834; but in 1835 he was assessed for that house and for two houses in North Salem--that which he bought of Nahum H Groce in June 1835 (deeds, 284:84), and this house, which he built on the lot bought of Robt Manning in July 1835 (deeds, 284:84).

Mr Upham was born in Saugus on 15 Dec 1784, & in 1804 came penniless to Salem, where he worked as a mason and, on 27 Jan 1807, married his employer's daughter, Mary Nichols, by whom he had 12 children. For many years he was superintendent at the Chemical Works, and Deacon of Salem's Baptist Church. After the death of his wife Mary, he married widow Ann (Marshall) Ruggs of Salem, in 1845. Joshua Upham died in Salem on 20 July 1858, aged 73, and was buried at Broad Street cemetery. Of his 12 children, one became a deacon & three became ministers, one of whom, James, published a memoir of his father in 1885, illustrating it with a fine daguerreotype of Deacon Joshua. This little book, & the Upham Genealogy by FK Upham, 1892 (see pp. 168-73), are available at the Library of the Essex Institute in Salem.

The land on which the house stands was, in the 18th century & probably even earlier, part of the Symonds family's holdings in the "North Fields" (now North Salem). Towards the end of the 18th century it belonged to John Symonds, who left it to his son John Symonds Jr, whose widow Susannah sold it for \$80 to Capt. Benjamin Daland on 18 May 1813. At this time there were no buildings on it, no Upham or Walter Streets.

Capt. Daland sank a well, & conveyed the property on 31 Mar 1820 to Elisha Mack, who on 22 Ap 1834 sold it for \$150 to Robert Manning. Mr Manning (uncle & former guardian of author Nathaniel Hawthorne, & America's foremost pomologist) lived on Dearborn St, & probably used the land as part of his extensive North Fields orchard. He sold it 2 July 1835 for \$350 to Joshua Upham, who probably built this house immediately. About 1839, Upham laid out Upham Street (35' wide) through his land, much of which he divided into marketable house lots, and finally sold this house & its land for \$725 to James Sanborn, Salem currier, on 5 Mar 1841.

James Sanborn, born in 1811 in Chichester NH, came to Salem & married Abigail F Cate in 1838. He was a tanner & currier, and did business at 3 Franklin St in North Salem. The couple had 8 children; she died in 1862, and he died 24 Feb 1863, at which time the property descended to their children, who slowly sold their

shares of the estate to their brother Arthur Prescott Sanborn, an apothecary then resding in Providence RI, who finally came to own the entire property on 13 Oct 1887.

On 29 May 1894, Arthur P Sanborn conveyed the estate to his sister & her husband, Annie L (Sanborn) & Horace N Smith. After the death of her husband, Annie L (Sanborn) Smith sold the property 6 Ap 1927 to William & Georgie Martin; & widow Georgie Martin conveyed it on 15 May to the present owner, Robert S Martin.

And Robert Manning also sells the lot immediately to the sw of this one. (Deeds, 284:85)





General ownership of property as of 2 July 1835




