

JOHN CODY died on August 17, 1934. His probate (#229895) mentions heirs: Honora I., Elizabeth M., Ellen (died Aug. 2, 1935) and Catherine A. Reference to book and page are deed books at the Registry of Deeds. Probate numbers are cases at Probate Court. Both offices are located in the same building on Federal St. All maps in this report are not meant to be exact, just for illustration purposes.

This two story plus pitch roof, wooden house has handsome features of the Italianate style which are not run of the mill; they include the cornice and paired brackets which are simple but bold, the second-story window pediments and the circular arch which is attached to the front columns of the entrance portico and makes a frame for the central front door. It is larger than most of the houses on the street. (Salem Historic District Study Committee Investigation)

As mentioned, Mr. Currin removed the old Smith house in order to build his handsome new dwelling. A permit was granted to John A. Currin, then of 78 Essex St., in October 1878. The house was to be wooden, 39' X 32', two stories with a pitch roof.

JOHN A. CURRIN was born in Salem, January 15, 1827, the son of Andrew and Susan Currin. He was educated in the Salem schools, graduating from the grammar school kept by Master Oliver C. Felton. He first learned the mason's trade of Samuel S. Standley, and worked for different contractors until 1857, when he was appointed assistant postmaster by Postmaster Joseph S. Perkins.

After leaving the postoffice, he resumed work at his trade in the employ of the late Capt. Benjamin R. White, then a large and well-known contractor of Salem and Essex county. He worked for Capt. White on the second mill of the Maumkeag Steam Cotton company, and when Capt. White was accidentally killed while building the Holyoke building, in July, 1866, Br. Currin was his foreman, and taking charge of the work finished the building for Capt. White's widow.

He next became associated in business with H. T. Conant, they buying out the business of Ars. White. This was continued until 1897, when he retired. Mr. Currin was a lifelong and sturgy Democrat. In his time ne knew all the great leaders of his party in the city and state, and many of the national lights. He was appointed registrar of voters by Mayor Rantoul, and held that office six years. His opinion was frequently asked, and his judgement was sound and of the best. possessed a splendid knowledge of the old merchants and worthies of Salem, gained by his prominence in political affairs and his long service in the postoffice. He also had a fund of local historical information. For several years he was a member and clerk of the old Salem artillery and he occasionally contributed to the columns of the old Salem Gazette and the Salem News. He was a Free Thinker in religion, but as tolerant of the opinions of others.

John A. Currin died on September 13, 1908 at the age of 81.
