392 ESSEX STREET

Built in 1850 by William Ives, Printer

History of the Property:

The building presently bearing the address 392 Essex Street was built circa 1850 by William Ives, a Salem printer-publisher who owned nearly all the land between Flint, Essex, Boston, and Federal Streets at the time. Ives' residence was next door at number 390 Essex Street, so presumably he built the large Italianate building numbered 392 as an investment property.

The large nineteenth-centuring Essex Street holdings of William Ives encompass the smaller seventeenth-century grant of Edward Flint, the namesake of Flint Street (see inserted "Part of Salem in 1700"). The parcel of Flint's property adjoining Essex Street was transferred successively to the Fabens and Mason families in the eighteenth century, and it was from Charles Mason that William Ives purchased the lot on which he would later build 392 Essex Street (Essex County Registry of Deeds, Book 384, leaf 170). In the first decade of its existence, 392 Essex Street was home to a number of residents, though

it does not seem to have been fully occupied (<u>Salem Directories</u>, 1850-60). In 1859 Ives sold part of the estate to George F. Putnam, tanner and currier (E.C.R.D. Book 587, leaf 253), and another part ten years later (E.C.R.D. Book 788, leaf 71).

Putnam utilized 392 Essex Street as both a residence and an investment property during the sixteen years that he possessed the building. In 1875 he sold the estate to George W. Rogers of Peabody and took up residence in Boston (E.C.R.D. Book 942, leaf 80). Rogers held the property for only a few years, during which he apparently went insane. In 1880 his court-appointed guardian sold 392 Essex Street to Nathan A. Frye of Salem at a public auction (E.C.R.D. Book 1041, leaf 183). Frye transferred the property to Joseph F. Dane of Salem, currier, three years later (E.C.R.D. Book 1099, pages 47-48). Dane would own and occupy the property for over twenty years.

The heirs-at-law of Joseph F. Dane conveyed 392 Essex Street to Alice Fletcher of Salem in 1906 (E.C.R.D.Book 1808, pages 526-527). Fletcher never occupied the property, nor does she appear to have sought out tenants, as the property is listed as vacant from 1906 to 1917 (Salem Directories, 1905-1920). The administrator of Mrs. Fletcher's estate conveyed the property to John H. Lewis and John J. Lewis, both of Salem, in 1910, and they also left the building vacant.

After J. Webster Dane, a relative of Joseph F. Dane and owner of property adjacent to 392 Essex Street, purchased the building in 1917 he began leasing rooms under the auspices of the "Salem Inn" (E.C.R.D. Book 2363, page 176). Dane divided the property into two parcels, both

of which were eventually purchased by Elizabeth Murtaugh of Salem in 1932 and 1949 (E.C.R.D. Book 2917, page 160 and Book 3690, page 370). Murtaugh renamed the Salem Inn "Murtaugh Apartments", the name by which it was known from 1935-1980 (Salem Directories, 1935-1980), despite the facts that Murtaugh died in 1951 and the building was conveyed by her estate to John M. Atkins of Marblehead (E.C.R.D. Book 3797, page 274).

John M. Atkins died in 1971 and his widow conveyed 392 Essex Street to George E. Maguire, trustee of the "Orne Street Realty Trust" the following year (E.C.R.D. Book 5937, page 443). A succession of short-term owners followed. Maguire transferred the property to Robert C. Bramble, trustee of the "Allyn Realty Trust" in 1974 (E.C.R.D. Book 6043, page 373). Bramble conveyed the building to two of its occupants, Herbert M. White and Helen E. White, two years later (E.C.R.D. Book 6259, page 161). Five years later, the Whites, then of Danvers, sold 392 Essex Street to Frederick and Karen Small of Topsfield (E.C.R.D. Book 6863, page 791). The Turners conveyed the property to another pair of out-of-town owners and landlords, David T. Ramsey of Wenham and Donald M. Moran of Beverly, in 1985 (E.C.R.D. Book 8053, page 385). Less than two years later Ramsey and Moran, as trustees of the "Phillips Pleasant Realty Trust" sold 392 Essex Street to John J. Suldenski, trustee of the newly-established "392 Essex Realty Trust" (E.C.R.D. Book 8975, page 39). After the holder of the mortgage on the property foreclosed in 1992, its present owners, James A. and Claire P. Bailey, purchased 392 Essex Street (E.C.R.D. Book 11214, page 442; Book 11317, page 378).
