



Gertrude Wood, wife of Frederick S. Wood, of said Salem, the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey unto the said E. Gertrude Wood, and her heirs and assigns, a certain parcel of land situated in said Salem, and bounded and described as follows, viz: Westerly on Linden Street, sixty-three (63) feet, more or less, northerly on land now or formerly of Barton, one hundred and fifty (150) feet, more or less, Easterly on land now or formerly of Hyde, seventy (70) feet, more or less, Southerly by land now or formerly of Devine, fifty (50) feet, more or less, Westerly again by land now or formerly of Washburn, seven (7) feet and Southerly again by land now or formerly of Washburn, one hundred (100) feet more or less, Being the same premises conveyed to me by deed of Calvin R. Washburn, recorded with Essex South District Registry of Deeds, Book 2025, Page 395. To have and to hold the granted premises, with all the privileges and appurtenances thereto belonging, to the said E. Gertrude Wood and her heirs and assigns, to their own use and behoof forever. And I hereby, for myself and my heirs, executors and administrators, covenant with the grantee and her heirs and assigns that I am lawfully seized in fee simple of the granted premises, that they are free from all incumbrances, that I have good
