### 2 Botts Court

# Built in 1848 for and by Aaron Kehew, Carpenter

# History of the Property:

2 Botts Court sits on the seventeenth-century lot of Robert Kitchen, Salem merchant, which bordered a narrow strip of land that Kitchen sold to Joseph Neale, joiner, in 1695 (Essex County Registry of Deeds, Book 17, leaf 33; see inserted "Part of Salem in 1700" from The Essex Antiquarian, Volume IV, 1900). At that time, the plot was part orchard, part pasture, and part marsh. The Kitchen family held the land bordering the "high" or "main" street, later Essex Street, until 1711, when it passed to the Pickering family, who later sold a lot to James Bott, "chaisemaker", saddler, merchant, and namesake of the court that would later bear his name (E.C.R.D. Book 138, leaf 267). A native of Tudbury, England, Bott arrived in Salem in the later 1760s and quickly proceeded to expand his business "at the Sign of the Saddle" and buy up properties in the vicinity of "Bradshaw's Gutter", the predecessor of Botts Court. After the laying out of Chestnut Street at the turn of the nineteenth century, Botts Court began to assume its modern form. When James Bott Sr. died in 1829 at the venerable age of eighty-four he left many properties on and around "his" court to his many heirs, including members of the Goodhue, Browne, Mugford, Potter, Safford, and Ferguson families.

Two Bott grandchildren and heirs, Thomas B. Ferguson and Benjamim Browne, sold a small plot on the family court to Aaron Kehew, carpenter, in 1847, "being part of the estate inherited by said Thomas from his grandfather James Bott and under mortgage to said Brown." The conveyance included "a right to the use of the Court for passing and repassing to said lot" and was "subject to a water course running through the same" (E.C.R.D. Book 389, leaf 68). Kehew erected a house on the lot in the following year, but continued to reside at 222 Essex Street. The next year, in two transactions of November 8, 1849, Kehew purchased adjoining property from two more Bott heirs, John Bott and Elizabeth Goodhue, and sold the whole estate to William Smith, merchant, at a considerable profit (E.C.R.D. Book 419, leaves 179-180).

William Smith, like Aaron Kehew, apparently regarded 2 Botts Court as an "investment" property, for he never made it his primary residence. He acquired a mortgage from William Hill of Salem in 1866, probably for the purposes of remodelling the house, and paid it off the following year (E.C.R.D. Book 703, leaves 146-147). The house was leased to a succession of occupants until Smith's death in the 1870s, after which his heir, Mary C. Knapp of New York City, sold the property to its occupants at the time, the Cloutman family (E.C.R.D. Book 1023, leaves 46-47). Joseph B. Cloutman, a Boston businessman, and his family resided at 2 Botts Court from 1878 until 1901 (Salem

<u>Directories</u>, 1878-1901). The nineteenth-century <u>Atlases of Salem</u> do not conform completely to the property records; while the 1874 <u>Atlas</u> (inserted) and the 1897 <u>Atlas</u> clearly illustrate 2 Botts Court, the 1851 <u>Atlas</u> (inserted) does not, even though the 1849 deed granted by Kehew to Smith specifically mentions a house.

For the greater part of the twentieth century (1905-1972), 2 Botts Court was the property and residence of the Faunce family, whose patriarch, Carlos P. Faunce, was President and Manager of Holyoke Mutual Fire Insurance Company in Salem for many years. The Faunces also maintained a summer residence on Winter Island. The Cloutman heirs, Ellen B. Cloutman and Frances Browne, "singlewomen", conveyed the Botts Court property to Jeannie Carlton Smith of Pawtucket, Rhode Island, Charles Browne Price and Frank Shreve Price, both of Salem, in 1901, but the grantees never took up residence (E.C.R.D. Book 1637, page 575). The Faunce family moved in, as tenants, in 1905, and purchased the property from Frank S. Shreve et als in 1914 (E.C.R.D. Book 2248, page 226). That same year, the Faunces were granted a substantial mortgage by William A. Horton of Salem, which they obtained for the purposes of remodeling and adding on to the house (E.C.R.D. Book 2248, pages 228-231). The mortgage was discharged by Horton in 1923 (E.C.R.D. Book 2563, page 600).

Retired and a new widower in the spring of 1948, Carlos Faunce transferred the title of 2 Botts Court to his daughter Margaret, "reserving, however, to myself, said premises and the use and employment thereof during the rest of my natural life...." (E.C.R.D. Book 4548, page 208). He died on April 1, 1959. Margaret Faunce lived in the house alone until her death in 1972, after which the trustees of her estate sold the property to Edward H. and Barbara P. Ribhany, "as the Tabernacle Church of Salem declined to accept the devise of the property at No. 2 Botts Court, Salem, for use as a parsonage" (E.C.R.D. Book 5881, page 465). After the death of Edward Ribhany in 1990, his designated executors conveyed 2 Botts Court to Stanley J. Usovicz and Mary P. Ankner-Usovicz, its present owners (E.C.R.D. Book 10694, page 231).




