PREVIOUS REFERENCE- "The which ... parcels of Land [here and in Book 14, Page 305] is part & parcel of the Land of my

said father John Archer, deceased."

NOTE-

In the above two transactions of July and August, 1703, Christopher Babbige [or Babbidge, or Babbagel purchased a strip of land about 74 feet wide and nearly 800 feet long, embracing the current lots along the northwest side of presentday Briggs Street, from Pleasant Street on the southwest to Webb Street on the northeast. As mentioned above, the land was originally owned by John Archer (1638-1693), a cooper. (See Map, "A Part of Salem in 1700.") He and his wife Bethiah (Weeks) had nine children, two of whom were Benjamin (1665/6-170_), cooper, and Thomas (1671-1703), potter, the grantors of the deeds above.

Christopher Babbige (1678-1755) married Lydia Marston in 1705, and had seven children, one of whom was also named Christopher (? -1752), a mariner. He married Anstis [or Anstiss] Crowninshield (b. 1727) in 1749, and had a daughter, also named Anstis (1750-1834). She married, in 1772, Captain Robert Stone (1744?-1817).

CONSIDERATION-

5 shillings, "but more especially for the affection and fatherly love which I ... bear unto my beloved son-in-law Thomas Briggs and my daughter Anne his wife as also for divers other good causes and considerations me moving ..."

GRANTEE-

Thomas Briggs of Salem, ropemaker

DESCRIPTION-

"... a piece of upland and flats adjoining in Salem ... beginning at the northeast corner of said Briggs land and running by the land of William Brown to low-water mark in Collins Cove (so called), and thence southeast twenty-four feet and thence southwest to said Briggs land and thence twenty-four feet by land of said Briggs to the first-mentioned bounds."

PREVIOUS REFERENCE- "... being part of the lot ... which I purchased of Captain Joseph Hodges ... 28 day of April 1779 ..."

NOTE-

Thomas Briggs (1758-1803) was born in Rhode Island, but came to Salem ca. 1778 and worked for Joseph Vincent (1738-1832), who had moved to Salem from Kittery before the Revolution, and had established a ropewalk southeast of (present-day) Briggs Street. In 1783, Thomas Briggs married Joseph's daughter Anna Vincent (c.1766-1842). Briggs later went into business for himself, buying the above two plots and laying out Briggs Court along the southeast side (now Briggs Street, but then extending only about two-thirds of its present length from the Common), and his work-house and ropewalk near the northwest side (near the back of the odd-numbered lots on Briggs Street). The second plot, purchased of his father-in-law Joseph Vincent, gave him access to Collins Cove, and so he extended his ropewalk on pilings out into the Cove, as Vincent had done (see "Map of Salem About 1780").

NOTE (Continued)-

Between Briggs Court and his ropewalk, Briggs laid out a private cemetery and also a nursery of poplar trees. Promenaders in the 1790's were wont to stroll down Briggs Court, rest on the bench at its end, and refresh themselves with cakes and ale bought of an elderly lady who kept a small house near the bench.

From this one might gather that Mr. Briggs was of a retiring nature, but not so: Reverend Bentley noted in his Diary, Nov. 25, 1793, "St. Catherine [ropemakers' patron saint]'s day celebrated with uncommon shew & noise, guns firing, flags displayed, etc. Mr. Briggs is the chief author of such folly. Mr. Vincent made no exhibition on the occasion." And again, for January 23-24, 1794: "A Second Guinea Captain has died this season ... The news produced a bonfire in the Common, in all the rain & the people were alarmed, supposing it to be a building in flames ... Great blame cast upon the contriver of the bonfire ... The whole disgraceful and unseasonable. One Briggs was the promoter, & gave the Liquor."

When the frigate Essex was built in 1799, Joseph Vincent's ropewalk supplied the cordage for the foremast, and Thomas Briggs's provided the rigging for the mizzenmast. The hemp cables were carried to the frigate from Briggs's ropewalk, on the shoulders of 200 men, accompanied by the American flag and by "Yankee Doodle" on fife and drum.

Upon Briggs's death on March 10, 1803, Reverend Bentley noted, "[Briggs] had great success, but relaxing from his industry, & living with every indulgence of good cheer, he left the vigour of a firm constitution, remained a prey to disease for several years, & finally died very old at 45 years. A fanatic in opinion, as well as in high life, he gave great satisfaction to his friends at death." And upon his burial on March 12, "He insisted upon a mahogany coffin, to be buried in his own ground, to be attended by his own sects & to have a minister of his own denomination, when he could not read or write, & was as ignorant, except of his own occupation, as a man in civil society could be."

NOTE (Continued)-

Shortly after Briggs's death, the ropewalk was sold and moved to Bridge Street, and the land passed to their only daughter, Ann Briggs (1786-1876). In 1804 Ann married Jabez Baldwin (1788-1819), who was born in Connecticut but moved early to Salem, where he learned his trade as jeweller (silversmith, clockmaker, etc.). A man of much enterprise, Baldwin had by far the largest stock in Salem at his shop on Essex Street and, after the War of 1812, established the firm of Baldwin & lones in Boston as well.

Subsequent to 1806, Jabez Baldwin built the brick house on the south corner of Briggs and Pleasant Streets, a little north of where Ann's father's house had been. After Jabez's death in 1819, his widow Ann Baldwin continued to live there. She sold the ropewalk land (on the north side of Briggs Street) piecemeal, retaining the plot of 19 Briggs until 1871, whereupon she sold it to the man who immediately built the present house upon it.

The Salem tax records for 1871 have a pencilled note for David G. Batchelder, assessing his new house at 11 Briggs Street. The house retained this address until 1888, when it became 19 Briggs St.

David Batchelder (c.1814 - 1877) was born in New Hampshire, and came to Salem about 1846, when the Salem Directory listed him as "laborer, Forest River Lead Comp., house S. Salem." By 1850, he was foreman of the Forest River Lead Co. He lived at 88 LaFayette until 1857, moving then to 3 Holly St., where he remained. By 1869 David Batchelder was superintendent of the new Salem Lead Co. Upon his death in September, 1877, the Salem Evening News said, "He was one of our most active and intelligent businessmen, and for twenty years has occupied an influential position in the community. [He] had those positive traits of character which command success in life, and also traits of disposition in private intercourse which engaged the confidence and esteem of numerous friends."

NOTE (Continued)-

By 1872 his eldest son, David Jr. (1849-1885), also worked at the Salem Lead Co., and in 1874 was assistant superintendent. It was this son who lived at 11 (i.e. 19) Briggs Street from 1872 until his father's death in 1877, when he in turn became superintendent of the Salem Lead Company, and rejoined his widowed mother and his younger brother George E. (born c. 1859) at 3 Holly Street.

NOTE-

George E. Batchelder owned but never lived at 11 (19) Briggs; he continued to live at 3 Holly Street with his mother, while studying law 1881-1883, and while practicing law in 1884-5 in the Post Office building at 118 Washington Street. By 1886, he moved to Amesbury. His older brother David had moved to a new house on Roslyn Street by 1881, and died in 1885. David's obituary in Salem Evening News, March 24, 1885, states he was "one of the best-known citizens of Salem, and respected by all who knew him ... The lead mills are closed today in respect to his memory. Mr. Batchelder was a prominent society man, and belonged to the American Legion of Honor, Pilgrim Fathers, Royal Arcanum and Essex Lodge of Masons, chapter and commandery. He leaves a widow and two children; his age was 34 years. [He] was insured ..."
