One Daniels Street Court Built by 1790 Moved to present site after 1820

The building which presently bears the address "One Daniels Street Court" was built by 1790, and perhaps decades earlier, and moved to its present site in the mid-nineteenth century. The evidence for these dates is physical and material, specifically the timber and hand-forged nails (used prior to 1790) and evidence that a circular saw was used on several planks (1820s). My colleague at Salem State College, Dr. Emerson Baker, an architectural historian and archeologist, examined the building in the Fall of 1996 and, after consultations with additional experts, made the above conclusions. The use of the circular saw is likely evidence of a move, but it could also point to substantial renovations well after the building's original construction.

ONE DANIELS STREET COURT

The Salem city maps for the years 1851, 1874, and 1896 point to the possibility that the house located at One Daniels Street Court was moved to its present site some time between the years 1852 and 1874. Since the style of the house reveals an eighteenth or early nineteenth century origin, it is probable that the house was built somewhere in the Salem area. However, the incomplete nature of deeds records before 1875 make it difficult to pinpoint exactly where the house was first established.

The 1851 Map of Salem [Peabody/Essex Museum] reveals the fact that Daniels Street Court did not exist in the 1850's. Instead, a field covered what is today the Court. The house appears on the 1874 Map of Salem [Peabody/Essex Museum] with a path running beside it instead of an official court. However, deeds records refer to the path as a court [see Essex County Registry of Deeds Book 881, Leaf 238 below]. The Court as it appears today was probably built in the late 1870's, when persons listed as living in the house were no longer listed as "29 Daniels Street", and were now listed as "1 Daniels Street Court".

The occupants of the house were part of the great Salem immigrant tradition. The neighborhood in which the house is located was once home to immigrants, mostly from Eastern Europe, who flocked to Salem in search of better opportunities in the last quarter of the nineteenth century.

The neighborhood was a solid working class community, with many of the residents holding jobs as tanners, leather workers, laborers, and clerks.

Even before immigrants arrived from Russia, Poland, and other Eastern

European nations, the neighborhood was heavily populated by Irish

immigrants, as the Salem Directory and Registry of Deeds information shows.

The first occupants of the house were the Coughlin family, led by Patrick and Fanny Coughlin. Patrick was employed as a laborer [Salem Directory, 1876, 1878]. By the 1890's, James Lynch and his wife Margaret were living in the house, and would continue to do so until the turn of the new century. James, also a laborer, sold the house in 1902 to Frank Siemiontkowski and his wife, Anna. The sale was symbolic in that it reflected the new flavor of the neighborhood, which was becoming increasingly Polish in its makeup [Salem Directory, 1881, 1884, 1888-1889, 1899-1900, 1905].

The Salem Directory for 1916 provides an interesting glimpse into the varied character of those living in the house. Besides the Siemiontkowski family, Adam and Rose Borina were listed as residents. Both were employed as florists. Also, B.W. Fellows, an artist, is listed as operating a studio in the house. He lived at 10 Bridge Street, Salem, with his wife, Fannie. By 1922, the Borina's and Fellow's had moved on, and Wladyslaw and Anastasia Tanski had moved in. Wladyslaw was employed as a leather worker [Salem Directory, 1916, 1922].

Throughout the 1920's, the Siemiontkowski's continued to own the house. In 1926, Anna and Frank's son, Frank Jr., was listed separately as an occupant of the house. He was employed as a shoeworker, while his father continued to work as a leather worker. It is common to see in the Directories

listings for such jobs, since the North Shore of Boston was known for its shoe industry (especially Lynn), and tanneries (especially Peabody) [Salem Directory, 1926, 1930, 1931].

The period of the Great Depression began in 1929, and, as was the case with many homeowners around the nation, Salem was hard hit by the sudden crash of the Stock Market. The 1930's were an especially trying time for the Siemiontkowski's, because in 1938 foreclosure proceedings commenced, and a public auction was held on the premises on Friday, December 2 of that same year. [Essex County Registry of Deeds, Book 3167, Page 562].

Despite this difficult episode, the Siemiontkowski's continued to live in the house. In 1940, Frank Sr. is listed as the head of the household, and since no occupation is listed in the Directories, he may have retired by this time.

Unfortunately, this is one of the last times Frank is listed in the Directories -- he apparently died in 1941 or 1942 [Salem Directory, 1940].

In 1943 and 1945 Anna is listed as head of the household, and also her two children, Emily and Frank Jr. were living in the house. In addition, Paul and Madeline Jankowski are listed as residing in the house with their two children. Paul was employed as a clerk.

In the early 1950's, Mary Pasternak and her four children lived in the house, as did Edward F. Brennan and his family of six [Salem Directory, 1950]. In the late 1950's and early 1960's, Ralph and Agnes Caldwell lived in the house, along with the family of Caroline Makowicki. She had four children who are listed as residents of the house: Matthew, who was employed at the

Health Department; Frank, who was serving in the Air Force; Edward, a leather worker for Hawthorne Tanneries in Danvers; and a son Richard [Salem Directory, 1955, 1960]. The 1965 and 1970 Directories show Napoleon and Stella Michaud as living in the house as was Matthew Mackowicki [Salem Directory, 1965, 1970].

The Michaud family continued to live in the house until the late 1970's, when Stuart Abrams acquired the property from the estate of Stella Michaud. Andrew Hingson purchased the property in 1978 and sold it to Warren White and Peter Kerr in 1982, who sold it to the Shapiro family, who in turn sold it to Richard C. Ager and Renée A. Meyer in 1994.
