

## THE ASA LAMSON HOUSE 104 Federal St., Salem

#### DOCUMENTATION

DEEDS - BOOK & PAGE

**283 - 153** July 18, 1825

LUCY MARTIN of Salem, singlewoman, for \$600 sells to ASA LAMSON of Salem, upholsterer, a certain lot of land on Federal St. bounded as follows: beginning on said street at SE corner of the house of Peter Webster, running N by house and land of Webster as the same goes 74'-4" to SE corner of Webster's barn; then E by land of Jonathan Millet 25'; then S by other land of said IUCY 58' to Federal St.; then W on street 49' to first bounds. Premises in part having descended to said IUCY from her grandfather Benjamin Bullock dec. and in part from her father George W. Martin, dec.

# 799 - 124 August 5, 1858

Robert Peele of Salem, exec. under will of ASA LAMSON, upholsterer, dec. of Salem sells real estate for payment of debts; for \$2375 sells to JOHN S. FELTON, trader of Salem, land and buildings bounded: on W in 2 courses by land of John Chandler 74:-4"; on N by land of Webster 25'; on N by land of Iucy Martin 58'; on S by Federal St. 49'. Being same purchased by Lamson Book 238 page 153 and which he occupied at the time of his decease.

# 925 - 61 April 12, 1875

Charles Symonds and George Burt, trustees under the will of JOHN S. FELTON, dec. of Salem, sell for \$3000 to IUCY WOODBURY wife of James Woodbury the messuage (same description as above) Premises having been convered to FELTON Book 799 page 124

## 992 - 187 February 18, 1873

JAMES and JUCY WOODBURY of Salem sell for \$2600 to JOHN H. BEIL of Salem the messuage (same description) Being same premises conveyed to said WOODBURY by deed Book 925 page 61

## 1292 - 229 October 7, 1890

JOHN BELL to JOSTPH A. BROWN to CHARLOTTE BELL wife of JOHN BELL in 2 deeds: messuage in Salem (same description) Being same premises conveyed to me by James Woodbury Book 992 - p.187

#### 2454 - 160 July 19, 1920

MARY A. JODREY of London, England sells to J. MORTON DAVIS and ELENORE B. G. DAVIS land and buildings (same description)
This land came to me by inheritance, see part of premises described in deed Book 1292 page 229

### 3362 - 462 March 17, 1944

ELENORE B. G. DAVIS of Marblehead sells to OLIVE M. and LEO BENNETT gand and buildings (described above) Being same premises conveved Book 2454 page 150

### 3758 - 10 August 1, 1950

LEO C. and OLIVE M. BENNETT sell to EDNA G. ODELL, ESTHER and RUTH ODELL land and buildings at 104 Federal St, bounded: beginning at SW corner on Federal St. by land now or late of Chandler, running NW and N by land of said Chandler 74.1-4" to land of said Chandler; running E by said land 25: to land now or late of Lucy Martin; thence SE by said Martin's land 58: to Federal St.; then SW by Federal St. 49! to beginning. Also small plot of land in rear of above premises extending back to land now or late of Norris. Being same premises conveyed to us Book 3362 page 462.

In tracing the house at 10h Federal St., we came upon a curious circumstance which used to occur occasionally in real estate transactions in the old days in Salem. Asa lamson, an upholsterer, purchased a "lot of land", the dimensions of which are the same as at present from Lucy Martin in 1825. In the City of Salem "ax Records, Asa Jamson began paying taxes on a "house" in 181h. He owned no other property, and so apparently Jucy Martin permitted him to build his combined house and shop on her land, which he finally purchased from her 11 years later. When Asa Jamson died in 1858 his will remembered various nephews and the Baptist Church deacons. His house and land were sold for "payment of debts". Oddly there is no mention of his wife or adopted son, for whom no record of death can be found up to 1850.

Iamson genealogy straightened out a confusing duplication of names. Another Asa Lamson, a saddler and chaise maker, lived in North Salem and had a shop on Bridge St. He was the son of a Capt. Asa Lamson of Beverly. A third Asa Lamson, a "Reverend", was born in New Hamshire, lived in Andover and died in Salem in 1860. The Asa Lamson of 104 Federal St. was probably distantly related to these others. He was born in Exeter N.H. son of Joseph Lamson in 1783. In 1814 he married Margaret Brown in Salem, and this was the year he built his house on Federal St. They apparently had no children of their own, but adopted Augustus Hodgkins Lamson in 1833.
