10 Turner Street

The probable date for the construction of the house at 10 Turner Street is circa 1800. Because of the lack of reliable Registry of Deeds records, establishing an exact date is impossible. However, upon consideration of the written records that do exist, and the inspection of the house by an architectural preservation team, the above date is plausible.

However, better sources exist when determining the people who inhabited the house in the nineteenth and twentieth centuries. The neighborhood of Salem in which the house is located is known in Salem's history as an area peopled by those who were a part of the "laboring classes." For example, in the late eighteenth and into the early nineteenth centuries, many sailors lived in this section of the city, when Salem was at the height of its glory as a world-class port, trading with Europe, the Caribbean, and China and Japan, to name only a few stops Salem's ships made. In the mid- to late nineteenth century, the neighborhood became home to immigrants who came from Europe as Salem declined as a sea power and began to develop as an industrial center for the North Shore. The influence of these immigrants is reflected in some of the street signs seen in the area, such as Kosciusko Street, named in honor of the Polish hero of the American Revolution, Thaddeus Kosciusko. Also, the Russian Aid society is still located in the Pickering Wharf area to aid immigrants from Eastern Europe.

The earliest known owner of the property at 10 Turner Street appears to have been Jonathan Andrews of Salem, who came into possession of the property in 1813. He in turn sold it to E.A. Holyoke, an attorney, for \$112.00 in 1822.

After the death of Holyoke, the property was acquired by Benjamin Merrill, a prominent Salem lawyer. The *Salem Directory* for 1846 lists him as President of

Salem Bank, although this appears to have been only one of many impressive achievements. He provided legal services to the influential Pickering family, whose members had distinguished themselves during the American Revolution. Timothy Pickering, a member of the Continental army, authored an influential book on military technique entitled *Easy Plan of Discipline for a Militia*, his attempt to help ready the Americans for war with Britain. After the Revolution, he served as an advisor to presidents Washington and Adams.

Merrill owned dozens of properties in Salem as well as in Ipswich,
Topsfield, Hamilton, and Gloucester. In addition, he had interests outside
Massachusetts, namely in New York and New Hampshire. In 1841, Merrill sold
the house to Susannah Ward, a widow. In 1860, the house was sold by Mehitable
Ward, who came to control the property probably as the beneficiary of Susannah's
estate, although the records are unclear as to how Mehitable came into ownership.
The Osgood family owned the property until the 1880's, when it was briefly owned
by Benjamin Sweetser, who in turn sold the property to Bridget Riley, a widow, in
1886, for \$1505.00.

A relative wealth of information exists about the occupants of the house from the 1880's on. The *Salem Directory* for 1881 lists Michael Flynn as the occupant of one part of the house, which by this point could be considered a "two-family". He was employed as a laborer. He lived in the house for approximately 14 years [*Salem Directory*, 1881, 1886-1887, 1893-1894). In this same span of time, Flynn became a well-known contractor, and was prosperous enough to advertise in the *Directory* (see attached advertisement). The other part of the house was occupied in the 1880's by J. Henry Walton, an engineer. By the early 1890's, Albert H. Hirtle was living in the residence. He was employed as a cooper (barrel

maker) [Salem Directory, 1893-1894]. These men are listed as "heads of household" in the Directory, which does not list the number of people living in a particular house at a given time.

Between 1901 and the late 1930's, the Tobin family were the primary residents of the house. It is interesting to note that the deeds records for 1916 list another dwelling on the property, possibly a guest house. It is unclear what happened to this dwelling, because in later deeds it does not appear.

The Salem Directory for 1901-02 lists Patrick Tobin, husband of Mary, for the first time. He was employed as a laborer. Other occupants of the house included William F. Mooney, a shoemaker, Mrs. Catherine Clark, widow of Roger Clark, and Mrs. Bridget Riley, widow of Matthew Riley [Salem Directory, 1901-02,1907, 1918, 1924]. Patrick Tobin's success mirrored that of Michael Flynn, since the Salem Directory for 1931 lists him as the owner of an automobile, a mark of distinction at the time for someone who was employed as a laborer. This is especially significant in light of the fact that by the early 1930's, the United States was in the midst of the Great Depression, which had the effect of throwing millions out of work.

In the mid-1930's the house number changed from #12 to #10. It appears that by the latter part of the decade, Patrick Tobin had died, and the house passed into the hands of James Tobin, who held the property until his death in 1961. In the meantime, there were a number of occupants who lived in the house. On the eve of America's entry into World War II, Mrs. Catherine A. Rodd, widow of George E. Rodd, moved into the house. Three dependents are listed as living in the house, possibly Catherine's children. By the end of the war in 1945, Catherine

Rodd had moved out, and Adeline C. Maxwell, widow of Thomas, is listed as the only occupant of the house.

In the 1950's, a number of different occupants lived in the house. William and Dorothy Kuronen were the first occupants of the decade. William's occupation is listed as "student." In 1956, Mrs. Catherine Gleichowski, widow of Anthony, is listed as the sole occupant of the house. In 1961, Gerald Seltser bought the property for the estate of James T. Tobin and in that same year sold it to O'Neil and Christine Proulx. The Proulx family owned the property until 1997, when it was sold to Gary Palardy.
