77 Bay View Avenue built in 1878 for Edward Ellingwood, Manufacturer

History of the property:

The house presently bearing the address 77 Bay View Avenue, formerly 17 Central Avenue, is one of the "Juniper Point Cottages" built after the 1875 subdivision of Salem Neck by Daniel Gardner, Jr.¹ Lot number "49", adjacent to Central Avenue and Short Street, was conveyed to Edward Ellingwood of Lowell by Gardner two years later.² At this time, Salem Neck was in the process of being transformed from farmland into a summer colony of seasonal residents, most of whom were from the prosperous Merrimack River Valley. The Ellingwoods proceeded to erect their summer cottage in the following year.

The best sources for the early history of Salem Neck are the 1897 reminiscences of William Welch and Gilbert Streeter. They recount the fortifications and fisheries of the Neck and Winter Island and the former's transformation after "Hospital Point" was laid out as the Willows public park in 1858. At the turn of the nineteenth century, the forty-plus acres that constituted Gardner's later subdivision were acquired by Captain Edward Allen of Salem, who extended the standing "ancient" mansion house, "planked new piers on the north side of Abbott's Cove" (according to Dr. Bentley's <u>Diary</u>), and indulged in considerable (and apparently expensive) landscaping. Allen was Juniper Point's first summer resident. After his death in 1816, his presumably-indebted family sold the "Allen Farm" to Jonathan Dustin, a Danvers butcher. Nineteenth-century Salem maps refer to Salem Neck alternatively as "Neck Farm" and "Heirs of Dustin", and it is from the latter that Daniel Gardner purchased his property in 1875.

Juniper Point's designation as a summer colony actually predated Gardner's development plan by several years. Lowell residents had traditionally summered across the water on Marblehead Neck, but in 1873 the land company that owned most of that neck advised its tenants either to purchase their plots or to seek a new vacation locale. Most left, but they did not go far. When Gardner purchased the Neck Farm in 1875, he was responding to the apparently-increasing demand of Lowell's prosperous industrialists for coastal vacation property on the North Shore.

Gardner's plots Purchasers of bound by were development conditions, specifically that "no shop, store, public house, boarding house, saloon, or stable shall ever be erected on said lot nor any building thereon used for any of said purposes." Stable lots parallel to "Cheval Avenue" were also available, and the Ellingwoods purchased stable lot number "43". 17 Central Avenue remained in the Ellingwood family until the end of the century, at which time it was conveyed to Cora S. Haskell of Salem, who represents the commencement of a Salem custom of maintaining a summer cottage on Juniper Point and a primary residence in "town".4

Cora Haskell's heirs-at-law, Mabel and Alvah Bigelow, summered at 17 Central Avenue/77 Bay View Avenue (after 1920) even before they inherited the property. According to the Salem Directories, Mr. Bigelow was a clerk at the M. Robson Leather Company on Goodhue Street in Salem. The Bigelows also maintained a primary "town" residence on Federal Street in Salem. Occasionally the Salem Directories refer to a summer tenant in residence at their Juniper Point cottage (such as Louis Bailey in 1910), or a vacancy. is no evidence of year-round, permanent residence in this century. In 1918 the Bigelow's transferred title to the property to Lucy H. Bigelow of Salem. 5 Successive transfers were made from Rosamond W. Gould to Lucy H. Gould in 1950 and from the latter and her husband Roscoe W. Gould to its present owners, Edwin W. and Rosamond W. Dennis, in 1972.6




