Historical Summary of House #15 Chestnut St.

The two men concerned with #15 Chestnut St. are brothers from Boxford. Amos, born in 1769 and Solomon born in 1774, sons of John and Anna Towne. Boxford, Topsfield and Andover had a great many Townes and Towns listed, with many repetitions of surnames, so tracing has been difficult. An Amos is listed in Salem marrying Polly Davitt in 1792, however after the first land purchase we are concerned with, (which mentions no wife's name) Amos Towne is listed with wife Rebecca. No children were born to these names. Solomon married a Salem girl Lydia Goodale, from whom he was absent often, on sea voyages. His name is connected to at least four vessels over the years, as a captain: ship "Lucia", ship "Galatea", brig "Baltimore" and brig "Conqueror". Solomon and Lydia Towne had seven children.

To go back in time. Amos Towne first appears in Salem as a young man of 28, paying taxes on a house in Ward 1, and a year later his brother Solomon, then 24 was living in Ward 1, perhaps in Amos' house. Amos Towne was a schoolmaster. In 1799 he had moved to Ward 3, and was paying taxes on a house. (no location mentioned, or deeds recorded.) William Bentley states that Amos opened a new school in the "west end" (Ward 3?) in 1802. Meanwhile Solomon Married Lydia Goodale, 19 year old daughter of a Salem family and in 1802 he was paying taxes on a house in Ward 1. A year later he and his wife had moved to Ward 3; and Amos Towne, for \$607, bought a lot of land on the corner of Cambridge and the recently laid out Chestnut St.

In 1804 Amos and Solomon Towne are assessed \$900 valuation each for a "pvt. house" (Wiswall claims that #15, was used as a 2-family house. Both Townes may have been living in it.) The tax jump seems to indicate this year as the year the house was built. In 1805 Amos took out a \$500 mortgage on half of his land, and dwelling house; this was carefully described as the half the present house is on. In 1807 Amos and his wife Rebecca had left Salem for Bath, New Hampshire, and he sold his Chestnut St. property to his brother (land, dwelling house and buildings) for \$5000. The price certainly indicates that a substantial house had been added since 1803. James Duncan Phillips dated this house 1807 or 1808, and Wiswall dated it 1810. Evidence shown in the documentation following this summary seems to point to earlier dating: 1804 possibly, and 1805 at the latest.

At any rate, Capt. Towne and his growing family lived on at #15. They took out a sizeable mortgage on the property in 1812 with William Gray. This was the merchant who in 1803 owned a quarter of all the Salem ships in foreign trade, including at least one of which Capt. Towne was master. Solomon Towne was a member of the "Salem Evangelical Library" and the Salem Marine Society. For unknown reasons, the Townes sold their property in 1821, although a son born in 1823 in Salem may mean they lived on for a while in the house. Tax records for 1823 note "gone"

after his name. Where the family went we can't trace: 12 years later news of his death in Sumatra reached Salem.

James King was a Salem merchant who owned considerable property. His first wife had died in 1809, and he was left with many children. When he was 69 in 1820, he married Elizabeth Grant, a spinster of 53. In 1821 he bought #15 Chestnut St. from Solomon Towne, but apparently he never lived there himself, preferring his house on Essex St. Wiswall names a variety of people who rented the house, including two sea captains Jerimiah Page, and William Pierce. The latter, with his wife and daughters was living there in 1855, when Mrs. King, a widow since 1830, died aged 85. She left a long will disposing of her many pieces of property and possessions. The house at #15 Chestnut St. was willed to Capt. Pierce's father-in-law, Ezekiel Goss. The Cambridge St. corner half of the land, with a house on it, was sold.

The Gosses moved in; daughter Almira Pierce, her husband and family apparently moved to Watertown. By 1892, the elder Gosses had passed away and the 4 children disposed of the estate, selling the Chestnut St. property to Jennie M. Emmerton. There is no record of the Emmertons living there themselves; and in 1901 the widow Jennie sold the house to Nathan and Eliza Osgood.

A notable addition to the property was acquired in 1910, when Shreves sold to Nathan Osgood a 62' lot between houses #15 and the Shreves' #17. This greatly enhanced the Osgood property, and made possible a wing on the house about 20 years later. When Mrs. Osgood died, the property was sold by her married daughter in 1932 to Sally Parker Barton; (it was said) as a wedding present from Mrs. Barton's mother. Twenty one years later in 1953 Alfred and Margery Moses purchased it, and lived there until 1965 when Mrs. Moses sold it to Jeremiah S. Burns, and his wife Abby. This family, including their 3 children reside in the dignified and gracious gray wooden house now, in 1969, 165 years old.

S. along Cambridge St. 59'6", W. along land of David Neal 103'10", then nearly N. on land of John Pickering Jr. 55' to a stone sunk in S. line of Chestnut St., then E. along Chestnut St. 105'6" to beginning, containing 21 and 7/10 poles, the premises being same conveyed to Amos Towne by David Neal Sept. 10, 1803 Book 173 p. 31, together with dwelling house and other buildings standing on said land (notes a mortgage on premises held by Susanna Ha(r)thorne, \$500 & interest dated July 15, 1805.) Amos & Rebecca give up right of dower.
- Book 198 p.126 July 7, 1812

 Solomon Towne and wife Lydia take out a \$3000 mortgage on the Cambridge St. Chestnut St. property (land, house & bldgs.) with William Gray of Boston. This mortgage was discharged in Sept. 10, 1818.
- Book 226 p.97 April 13, 1821 Solomon Towne, Master Mariner, for \$3000 sells

to James King, Salem merchant, a lot of land with dwelling house and all other buildings described: beginning at corner of Chestnut St. and Cambridge St. running S. on Cambridge St. 59'6", W. along land of David Neal 103'10", then nearly N. along land late of Pickering, now of Stephen Phillips 55' to a stone sunk in the S. line of Chestnut St., then E. on Chestnut St. 105'6" to corner first mentioned, containing 21 and 7/10 poles of land. Provided if Solomon Towne or heirs pay to James King \$3000 plus interest in one year, this deed is void. Solomon and Lydia, for \$1 release to James King rights of dower in premises.

This estate coming to their father Ezekiel Goss from Elizabeth King, widow now deceased, and conveyed to their mother Almira D. Goss.

Jennie M. Emmerton, widow of George R. Emmerton sells for \$1 to Eliza Stevens Osgood, wife of Nathan C. Osgood land and dwelling house & other bldgs. described as follows: Commencing at Chestnut St. by land formerly of Neal now of Kittredge, W. on Chestnut St. 54.35' to land now or late of Shreve, then S. by land of Shreve 68'75" to land of Waters, E. by land of Waters 43' to land of Kittredge, by land of Kittredge N. 28.1', E. 17.3' N. 42.45' to point of beginning.

Book 2004 p. 261 Jan. 22, 1910

Octavias B. Shreve & Wm. P. Shreve, trustees under will of Benjamin Shreve, late of Salem sell to Nathan C. Osgood for \$4000 land betw. houses #15 & 17 described as follows: N. by Chestnut St. 62.65' E. by land of Elza S. Osgood formerly of Goss and land now or late of Waters 117.5', S. by land now or late of Waters or Blake 48.5', W. by land of grantors 122' (containing approx. 6580 sq. ft.) subject to this restriction: no buildings will ever be built closed than 30' to house #17 while Shreves own #17.

Burns land in Salem together with buildings thereon bounded & described as follows: Commencing at a point on Chestnut St. at land now or late of Kittredge, running W. by Chestnut St. 52.78' to land (described following) then S. by said land 68.75' to land now or late of Waters, then E. by Waters' land 43' to Kittredge land, then N. by Kittredge land 28.1', E. 17.3', N. 7.85' and 34.7' all by Kittredge land to Chestnut St. and point of beginning.

Also land betw. houses #15 & #17 on Chestnut St. as follows: N. by Chestnut 62.25', E. by parcel described above & by land now or late of Waters 117.5', S. by land now or late of Waters or Blake 48.5', W. by land now or late of Shreve, 122' (approx. 6580 sq. ft.)

Solomon Towne, entered from Calcutta with a cargo of sugar, indigo and cheroots" William Gray of Salem owner is spoken of as one of the "greatest merchants in Mass." In 1803 of 132 Salem vessels engaged in foreign trade, 36 were owned by Gray. His son William R. Gray was his agent in Boston.
- - p. 2885 ship "Baltimore", 1832 owner John Sever blt. in Kingston
 - p. 2991 ship "Galatea" 300 tons blt. by Enos Briggs, Salem launches 1810, sold to Henry Gray. (not reg. from Salem)

Diary of William Bentley contains 2 brief references to "Mr. Town's (Amos') writing school opened in the west end." 1802

p. 264 Salem Imprints by H. S. Tapley lists Solomon Towne as a member of the new "Salem Evangelical Library" of 500 volumes.

Salem Marine Society lists Solomon Towne as a member, joined in 1821. Later noted as "left the society."

P. 291 Salem and the Indies by James Duncan Phillips notes that Capt. Stephen Phillips bought lot at #17 (Chestnut St.) in May 1804 and by end of the year had completed that house . . . "2 or 3 years (after 1805) Capt. Solomon Towne built a wooden house at #15" (no documentation is shown for this 1807 or 1808 dating)

P. 11 Notes on Building of Chestnut St. by Wiswall. He mentions Solomon Towne as Capt. of the "Galatea". He claims the house was built in 1810 by Solomon Towne, as there was "no mention of a house" in earlier deeds. He notes that the house seems to have been a 2-family house and lists the following people as known to have lived at #15; (incl. Townes) E. H. Payson, 1828; Capt. Jeremiah Page, 1829 or earlier; A. F. W. Gayle before 1837; Mrs. Harriet Rose, 1846; John Chadwidk, 1841; Ira Cheever, 1846; Capt. William Pierce, wife and 4 daughters lived in whole house 1849-1855; Ezekiel Goss 1869-'81; George Shattuck 1899; the Nathan Osgoods 1901-1932.
