Built for HENRY THOMPSON, teamster c. 1830

Research: Mark Droste September, 1994 Built c.1830 for Henry Thompson, teamster of Salem

Andrew Jackson was inaugurated the seventh president in 1829. In October of 1829 the first luxurious hotel of the New World opened in Boston. The Tremont Hotel had 170 private bedrooms with door locks, soap and water in each room, indoor toilets, menus for dinning, room clerks, and bellboys, all new and first time ideas for the New World. The 1830 census recorded a population of 12,866,020 people living in the United States. On September 16, 1830 Oliver Wendell Holmes wrote the poem "Old Ironsides", which was published in the Boston *Daily Advertiser*. Holmes wrote the poem after hearing that the *Constitution* was to be dismantled. The poem was so popular that it helped to lead the way in a campaign to save the historic frigate.

In 1830 the population of Salem was 13,895. Henry Thompson had his house bilt circa. 1830. He lived in the house until his death intestate in 1860. His widow, Abigail, received the first floor of the house and the western half of the cellar and the attic. The children received the second floor and the eastern half of both the attic and cellar.³ Abigail lived in the house until 1876. Orrin Thompson, a clerk, then lived in the house until he sold the property. Olive Newbegin bought the house and then immediately sold it to Louise Waters. Louise and her husband Ernest lived in the house until 1933. The house was vacant for two years before being rented out.⁴ Richard Blake, a lawyer and notary, then moved in in 1939 after his wife bought the property. They lived the house until 1951 when they sold the property.

remaining part of said lot retained + owned by said Stone and parallel with the first described line to the middle of a bound stone on Green Street then running easterly on said Green Street sixty three feet + nine inches to the first bounds..."

Henry Thompson left his lands to his three children Kate L. Thompson, Caroline A. Brown, and Orrin F. Thompson.

Kate L. Thompson married Samuel D. Chamberlain, then later she married William W. Doherty. She died interstate and her sole heir was her daughter, Anna A. Chamberlain. Anna died August 23, 1892, she left her estate to her uncle Orrin F. Thompson, see Essex Probate #73222.

Caroline A. Brown died leaving her brother Orrin F. Thompson as her sole heir. Orrin F. Thompson left the property to Orrin Clayton Symonds, see Essex Probate #143229.
