# 10 Broad Street

#### Built in 1800 for Hannah Smith, Widow

#### History of the Property:

The house that presently bears the address 10 Broad Street was built in 1800 by the widow Hannah Smith, partitioned by her heirs in 1831, and reunited by another Salem widow, Hope Brown, over a hundred years later.

10 Broad Street sits on a small parcel of the seventeenth-century "homestead land" of Jonathan Neale, one of Salem's first settlers (see inserted "Part of Salem in 1700" no. 5, from The Essex Antiquarian, Volume IV (1900)). Jonathan Neale was Hannah Smith's grandfather, and their heirs would reside in the Broad Street neighborhood well into the nineteenth century. Twenty years after the elder Neale's death in 1732, his homestead was partitioned between his two sons, David and Jonathan Jr.; the former received a northern section bordered by the lots of various Essex Street property owners while the latter took possession of a sourthern lot bordering Summer and Broad Streets and John Pickering's land to the west (Essex County Registry of Deeds, Book 100, leaf 14). For most of the eighteenth century these Salem streets are referred to as the "Street or Highway to Marblehead" (Summer Street), and the "Highway to the Pound" or "Highway to the Almshouse" (Broad Street) in property and other records. Only at the turn of the nineteenth century did they assume their modern names. Likewise, Cambridge Street, the lane which ran through the Neale properties northward toward Essex Street, was known as "Almshouse Lane" or "Meeting house Lane" in the middle of the seventeenth century and Cambridge Street at its end.

A second partition of the Neale properties occurred in 1799, after the deaths of David and Jonathan. Their heirs divided up the two estates between them, and Hannah Smith, the daughter of Jonathan, forty-three years old and recently widowed, was assigned "lot no. 7, together with the small old house thereon, bounded as follows: beginning at the southwesterly corner of the same on Broad Street and the southeasterly corner of Cambridge Street and from thence running northerly by Cambridge Street seventy feet, thence running eastwardly, straight to land of Woodbury, from thence running southerly by said Woodbury's land fifty-three feet to Broad Street, from thence running westerly one hundred and twenty-five feet on Broad Street to the first point — together with the well upon this lot, to have and to hold the premises so assigned to the said Hannah Smith as aforesaid, to her and her heirs and assigns forever..." (E.C.R.D. Book 166, leaves 69-72).

Apparently Widow Smith was not content with the "small old house" on her new property, for the next year she demolished it and began

building a new house. For financing, she turned to a Broad Street spinster, Mary Hathorne. In the spring of 1800 Smith mortgaged "a certain piece of land, on which I am now building a dwelling house" to Hathorne for \$150 (E.C.R.D. Book 166, leaf 243). Smith's heirs eventually paid off the loan in 1842. The house that Widow Smith built was too large for her needs, so she periodically leased the half that bordered Cambridge Street to various tenants. Joseph Farmer, a Salem farmer, occupied the Cambridge street side from 1813 to 1825 (E.C.R.D. Book 201, leaf 60 and Book 206, leaf 131).

Hannah Smith died in early 1831 and her estate was partitioned among her heirs, sons George and Joseph Smith and the minor children of deceased son William Smith, in April of that year (Essex County Registry of Probate, Docket #25538). At this time her real estate, including "a lot of land situated in Broad Street valued at \$1200" and "a two-story dwelling house on said land valued at \$300" was divided into three lots. Lot number 1 constituted the western (Cambridge Street) end of the house and was granted to Joseph Smith and the minor heirs of William Smith, lot number 2 constituted the eastern (Broad Street) end of the house and was granted to George Smith, and lot number 3 constituted a lot of land situated on the northern border of the house, assigned to Joseph Smith and William Smith's heirs. From this date until after World War II, the house was formally divided into two residences.

For the remainder of the nineteenth century, the western half of the house, 19 Cambridge Street, was continuously occupied, while the eastern half of the house remained vacant for long periods of time. This was primarily due to the fact that the owners of 19 Cambridge Street used their property as a residence, while the owners of 10 Broad Street viewed their property as an "investment". In 1839 Joseph Smith, cabinetmaker, sold his "undivided half part" of 19 Cambridge Street to John Aaron, cabinetmaker, who occupied the western house of the house until the end of the century (E.C.R.D. Book 316, leaf 175). William Smith, the grown-up son of William Smith deceased, sold the other half part of the property to Aaron in 1841 (E.C.R.D. Book 323, leaf 249).

George Smith died shortly after the 1831 partition, and his son and widow retained possession of the eastern half of the house until 1842, when they sold it to Joseph Smith who in turn sold it to George W. Felton on the same day (E.C.R.D. Book 331, leaves 171-172). Felton was unable to finance the purchase, so he immediately mortgaged the property to mortgage broker George Wheatland, who in turn conveyed the mortgage to a succession of assignees (E.C.R.D. Book 331, leaf 173; E.C.R.D. Book 334, leaf 16; E.C.R.D. Book 416, leaf 140). Felton was not able to pay off the debt until 1865, after which he sold 10 Broad Street to Mary Wilson, who occupied the house until her death in 1883 (E.C.R.D. Book 691, leaf 180; E.C.R.D. Book 692, leaf 53).

Peter Ingoldsby, tanner, purchased 10 Broad Street in 1883 from the heirs of Mary Wilson (E.C.R.D. Book 1119, leaves 216-217). The Ingoldsby family lived in the house until Peter's death in the 1920s, after which his children and heirs transferred its title to their mother, Ellen Ingoldsby, who was in residence until 1931 (E.C.R.D. Book 2719, pages 237-238). In 1929, Mrs. Ingoldsby's son James, a

chemist and resident of 17 Cambridge Street, purchased the western half of the house, or 19 Cambridge Street, from the trustee of a trust earlier established by John Aaron, thus bringing both halves of Widow Smith's house into the possession of one owner (E.C.R.D. Book 2821, page 288).

Though 10 Broad Street/19 Cambridge Street was brought under single ownership in 1929, James Ingoldsby still maintained it as two properties. From 1930 until Hope Brown took up residence in 1954, both halves of the house were alternatively vacant or leased to a succession of short-term tenants, including Karl and Elinor Patten (19 Cambridge, 1940-1945) and James Civitarese, laborer (10 Broad, 1950-1954) (Salem Directories, 1930-55). The Ingoldsbys continued to reside at 17 Cambridge Street, next door. In 1945 Anna Florence Ingoldsby, administratrix of the estate of her father, James Ingoldsby, sold "19 Cambridge Street/10-10 1/2 Broad Street" to Hope Brown of Salem (E.C.R.D. Book 3416, page 158). Mrs. Brown did not move into the house until 1954, the same year that it was converted to a single-family house and "19 Cambridge Street" disappeared. After nearly thirty years in the house, Hope Brown retired to Castine, Maine in the early 1980s and sold 10 Broad Street to Ann Burke Neubert in 1983 (E.C.R.D. Book 7059, page 306). Neubert occupied the house until her death in 1990, after which her brothers and heirs conveyed the property to John T. Mastovich and Vonzella A. Moore-Mastovich, its present owners (E.C.R.D. Book 10759, page 64).


