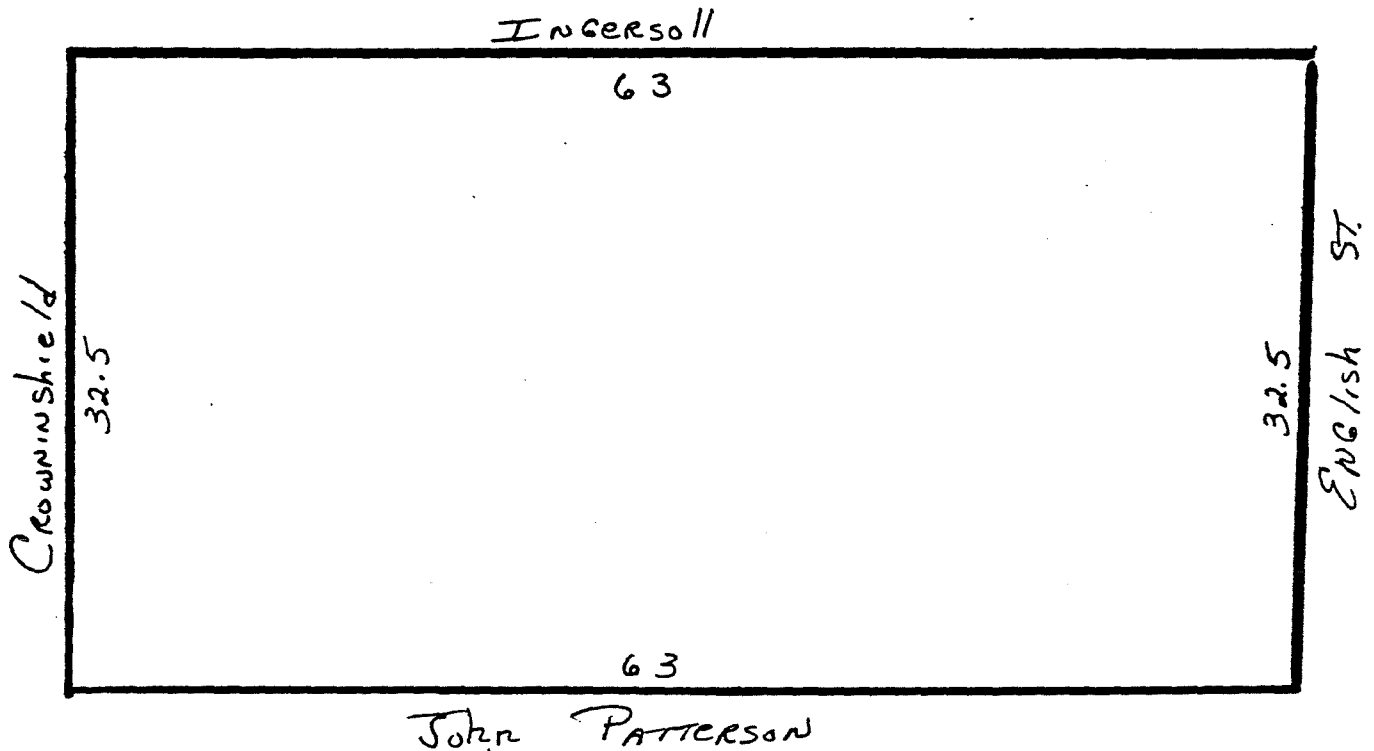

sold a lot of land to Joseph Webb:

March 27, 1807  
\$2,000

Joseph Webb, boatbuilder, sold a dwelling  
house and land to Daniel Moore, shipwright.  
The same property as described in the deed  
from Samuel Masury.

Book 185 page 73  
July 29, 1808

Daniel Moore, shipwright, and his wife  
Margaret, mortgaged the land and dwelling  
house to Isaac Stilman Bullock, trader.

Book 420 page 124  
Nov. 19, 1849  
\$850

Isaac S. Bullock, trader, and wife Sarah sold the land and dwelling house to Daniel Gilman, ropemaker.

Book 3615 page 273  
July 29, 1948

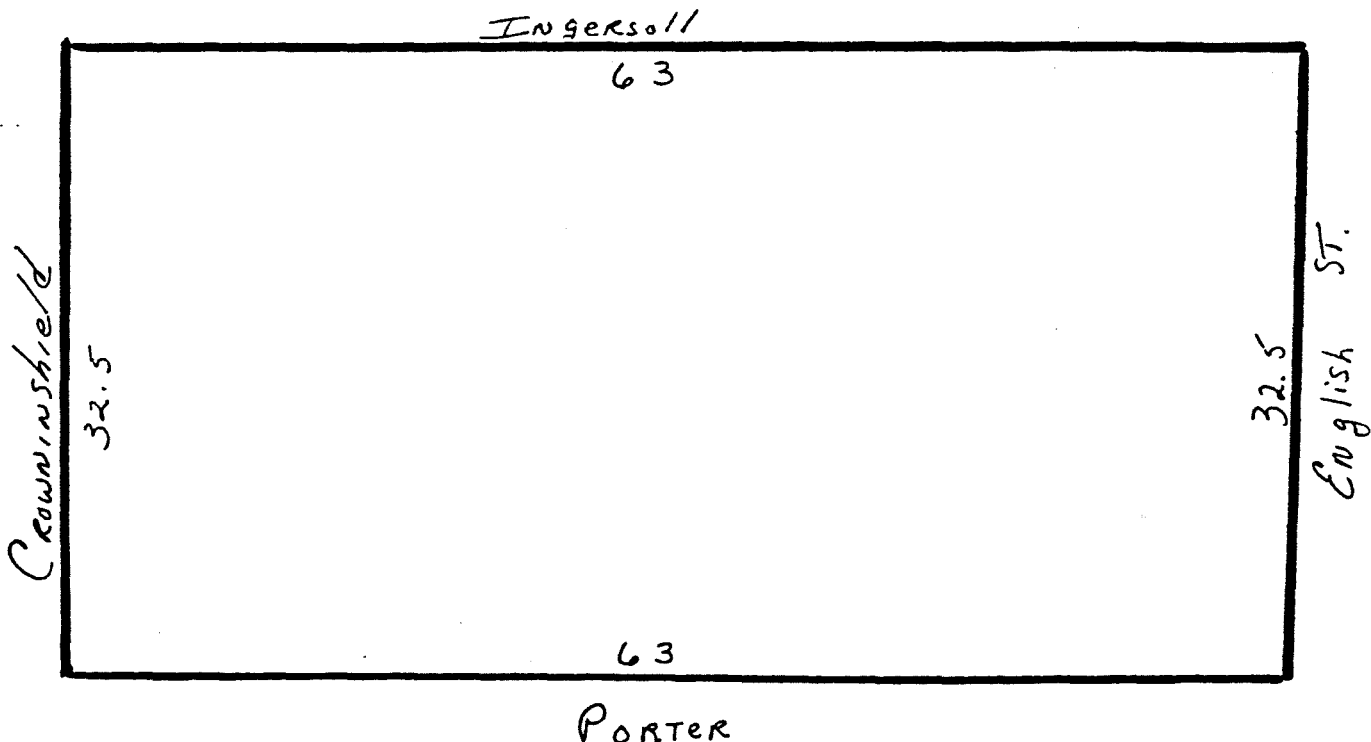
Clarence and Grace E. Richardson, heirs of Daniel Gilman, sold the land and buildings to Clarence and Nita Stewart.

Book 3870 page 223  
Jan. 14, 1952

Nita Stewart sold the land and building to Roland and Annette Dumas. The same property as described in deed book 3615 page 273.

Book 4146 page 587  
March 11, 1955

Roland and Annette Dumas sold the land and building to Anthony J. and Ruth E. Welenc. The same conveyed by deed recorded in book 3870 page 223.
