31 Broad Street

Built in 1846 for Charles M. Richardson, Purveyor of Hardware

History of the Property:

The lot on which 31 Broad Street sits is the former site of the seventeenth— and eighteenth—century western common land of Salem and a bordering parcel of the large Hathorne estate (See inserted Map of Salem in 1780). One of the founding members of the famous Hathorne family, the merchant John Hathorne, bought the land adjoining the common pasture from Resolved White and Lott Gourdling, respectively, in 1680—81 (Essex County Registry of Deeds Book 5, leaf 101; E.C.R.D. Book 6, leaf 21). A century later, after Broad Street was laid out, the small strip of remaining common land bordering the farm of "ye worshipful Major Hathorne" was the site of "the Salem Circus" (Sidney Perly, "Part of Salem in 1700", The Essex Antiquarian IV (1900): 97—102).

When the scattered Hathorne holdings, including the family "mansion house", were partitioned by the Court of Common Pleas in 1808, the Broad Street property, was conveyed to Luke Brooks, trader and

grocer, a grandson of Major Hawthorne (E.C.R.D. Book 185, leaves 2-3). Several years later, Brooks purchased the adjoining common land from "the inhabitants of the town of Salem" for \$41.60 (E.C.R.D. Book 186, leaf 255), thus forming the lot on which 31 Broad Street was later to sit.

Brooks maintained the old Hathorne farm buildings along the newly-laid-out Hathorne Street, but did not build on the Broad Street lot. He resided with his wife Mary on Water Street, near his grocery business (Salem Directories, 1836-1846). In 1845 Charles M. Richardson, hardware merchant, bought the "certain parcel of real estate...bounded by Broad Street and Hathorne Street" with no extant buildings, from Brooks (E.C.R.D Bood 357, leaf 163). Richardson operated a business at 207 Essex Street and resided at 4 Broad Street at the time of the transfer (Salem Directory of 1846). In 1846 he erected the former and present 31 Broad Street, which is clearly indicated on the 1851 Map of Salem (inserted).

The Richardson family lived in their new house from 1846 to 1884, during which time Charles Richardson expanded his Essex Street hardware business. In the latter year, he sold "a certain parcel of land with the buildings thereon situated in said Salem and bounded Northerly on Broad Street....and Easterly on Hathorne Street...." to Clarence Hayward (E.C.R.D. Book 1136, page 74). Hayward, a salesman in Boston, and his family lived in the house until 1913. In April of that year, the executors of Hayward's estate, his children, conveyed the property to William F. Cass, owner of Cass & Daley Shoe Company at 24 Saunders

and 28 Goodhue Streets (E.C.R.D. Book 2207, page 46).

Cass found himself in an overextended position in 1926 and declared bankruptcy. The court-appointed Trustee in Bankruptcy, Guy C. Richards of Beverly, conveyed Cass's residence to his brother John L. Cass in May of that year (E.C.R.D. Book 2679, page 90). John Cass held on to the property for only a few months, and then sold it to Bessie M. Strangman, the wife of Dr. William Strangman, a dentist with offices at 208 Essex Street (E.C.R.D. Book 2694, page 483).

Upon Dr. Strangman's retirement nearly twenty years later, the Strangman family decided to move to Rockport and sold the house to Lincoln and Elizabeth Davis in 1944 (E.C.R.D. Book 3366, page 71). Mr. and Mrs. Davis transformed the residence into the "Davis Nursing Home" shortly thereafter, the first of its two institutional functions in the twentieth century (Salem Directories, 1946-1959). After operating the nursing home for thirteen years, the Davis couple sold 31 Broad Street to Richard and Ellen Rulon of Salem, who owned it for only two years (E.C.R.D. Book 4612, page 96). In 1961 the Rulons sold the property to the Roman Catholic Archbishop of Boston, "A Corporation Sole" (E.C.R.D. Book 4769, page 57). From that date until 1973, the house functioned as the Catholic Charities Center of the North Shore, with the Reverend John J. Tierney in residence and serving as director (Salem Directories, 1961-1973).

31 Broad Street returned to a residence in 1973 when the Archbishop of Boston, then Humberto Madeiros, conveyed the property to

Peter and Barbara Copelas, owners of Peter's Laundry in Salem (E.C.R.D. Book 6018, page 726). In two transactions of September, 1987, Peter Copelas transferred the property to his wife, who in turn conveyed it to the newly-established Boone Realty Trust (E.C.R.D. Book 9171, page 179; E.C.R.D. Book 9173, page 22). Two years later, the Trustees of the Trust, Barbara Copelas and Linda Copelas Jones, sold the property to Stephen Grasberger and Katherine Van Dyke, its present owners (E.C.R.D. Book 10156, page 334).





Summary

The answer to the title search of this gracious 19th Century home is found in the Salem Tax Records. In 1844, Charles M. Richardson was boarding at 4 Broad St, paying no real estate taxes. A year later, he still lives at 4 Broad, but is building a new house. And by 1846 he lives in and pays taxes on his new house, noted "finish." There does seem to be a bit of confusion as to what the number of the house is to be — it is noted as "33", "39", and finally "31." But Richardson didn't own other land on Broad St. 30 we know it is the same house. This house should have a historic sign with the building dated 1846.
