15 MALL STREET

Built for JOHN FAIRFIELD, merchant c. 1810

Research:

Mark Nystedt April, 1993 The house at 15 Mall Street was built by John Fairfield, merchant, about 1810.

John Fairfield purchased the land from Jonathan Mason, executor of the last will and testament of Jonathan Mason, his father, on the 24th of November 1800 (ECRD bk167 pg227). This irregular shaped parcel of land was approximately 80 feet wide and extended about 700 feet from Brown Street (now, Washington Square North) to the road by the North River (now, Bridge Street). During the next ten years, Fairfield laid in Mall Street, and was able to build at least three houses, one house.for himself (on the east side of the street) and at least two houses (on the west side of the street) that he was able to sell (1810 Fairfield bank mortgage deeds describes Fairfield land as abutting the property of Gray and John Derby on Mall Street). On March 5, 1810, Fairfield mortgaged his remaining property to Jonathan Gardner (ECRD bk189 pg189). That mortgage was satisfied three weeks later, on March 30, when Fairfield mortgaged the property to the Essex, Salem, and Marblehead Banks. Three houses, now numbered 13, 15, and 17 Mall Street, were located on that portion of the property that was mortgaged to the Essex Bank (ECRD bk189 pg220). Fairfield was unable to satisfy that mortgage and the Essex Bank took possession on March 16, 1816 (ECRD bk210 pg87). It is not known if anyone lived in the house during this time.






