

Peletiah Brown, wharfinger, mortgaged his land and dwelling house to Joseph Chipman Ward, trader. The property was then described as:



Book 242 page 159 Oct. 20, 1826 The land and dwelling house was deeded to Joseph C. Ward. Mr. Ward leased the estate to Peletiah and Hannah Brown "for and during their natural lives and the life of such survivor yeilding and paying therefor the annual rent of one dollar if demanded for each year during said term."

The heirs of Joseph C. Ward sold the land with a dwelling house to Hannah Trumbull. The same described in deed book 242 page 159. Hannah Trumbull, daughter of Peletiah and Hannah Brown, died in 1845.



Edward H. Trumbull, master mariner, sold his rights to the land and buildings on Winter St. to Ephraim and Maria (Trumbull) Brown. "The whole estate conveyed to my late mother by deed of Ward et al."

Ephraim and Maria Brown razed the old buildings on this land, then called ll & 13 Winter St., in 1868. The couple then proceeded to build a new house on this lot. Ephraim Brown died on March 28, 1879. Maria Brown died on Oct. 12, 1912. The house and land was devised by Maria Brown to John S. Williams.

Book 2344 page 141 Sept. 27, 1916 J. Stoddard Williams sold the land and dwelling house to the Trustees of Essex Mutual Investment Co.

Ralph B. Williams of Garden City, New York; Leonard H. Goodhue and Alice T. Goodhue, in her own right, of Malden, MA.; and Chester P. Williams of Malden, MA. sold the land and buildings to Constantine Moustakis. "The same devised to our father, John S. Williams, by Maria Brown."

The heirs of Constantine Moustakis sold to George C., Nicholas C., Louis C. and John C. Moustakis, along with M. Pauline Murphy one share each in and to the estate at 11 Winter St.

M. Pauline Murphy sold her 1/5 share to Louis C., Nicholas C. and John C. Moustakis. George C. Moustakis sold his 1/5 share to Nicholas, Louis and John Moustakis.

Nicholas C., Louis C. and John C. Moustakis sold the land and buildings to Urania Marcopoulos and George J. Marcopoulos.

Urania Marcopoulos and George J. Marcopoulos conveyed the property to George J. Marcopoulos. "Being the same premises conveyed to us by deed of Nicholas C. Moustakis et ali, dated June 16, 1966." Book 7100 page 92 April 11, 1983 George J. Marcopoulos, now of Somerville, conveyed the land and buildings to Jonathan T. Huntington, II and Patricia J. Huntington, husband and wife. "For my title see deed recorded with Essex South District Registry of Deeds, Book 6077, Page 196."

Reference to book and page are deed books at the Registry of Deeds. Probate numbers are cases at Probate Court. Both offices are located in the same building on Federal St. All maps in this report are not meant to be exact, just for illustration purposes.

DATE DOCUMENTATION

11 Winter Street

This house is described in the Salem Historic Commission Report as: "Similar in size to its neighbor #7, this two-story plus pitch roof, wooden house has many features of the Italianate style and is probably a few years older than #7. The broad, recessed entrance has ornately carved bracket trim, the first floor window lintels are Italianate as is the matchedboard facade, bay window, paired brackets under the broad eaves and facade gable."
