 - 6 Attended Church at the Old South with Hon. Mr. Bemja, min/
 - 8 Hon. Aaron King arrived and I was appointed to conduct him to the Governor and Council to be qualified.
 - 9 The President of the Senate proceeded to appoint the different committee on the part of the Senate.

In consequence of the great number of Petitions presented to the Legislature for the allowance of Claims against the Commonwealth, the above named Committee were in session almost every day during the session of the Legislature and reported on 77 different cases, every one of which were accepted as reported, althosome were very spiritedly debated.

In March a Petition was presented in the Senate by David I. Paul and many other citizens of Millbury in the County of Worcester for the removal of Abraham I. Randall, Esq. from the office of Justice of the Peace for said Worcester County.

The Examination was Prosecuted by Park of Boston on the part of the Petitioners and by Chandler & Hall on the part of the Responders.

After several serious and tedious sessions of the Committee. and examining nearly one hundred witnesses and Depositions and hearing the very eloquent and learned remarks and speaches of the Council for an against the delinquent, the Committee submitted to the Senate a Printed Report of their opinion in the case. It was unanimously agree to and signed by all the Committee stating that altho all the charges against him were not fully proved, yet enough appeared to satisfy them that he was so far guilty that an Address ought tobe made and by said report an address was made to the Executive of the Commonwealth for the removal of said Abraham I. Randall from the Office of Justice of the Peace. The report was presented in the Senate by the Hon. H. L. Dawes, Chairman of the Com. who moved that the same be accepted. On this motion a Debate commended principaly by Hon. Pliny Merrick of Worcester in opposition to the Report, principly on ghe ground that the Committee had reported merely their opinion without the evidence on which their opinion was grounded. Before the question was taken, a subsequent day was assigned when Judge Merrick abandoned the former ground and was about to argue on the Constitutional question, when it was moved to lay the subject on the Table, which was sustained.

- May 3 Not having kept any daily record of events while at Boston, I shall hereonly remark that the Legislature adjourned on Friday 3rd May having attended 119 days and travelled 120 miles. I received \$262. Dollars. My expenses at the Hotel and two travels home and back during the Session amounted to about \$122. dollars. I started in the cars and arrived at Springfield to dinner. Mr. Dawes and his wife and Mr. Hawley came, also, Staid at the Massasoit.
 - Started in the cars with Gov. Briggs, Hon. Mr. Owen, Counsellor and Hon. Mr. Benjamin and wife, Mr. Strickland and Mr. Bates and came to Westfield and home with Stephen Spelman with Mr. Strickland and Mr. Bates. Timothy and his family and James had been very sick and James Babe died on the April.
 - 5 Raining. Attended Church in the afternoon.
 - 6 Cool damp weather
 - 7 Went to Springfield with Ansel King to Probate Court. Received severe censuring from Judge Morris. The Law altering the times of holding the Probate Court repealed the old Law so far that he could do no new business on this day.

HON. JAMES COOLEY DIED SEPT.20, 1851 AGED 72

Copied from the Diary of the Hon. James Cooley by Avola B. Hiers. He was halph H. Hiers great-great-grandfather. Items of historical interest or family interest are CAPITALIZED. Most of the parenthesis contain my comments although are, obviously, Mr. Cooley's, Many blank spaces are left as I may be able to interpete some of the penmanship later.

Later. October 18, 1975 - with the help of melena Duris I have filled in some of the names. However, many of the blanks were left by Mr. Cooley.
