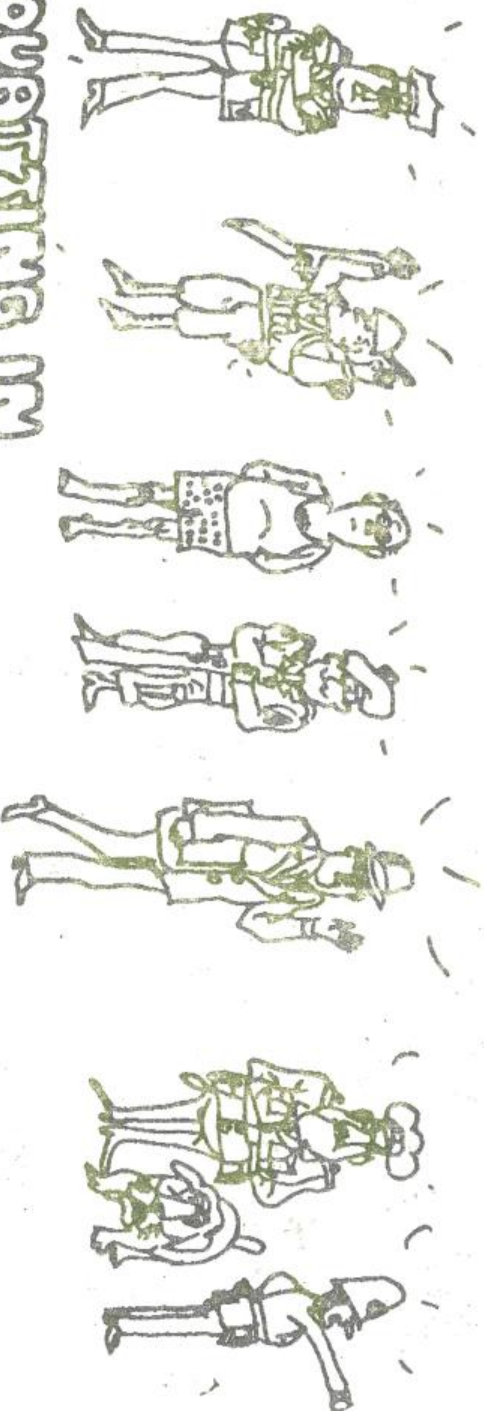

SQUATTING IN AMSTERDAM. PART 2

A few more differences between

London and Amsterdam play an important role. With slightly less redundancy in Holland than in England, living on the dole in Holland means some £250/300 pcm but you have to pay your own rent etc. Squatting, not implying not paying rent, quite a few squatters in Amsterdam may have regular jobs but are squatters because they're not licensed. So, most squatters can afford to have a telephone which plays a crucial role in the whole day to day concept of squatters organisation. Squatting is also much more widely socially accepted, although most of the public seems to resent the over-published 'squatters riots'. In court a case of the housing council or owner vs. squatter/s may be won by the defendant, resulting in a tenancy or sometimes even a summons to the owner to carry out repairs. But to make it to court, the prosecution must know your name: courts cannot take a case against a 'present occupier' - they need your name and it is quite easy not to let them know.

And last but not least, Amsterdam people have better social attitudes than Londoners, generally speaking. Go over to Amsterdam and find out yourselves. Depending on the situation of concern, what you generally do when you move into a squat in Amsterdam is to knock on your neighbours door, introduce yourself as a squatter, and your neighbours will either show their disapproval or, more likely, offer to help you out with things like an electricity line or use of their showerer until you've got your own, and if you're lucky, they'll give you some spare furniture or curtains, because they are/ have been squatters themselves.

SOUTHARK CAPPED



So, Southark Council is to be rate capped by 24%. Shouts of indignation at the Tory Government and much bleating about being one of the poorest Boroughs in London. So if this is the case, why so much waste? If money is short in one direction why not make more in another? Why wasn't the original policy of giving tenancies to squatters kept to? So that instead of 500+ squatters there would be 500+ tenants paying, say, an average rent of £20 giving a revenue of £10,000 per week or at least £3m a year-0.K. so this may not represent a large percentage of the budget yet it would be gain and not loss as at present. This money is being wantonly refused by Southark Council because of its ridiculous policy of not giving tenancies to squatters. This doesn't take into account the further money being wasted on legal action - the council officers' wages, the costs of solicitors and the court cases - as well as the costs of 'improved security' - the steel-doors alone cost £400 each - all this must add up to a tidy sum and all waste. So don't bleat about not having enough money, Southark Council, you must have plenty if you can afford to throw it away the way you do. Stop all this legal nonsense against squatters, cancel the orders for steel-doors, give tenancies to people in hard-to-let places and start collecting the rent. After all, most people would claim it from the D.H.S. Anyway so you'd be getting your support from the government in the end - and don't worry about repairs etc. most squatters are prepared either to put up with lower standards or do their own. So come on Southark Council get wise - there's no way you can get rid of us 'cause we aint got nowhere else to go. So stop the hasslin' and let's start working together on the real problem - you know - the one up the road over the river.

Dear All,
S.N.O.W. is a loose knit collective of people who are squatting/have squatted or are interested in the practice of squatting who live in Southark fairly close to the Ambulance Station where the present SNOW office is.

There is no set membership of SNOW. Nobody pays any membership, nobody carries a membership card and nobody has any power or authority over anybody else within the SNOW collective. Decisions, if they are necessary are decided by consensus at SNOW meetings which, although sometimes stormy and untidy, have continued to happen for over 18 months now.

'The Wire' is a 'squatters comic' which is put together voluntarily, paid for by donation and distributed free of charge to 400 odd squats. The 'Wire' grew up as a newsletter to the squatting community and as the community has continued to grow, so has the Wire. To assume that the only thing of interest to squatters is squatting would be narrow minded or political, and therefore the wire has attempted to diversify in whatever direction contributors write in. This has often been controversial and censorship has been discussed. However, the largest problem seems to be that people who consider that they are part of the SNOW collective assume that they are automatically associated with anything which is printed in the Wire. By the same token they should assume that all normal media-hype illusions of squatters apply to them.

I am frequently unimpressed with the contents of the Wire, but to assume that all the other readers have the same morals/value judgements as me strikes me as pretty fuckin' arrogant. Any possible editorial/censorship policy relies on somebody or some group of people deciding what people should and shouldn't read, which is obviously not going to please everybody.

Perhaps it would be more constructive if the enlightened few in our community took it upon themselves to explain to the depraved masses why they shouldn't get into the crap that the Wire churns out.

KEEP ON KEEPIN' ON

The general state of music/bands to-day reflects the apathy and non-direction of our culture. I, for one, am becoming increasingly disillusioned with many of the bands we all so avidly follow now that it seems so hopeless under this Government.

People generally thin quite optomistically, that things will get better. But most people do NOTHING really to make that happen. Our current indulgence with Gothic Spiritualism (Cramps, The Cult, Nick Cave etc.); Anarchy re-visited (Conflict, State Hate, Chaos etc.) and Fetish-Disco/Punk (Divine, Dead or Alive etc. Sorry Neil!) doesn't really lend much weight to any organised struggle by young people. This doesn't dispute that the music is good; the majority of it is, but it relies so heavily on the Image Machine to achieve any credibility.

The old rock cliché of an 'image if important' may have had some truth behind it when we view music over the last 25 years, but is it really important now? It certainly is if you want mass success, but those bands who participate in that lose any inch of credibility they ever had, their personal integrity (if they ever had any) and instead help to perpetuate fashion and the NEED for an image.

An image has lost its importance ... or at least that's what I argue. When it's so obvious that this country's in a diabolical mess - isn't constructing an image more a sign of going mad, delirium, giving up trying than being individual and militant?

'Anarchy' is washed up. It has got nowhere and it will get nowhere. It is just an arrogant rejection of left and right - with no real solutions or answers offered. You only have to see the last STOP THE CITY to illustrate this point - it was a complete farce - the only damage that was done was to STOP THE CITY themselves. 'STOP THE CITY' is pantomime politics. The intentions are good, but the practical capabilities and theory are too basic to be taken seriously.

The anarchism of the past six years or so must now make way for a positive move to the left. Why? Because you cannot sit on the fence and declare impartiality at such a time as this - where would the miners be if they declared they wanted the right NOT to work!! Thatcher would have a hey day.

Stop and think. Just where is this anarchism going? What has it achieved? Did the GLC get to where it is by being anarchists? Would the miners win if they declared opposition to work? Would the NHS, the welfare State etc. exist because of the campaigns of unorganised anarchists on 'Stop the City'? The answer is simple ... NO. Socialism has won these advances, and no matter how pessimistically you view them, life would be a sight harder that it is now.

This brings me around to the The Redskins, 3 blokes with crops and DM boots - not really anything new, but who gives a toss what they look like - their music and lyrics are brilliant. Knock them as much as you like, but this lot are actually SAYING SOMETHING, unlike a lot of bands I could name, who just spout pretentious arty-farty crap.

For once in a long time, a band like this is actually offering hope and yes, change. But not arty-farty anarchist driven about vegetarianism and the occult but positive working class socialism - the spirit that has kept the miners' strike going since the beginning. So stop messing around with those abstract concepts and transsexual occult paedophilians dressed up like paranoid afterbirths and move towards socialism.

'Keep on keepin' On' is the Redskins' current single, a lyrical anthem to the Miners' Struggle in all its strength - "The bosses jump, the workers fall in line

They whip us into line, with threat of the dole."

This is the text of a leaflet produced last week. It's meant for squatters who have had High Court Cases.

DOM'S FEAR EVICTION

Many people will feel it is hopeless to stay put in their flat when a Possession Order has been granted. It may seem better to get out and go somewhere else rather than live with the uncertainty of not knowing when the Bailiff is going to come. However, there is an alternative - you can **RESQUAT**.

Several weeks after the Possession Order has been granted you will receive a Sheriff's Writ. This is a notification that the Sheriff's office has the power to evict your flat (See (A).). In the past it has been at least two months and sometimes over six months before the eviction takes place. Recently the Council has been delivering a letter informing occupiers that eviction is imminent. (In practice this means within 7 days. See (B).).

Try to make sure that you're home when the Bailiff's come to evict you (as they may damage your flat if you're not there). Leave your furniture inside and get an inventory for it. Hang around while they're securing your home and watch what they do. If they put up a steel door make a note of how they attach it. Wait until they go away then go back in again.

Remember - re-squatting is not illegal and you'll have at least six more months in your home.

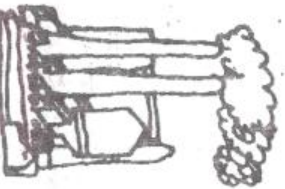

Here are some points for people thinking of getting turned on legally.

If you go down to the IEB office and fill in the form they'll try and get £100 deposit off you if they know you're a squatter.

No avoid this try :

1. Ask to go on the the budget scheme. Don't tell them you're a squatter. This won't work if there's money owing from the previous user. Although you're not liable for this it makes them more reluctant to give you a supply.

2. If you've had a supply before and can give the address you're okay, as long as you don't owe them anything.

3. Get a guarantor to stand for you. This makes them liable for your debts so who do you know like that.

4. If you've got a bank account you can make a standing order for say £10 a month. But they still want a deposit. Some people have hassled and got it down to £50.

5. Always say you can't afford £100 and offer less, say £50, if you can.

We had a 100% turn out on our part, the council had a 100% success as far as they were concerned. Still we gave them a bit of hassle and it was fun anyway to see just what walls the council are when it comes to managing their affairs.

P.I.O.

The dreaded P.I.O. hasn't appeared yet. It seems that the Council are still trying to work out how to use them. At this stage we may fairly safely say that we won't see one this side of the New Year. Nevertheless the Council are liberally slapping stickers on like confetti. Every housing district now has them. The problem is, that the Council are using them not to inform squatters that the gaff they've got an eye on is protected, but rather to scare squatters off.

The first one that SNOW heard of appeared in Rockingham four weeks ago. It was slapped on the door of a flat that was already squatted, though the people there didn't have a legal warning up. To date all they've received from the Council is the standard "according to our records etc" letter and a festive greeting from that ball of slime Cooke the property investigator. Obviously, a P.I.O. certificate will not be used on this people at this stage. In other words the stickers are BULLSHIT If a gaff is empty, go for it as you would do anyway.

In the Arnold Estate on Wed. this week a sticker was put on the door where a legal warning already indicated that the squatters were in. This was intimidation, but the squatters ignored it. Not only that, but two derelict flats in the same estate have these stickickers up. If there is an intended tenant for these flats then this tenant must be some form of rat, as nobody could possibly live in them. If anybody gets hassle from Council people or people who say they've been allocated a place, get down to SNOW on the double. It's more likely than not a heap of lies and Council bullshit.

RESISTANCE to the introduction of PIOs through action, publicity and lobbying by a wide range of individuals and groups active in squatting, the tenants movement, advice organisations and the Labour Party has so far kept PIOs in the legal Department where detailed consideration is being given as to exactly how the procedure for their use will be conducted.

Meanwhile the Council have started sticking up 'PIO warning notices' on empty flats. IT IS VERY IMPORTANT WE KEEP AN ACCURATE TRACK OF THESE TO EXPOSE THEIR TRICKS - as suggested at a TASCs meeting a while ago...A Number of people have agreed to keep watch. IF YOU SEE ANY PIO WARNING NOTICES PLEASE RECORD THE ADDRESS AND DATE WHEN THEY APPEARED AND ANYTHING ELSE RELEVANT (eg time vacant) and get the information to SNOW Office or TASCs via me at 55 Innis House...Then I can make some enquiries...and I daresay other things....

If we keep up the pressure we can force the Council to bring back hard to let. The current chair of Housing only got their narrowly and the main opposition wants hard to let. THE SOUTHWARK GROUP OF TENANTS ORGANISATIONS wants Hard to let (and the consequent tenancies for many squatters) and are LOBBYING THE HOUSING COMMITTEE ABOUT THIS AND TWO OTHER DEMANDS ON MONDAY 17th DEC 6.30pm onwards. The shit has rightly hit the fan up here at the moment.

The Council has got three more flats up to court this week. They are 42 Wicksteed, 28 Fillington and 53 Martin. All three were in court and Possession Orders were granted in each case. The council made a fuck-up in the case of 42 Wicksteed and moves are afoot to get the case -set aside- as they say. We'll keep you posted.

93 Whitworth got a letter saying they are to be evicted on the 10th of January. But Bailiff is a lying animal at times. There should be some interesting developments there if it ever happens. They were in court as it happens on the 19th of October.

So was 81 Whitworth but they got a letter informing them that their case has been dismissed. Another 6-8 months of happy squat finally, it is of interest that a flat in the estate where the council slapped a sticker on the door threatening hassle if anyone went in is getting treated in exactly the same way as any other squatter would. Usual letter, usual visit from Cooke and another 6 months or so before any serious hassle might arise (i.e. eviction if it comes to that). So just ignore those stickers for a while yet. The GLC and Southwark Council are having an independent enquiry along the lines of how the centre should work in the future. Meanwhile the occupation is continuing but needs more people to come along and keep the centre open every day so that unemployed people can use it.

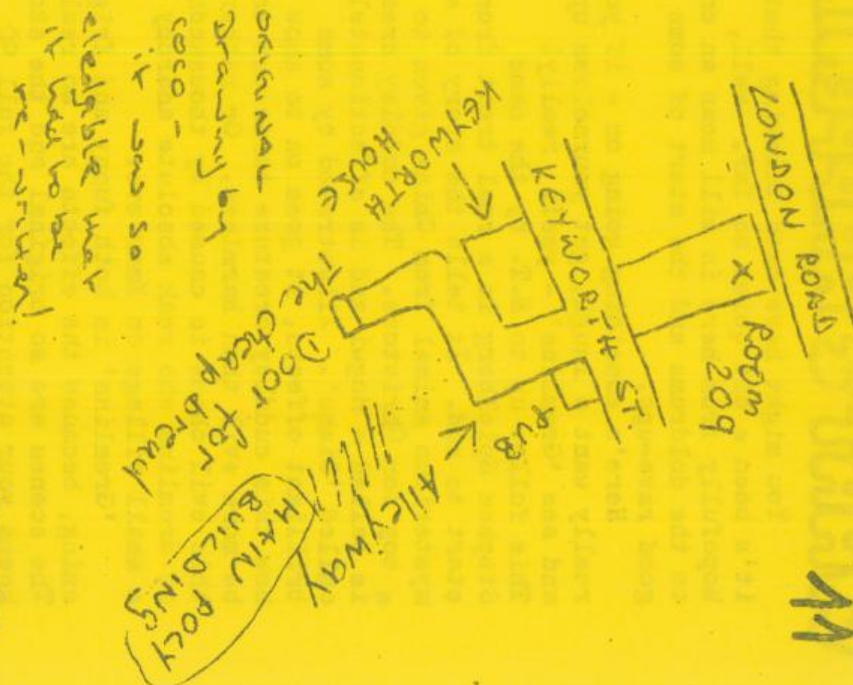

USE YOUR RECORD LIBRARY

Some good stuff in the Welworth Road library. We've spotted Gramps 'Of the Bone', Echo & the Bunnymen, Undertones (early), Billy Bragg, Gang of Four, Damned and lots more. New LPs all the time!

And get an unemployed card for leisure activities - it entitles you to free use of nearly everything in the Recreation Centre in the Elephant (swimming, squash, sauna, solarium! etc.) All you need is a passport size photo of yourself and proof of address - then you get one at any library. It's there for you - use it!

BATTERY EGGS

95% of the hens in this country are kept permanently in battery cages. They can never spread their wings, scratch in the earth, make a dust bath, walk, run or exercise, perch nor make a nest. Yet instinctively they need to do all these things.

Instead they squat on a sloping wire floor for the whole of their productive lives, with wire all around them and a wire ceiling.

In a 20" x 18" cage there will be 5 or even 6 birds ... a bird every 4 inches. Yet the bird's wingspan is 32". The protection of birds act 1954 makes it an offence to keep any bird in a cage which is too small for it to spread its wings. But poultry is exempted because of the profit motive. This has nothing to do with the real survival needs of human beings. It is a deliberate act of selfishness.

If poultry were not exempted battery cages would need to be at least three times larger than at present. If birds want to move they have to clamber over one another.

Overcrowding in an unsuitable environment causes aggressive feather picking and cannibalism. To prevent this the hen may be de-pecked, an extremely painful operation in which one third of the upper beak is burned off. Alternatively the lights may be kept very low as twilight is found to reduce activity in birds.

The British government gives two reasons for retaining the battery cage. Firstly that more research into alternative methods is needed and secondly, that it is against EEC rules to take unilateral action.

What can be done?

- * Avoid consuming those eggs or products made from them like bread, cakes, chocolates etc ... in fact all the processed drug/food of the party of 'Big Brother'.
- * If you want eggs very much then get the good ones (not battery eggs) You might have to pay a bit more.
- * The real alternative is to be a Vegan (get information)

I remember the day when I used to look forward to receiving my Wire and reading all the news on squatting, but these days the best place for the Wire is the rubbish bin.

Cannabole Culture

This is the fire and water method of hand pressing hash.

Examine the hash powder and crumble any lumps into powder. When it's fine and powdery, scoop up a palm full of the hash and sprinkle in a few drops of water and start pressing particles together between your palms.

Once the hash starts binding, flatten it out in your palms, then lightly place it on hot glowing coal, turning over a couple of times to warm both sides. From lying on the hot coals, the hash cooks slightly, causing the hash and water to expand and gel together and turning the hash from powdery green to an olive-brown tone.

When the hash has attained a consistent interior no more water or hot coals are needed. The piece is then continually flattened between the palms for at least another hour until it has reached a doughlike consistency. It is now ready for shaping.

Making has is very much an old art, and one many traditionalists stick to, though in many places, if you only take 30 minutes instead of 2/3 hours to shape the resin, so be it. It's bought and smoked so they don't care.

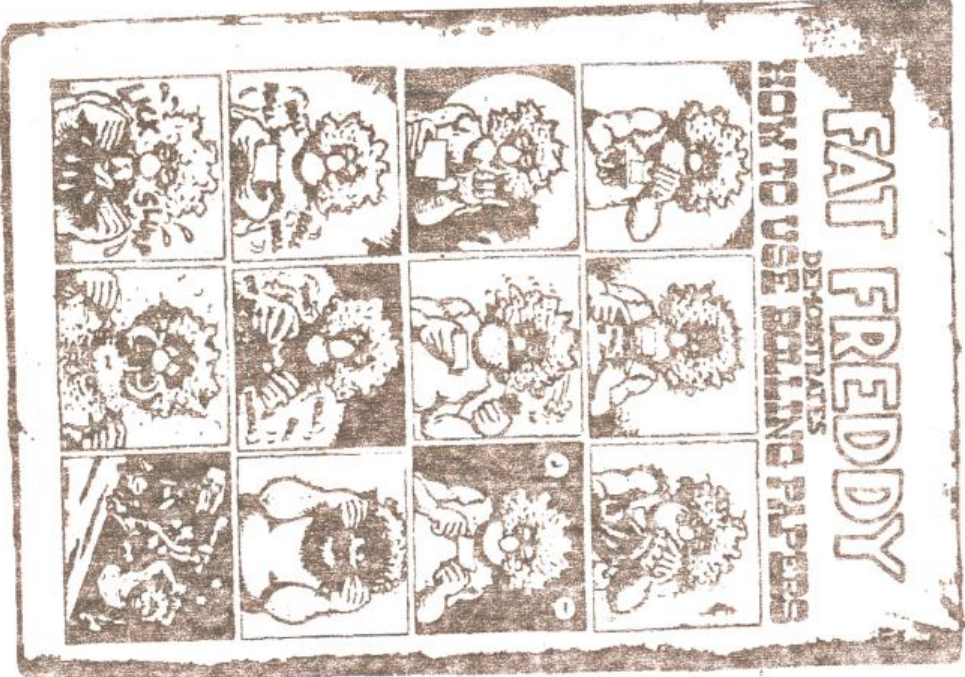
