This is to acknowledge receipt of your letter in reference to oil exportation and the Watergate situation. As you may know, Congressman Jones left this week for an Armed Servides Committee fact-finding trip to the Middle East. Prior to his departure, the Congressman reviewed your letter and asked that I respond in his behalf.

Much attention has been given this week to our oil exports, which come to some D.3% of our total production. A considerable quantity of this oil returns to us in the form of refined products. However, the question becomes a matter of priorities, and surely our own domestic priorities must come first in this situation. The major industrial consuming nations have done little to resist the Arab cutoff, and they have offered little support to us in our efforts.

Your comments regarding the President are absolutely valdd. Congressman Jones has repeatedly stated that President Nixon remains innocent until proven guilty, for just as he is not above the law, he is to be afforded its protections. Further impeachment should be based on legal, not political grounds, I am hopeful that the actions of this coming weekend will begin to reestablish credibility and trust in our President.

With increased participation and awareness, and with renewed faith and patientism, we will perservence Congressman Jones asked that I express his thanks for taking the time to write on these important matters.
