N ACT TO CONVERT THE ARSENAL AT COLUMBIA, AND THE CITADEL AND MAGAZINE IN AND NEAR CHARLESTON INTO MILITARY SCHOOLS..-[Passed 20th December, 1842.]

1. Be it enacted, by the Senate and House of Representives, now met, and sitting in General Assembly, and by a authority of the same, That the sum of eight thousand ollars be, and the same is hereby appropriated annually, for e establishment of a Military School at the Arsenal at Combia, and the sum of sixteen thousand dollars be, and the me is hereby appropriated annually, for the establishment a military School at the Citadel at Charleston, in lieu of e like sums heretofore appropriated for the Arsenal and agazine Guard, at Columbia, and the Citadel and Magazine Guard, at Columbia, and the Citadel and Magazine

e Guard, in and near Charleston.

II. That the Governor and Commander-in-Chief, is hereauthorized to organize Military Schools at the Arsenal at lumbia, and at the Citadel in Charleston, the students 1 Members of which, shall be employed in performing th services as may be assigned them: And he is also horized to appoint a Board of five persons, who together h the Adjutant and Inspector General, shall constitute a ard of Visitors, for the said Military Schools; any four of in shall constitute a quorum, and who at such times as Governor shall designate, shall meet at the said Arsenal olumbia, and at the said Citadel in Charleston, and esish such regulations as they may deem necessary and per for the organization and good government of said That the said Board of Visitors shall have power .. stablish such Bye-Laws for the management of said ols, and the protection of the public property thereat, fall not be inconsistent with the laws of this State, or te United States; shall inspect the public arms, and Property at the said Arsenal at Columbia, and at the lel and Magazine at and near Charleston, and make a te und full report of their condition, as well as of the ition and management of the said Schools, to the Govto be by him laid before the General Assembly in

each and every year. They shall have power to appoint one or more Professors, qualified to give instruction in Military Science, and in other branches of knowledge, which the said Board of Visiters may deem essential; to fix the salaries of said Professors, and to remove them for good cause; but in every case of removal, two-thirds of the

whole number of the Board of Visiters shall concur.

III. That the Students, when admitted, shall be formed into Military Corps, and shall constitute the public guard of the Arsenal at Columbia, and of the Citadel and Magazine in and near Charleston, aforesaid; and whenever the said Board of Visiters shall certify to the Governor that the said Schools are ready to go into operation, and that a sufficient number of Students or Cadets have been admitted to guard effectually the public arms, and other property at the places aforesaid, the present guard shall be diminished so far, and as soon us the Governor shall decide that the said Students or Cadets are able to perform their duties.

IV. That all property in any way belonging to the said Arsenal at Columbia, and the said Citadel and Magazine in and near Charleston, shall be surrendered to the Governor, to be disposed of according to the regulations to be established by the Board of Visiters herein before mentioned.

V. That all Acts and clauses of Acts heretofore passed, that are inconsistent with this Act, be, and the same are

## CITADEL ACADEMY AT CHARLESTON.

### ORGANIZATION AND DUTIES OF OFFICERS.

- 1. There shall be to each Academy, one Superintendent, with the title of Captain; and such Professors (who shall onstitute the Faculty) as may be employed by the Board f Visitors, with such titles and relative ranks in the Academy as may be conferred by the Board, one Surgeon and one Bursar.
- 2. The Superintendent will have the immediate government of the Academy, and be held responsible for its prect management. All Professors, Teachers, Academic officers, Cadets and others belonging to or employed about the Academy, shall be under his command, and subject to its orders. He shall be charged with the safe keeping, and reservation of the Arms, Ammunition, and other public ores and property confided to his care: and shall report the innumber and condition, and render all returns, estimates, and communications, concerning the Academy, to the Board Visiters, as often as required by them. The Superindent of the Arsenal Academy at Columbia shall be Armal Keeper and Powder Receiver.

3. The Superintendent, and all other Professors and enchers, shall perform such Academic dutien as may be on time to time prescribed by the Board of Visitors.

4. The Superintendent, will be required to give six onths, and other Professors and Teachers, three months evious notice to the Board of Visiters, before resignation.

5. The Superintendent is authorized to detail as many idets as may be required to act as Assistant Teachers, and appointment will be considered an honorable distinction.

6. It shall be the duty of the Surgeon to attend promptly in person upon the Cadets and others employed about and belonging to the Academy, whenever called upon professionally for that purpose, by any Officer of the Academy. He shall make careful examination of all applicants for admission into the Academy, and report to the Superintendent in writing, all deformities, diseases, or infirmities, with which any of them may be afflicted, and generally their physical qualifications for military service. He shall, at the requisition of the Superintendent, examine into, and report in writing, upon the health of any Cadet, who complaining of sickness, may ask on that account to be relieved from any of his duties; and shall do generally whatever is proper to be done by him, as health officer of the institution.

7. It shall be the duty of the Bursan, upon the requisition and under the supervision of the Superintendent to purchase all necessary supplies of food, clothing, fuel, oil, and candles, furniture, medicines, and books and stationary; and to issue the same according to such regulations as may be adopted; to hire cooks and waiters, and superintend the cooking and serving of all food and articles of diet for the Cadets: and shall keep his table at all time supplied in the neatest manner, with the articles required in the bill of fare prescribed by the Board of Visitors. He shall render quarterly accounts of his expenditures, accompanied by the proper vouchers, to the Superintendent, who shall examine the same, and make up from them an annual account of expenditures, which he shall lay before the Board of Visitors, together with the quarterly accounts of the Bursar, at the regular annual meeting of the Board. The Burzar shall give bond and security, in the sum of Fivo Thousand Dollars, for the faithful performance of his duty and responsibility for all money confided to his charge.

8. The Superintendent shall keep a register, in which he shall record the name of every Cadet, as soon as he shall enter the Academy, with his age, height and general description, and the District from which he may come, distinguishing the beneficiary from the pay Cadets; a transcrit of which, so far as may relate to the Cadets for the time being, shall be lad before the Board of Visitors at every

annual meeting.

Thirty-nine of whom will be admitted into the Citadel Academy at Charleston, and fifteen into the Arsenal Academy at Columbia.

11. All applications for admission into the Academy, shall be addressed to the Board of Visiters at Columbia, accompanied by written testimonials of fair moral character, and of the claims and qualifications of the applicant, on or before the annual meeting of the Board: and the candidates selected will repair to the Academy indicated by the Board, by the first of January then next ensuing, and report themselves to the Superintendent, by whom they will be examined.

Admissions will not be permitted at any other time, except under special circumstances, of which the Board of Visiters will be the sole judge.

- 12. Each candidate, before he is admitted into the Academy as a Cadet, must be able to read and write with facility.
- 13. In making selections of Cadets from beneficiary candidates, the Board of Visiters will give preference to those recommended by the Commissioners of Free Schools. But whenever the full quota to which any District may be entitled, shall not be recommended by the Commissioners of Free Schools, the Board will consider the claims of those that may be otherwise recommended.
- 14. No Cadet will be admitted who does not submit testimonials of fair moral character, or who is less than fifteen, or more than eighteen years of age, or who is below four feet nine inches in height, or deformed, or afflicted with any disease or infirmity, which would render him unfit for military service; or who may bring with him, at the time of presenting himself, any disorder of an infectious or immoral character.
- 15. Pay Cadets will be admitted upon the payment of Two Hundred Dollars per annum, which shall be transmitted to the Superintendent quarterly, in advance, viz: Fifty Dollars on the first day of January; Fifty Dollars on the first day of April; Fifty Dollars on the first day of July; and Fifty Dollars on the first day of October; which sum

of Two Hundred Dollars shall be in full of subsistence, clothing, tuition, books and stationery, medical attendance, and all charges and expenses whatever, for the year. Upon failure to pay the sum required, within one month after the ime specified, the Cadet shall be discharged.

16. No pay Cadet who may be discharged for misconuct, shall be entitled to be refunded any part of the money

aid in advance.

17. No difference shall be made in the treatment or duies required between the pay Cadets and beneficiaries; nor hall any distinction between Cadets be known in the Aca-

lemy, other than that arising from merit.

18. The term of service of the beneficiary Cadets shall be four years, and they shall subscribe in a book to be kept or that purpose, the following matriculation promise: "I bereby engage to serve as a State Cadet for the term of our years, and promise, on honor, to obey all legal orders of the constituted authorities of the Academy, and discharge he duties as Cadet with regularity and fidelity while I conmuc a member thereof."

19. If any District shall fail to make application for the dmission of its full quota of Cadets, at the annual sitting f the Board of Visiters, the Board will proceed to supply ach deficiency from applicants of other parts of the State.

20. No married person will be appointed a Cadet; and any Cadet should be married while in the Academy, he hall leave the institution.

#### CLOTHING.

21. Each Cadet shall be required to keep himself suplied at all times, with the following articles of clothing, and ilet, which shall be issued to him by the Bursar, viz:

22. The Bursar shall keep a clothing account open with each Cadet, in which he shall annually credit the Cadet with the sum of fifty dollars, and charge him with all articles of clothing issued to him, at the cost price; and at the expiration of the term of service of the Cadet, he shall be entitled to receive in money any balance to his credit on such account.

23. No Cadet who shall leave the Academy before the expiration of his regular term of service, or be discharged for misconduct, shall be entitled to any balance standing to

his credit upon his clothing account.

24. No article of clothing shall be issued to any Cadet without the permission of the Superintendent, expressed by the initials of his name, under the specification of such article, entered in a Check Book to be kept by each Cadet. The check books of the Cadets, shall be examined quarterly by the Superintendent, and if found correct, shall be vouchers to the Bursar for his issues.

25. No other Dress than that which is prescribed, shall be worn by a Cadet on any occasion, without permission from the Superintendent, nor will any Cadet be permitted

to keep in his possession any other articles of dress.

26. No Cadet shall contract any debt, or open any account whatever, except such as is prescribed, with the Bursar.

27. All articles of clothing which may be furnished to any Cadet by Parents, Guardians, or other persons interested, shall be exhibited to the Superintendent, and entered in the check book of the Cadet, with such remarks as may be necessary to show the source from whence derived.

### COURSE OF INSTRUCTION.

28. The Cadets shall be arranged by the Superintendent four distinct annual classes, corresponding with the four ars of service and study. The Cadets employed in the st year's course, shall constitute the fourth class; those on e second year's course, the third class; those on the third ar's course, the second class; and those on the fourth year's arse, the first class.

29. The following shall be the prescribed course of study

the Academy.

Fourth Class.—Geography, Arithmetic, English Gramir, History of South-Carolina; the duties of a private Idier.

Third Class.—The French Language, Algebra, Geome-Trigonometry, Book-Keeping, History of U. States; School of the Company, and duties of Corporals.

Second Class.—French Language continued, Modern story, Mensuration, Descriptive Geometry and its Applions, Rhetoric, Moral Philosophy, Architectural Drawing, t of the course of Artillery; the School of the Battalion,

duties of Sergeants.

First Class.—Topographical Drawing, Natural Philosoremainder of the course of Artillery, Chemistry, Geolo-Mineralogy, Botany, Engineering, Civil and Military, and ence of War, Constitutional Law of the United States, y of Nations, Evolutions of the Line, and Duties of numissioned Officers.

O. The time to be employed in each branch of Instrucdaily allowance of time for the class studies, and hours ecitation, shall be prescribed by the Superintendent; and ogramme of such arrangement shall be submitted by him he Board of Visiters annually, they reserving the right to

e such alteration as they may deem proper.

1. An annual examination of all the classes, preparatory teir advancement, will be held at the Citadel Academy he third Monday in November, and at the Arsenal Acay on Tuesday after the fourth Monday in November in year, at which time the Cadets shall be examined by Superintendent and Professors of the Academy, in presof the Board of Visiters, and such literary and sciengentlemen as may be invited by the Board to attend.

- 32. The classes shall be considered as taking their commencement on the 1st of January annually, when the result of the Examination held in the preceding November shall be announced.
- 33. Each instructor shall keep daily notes of the progress and relative merit of each pupil in the classes under his immediate charge, and at the end of each week he shall make report thereon to the Superintendent, according to such form as he may prescribe.
- 34. Any Cadet found deficient at the annual examination, in the studies of his class, shall not be advanced to the next higher class; and if in the opinion of the Superintendent, his deficiency is to be attributed to the want of capacity, or habitual want of application, or his conduct be grossly or generally immoral or improper, his case shall be reported to the Board of Visiters, at their annual session, to the end that he may be discharged.
- 35. Each Pay Cadet, immediately after reporting himself to the Superintendent, shall be examined and placed in such class as in the judgment of the Superintendent his proficiency and degree of advancement may warrant; but no Pay Cadet shall be placed in any higher class than the second.
- 36. A semi-annual examination shall be held, in the presence of such members of the Board of Visiters as may attend, commencing at the Citadel Academy on the fourth Monday in May, and at the Arsenal Academy on the first Monday in June, in each year; and immediately after such semi-annual examination, the Superintendent shall report to the Board of Visiters, the names of all such Cadets as shall have shown utter incapacity, or whose conduct has been grossly or generally improper or immoral.

### DISCIPLINE.

37. The Cadets of the Academy shall constitute a Military Corps, and shall be subject to military discipline, under the command of the Superintendent, or, in his absence, the next Professor in command.

33. The punishments to which a Cadet shall be liable, are comprised in the three following classes, viz:

1st. Privation of Recreation, &c., extra terms of duty,

reprimands.

2d. Arrest, or confinement in his Room or Tent, suspension until the Board of Visiters can act upon his case.

3d. Dismission.

The punishment of the first and second classes, may be inflicted by the Superintendent, or with his approbation; that of the third class, only by the Board of Visiters, upon the report of the Superintendent, and after examination or trial.

39. The Cadets are not only required to abstain from all vicious, immoral, or irregular conduct, but they are enjoined on every occasion to conduct themselves with the propriety and decorum of gentlemen. And any Cadet who shall be guilty of conduct unbecoming an officer and a gentleman, shall be dismissed, or otherwise less severely punished.

40. No Cadet shall be allowed to keep a waiter, horse,

or dog.

41. Any Cadet who shall drink, or have in his possession any wine, porter, or any other spirituous or intoxicating liquor, or shall go to any inn, public house, or place where any of those liquors are sold, without the permission of the Superintendent, or shall play at cards or any other game of chance, or have any cards or materials used in any game of chance in his possession, or use tobacco, or have it in his possession, or insult a sentinel by words or gesture, or answer for another at roll call, or engage another to answer for lain, or behave indecently or irreverently while attending divine service, or profane the Sabbath, or use any profang oath or execration, or insult, traduce or defame or strike, or in any manner offer violence to another Cadet, or shall enter into any combination or agreement to hold no friendly or social intercouse with another Cadet, or shall be guilty of any disrespect or disobedience towards the Superintendent, Protessors, or constituted authorities of the Academy, shall be dismissed, or otherwise punished, according to the nature and degree of his culpability.

42. Any Cadet who shall wantonly damage any building quarters, or other appurtunances, or lose, damage or deser-

troy, sell or otherwise dispose of the arms, acconfroments, books, instruments, or other public property, shall, besides paying for the same, be otherwise punished, according to the nature of the offence.

43. Attendance upon divine service on the Sabbath shall be imperative; and the Superintendent is required to prescribe such regulations upon the subject, as shall enforce strict obedience from every Cadet.

44. All immoralities, disorders, misbehavior or neglect, of which any Cadet may be guilty, to the prejudice of good order and discipline, though not herein expressly mentioned, are to be punished according to the nature and degree of the offence.

45. All combinations, under any pretext whatever, are strictly prohibited. Any Cadet, who in concert with others shall adopt any measure, under pretence of procuring a redress of grievances, or enter into any agreement, with a view to violate or evade any regulation of the Academy, or shall endeavor to persuade others to enter into such concert or agreement, shall be dismissed.

46. The Superintendent shall prescribe such limits around the Academy, as he may deem proper, beyond which no Cadet shall go without his permission.

47. If any Cadet shall consider himself wronged by another, or by a Professor or Officer, he is to complain thereof to the Superintendent, who is hereby required to examine into such complaint, and to take the proper measures for redressing the wrong complained of. Should the party complaining be refused redress, he may appeal to the Board of Visiters.

48. All communications to the Board of Visiters from any person belonging to the Academy, shall be made through the Superintendent, whose duty it shall be to forward them to the Board, with such remarks as he may think proper.

49. The Superintendant shall have full power to prescribe such rules and regulations of interior police and discipline as he may deem proper, to insure regularity, order, cleanliness, propriety of conduct, and strict attention to, and due performance of duty by every Cadet; to regulate the times

of parades, inspections, mounting and relieving guards, the duties of guards and sentinels, and generally every other thing necessary for the good government and well being of the Academy, not herein specifically mentioned—subject, however, to the revision of the Board of Visiters.

50. At every examination, the Superintendent shall lay before the Board of Visit ers, such rolls as shall be necessary to exhibit the relative merit of each Cadet, in his studies and

conduct.

51. The annual meeting of the Board of Visiters will be held in Columbia, on Saturday after the fourth Monday in

November in each year.

52. There shall be a suspension of the Academic studies for the months of August and September in each year, and the instruction of those months, shall be exclusively Military. During these months, the Superintendent may, at his discretion, on the application of parents or guardians, grant furloughs to such of the Cadets as may have deserved such indulgence, for a length of time not exceeding fifteen days: Provided, that such a number of Cadets shall at all times be retained at the Citadel Academy at Charleston, and at the Arsenal Academy at Columbia, as will be fully sufficient to discharge the duties of public guard for the Arsenals efficiently; and no leave of absence shall be given at any other time, except in cases of strong necessity.

53. All monies received by the Superintendent at Charleston, on account of pay-Cadets, or on any other account whatever, shall be by him deposited in the Bank of the State, and all monies received by the Superintendent at Columbia, shall be by him deposited in the Branch of the Bank of the State of Columbia; subject, in both cases, to the order of the

Board of Visiters.

### UNIFORM.—(Officers)

Coat: Dark blue, double breasted, 2 rows of buttons, ten in each row, at equal distances—the distances between the rows 4 inches at top, 2 inches at bottom, measuring from the centres or eyes of the buttons. Stand up collar of black

velvet, gold, embroidered wreath on each side near the front. of laurel and palm, crossing each other at the bottom, encircling a star of gold embroidery. Cuffs of black velvet, without indentation, 3 inches deep; slashed flap on the sleeve. of black velvet, embroidered with gold-for a Captain 41 inches long, with 3 buttons; for a subaltern, 3 inches long. with two buttons—the width of the flap in each case to be of inches at the point, and 21 inches at the narrowest point of the curve. Against each button, united gold embroidered sprigs of palm and laurel; the opening of sleeve to be closed with hooks and eyes. Skirt to extend within 33 inches of the bend of the knee; bottom of the skirt not less than 3, nor more than 5 inches broad. Turnbacks of the same cloth as the coat; at the bottom of the skirt, a gold embroidered wreath of palm and laurel, encircling a cross cannon and bombshell on a diamond shaped piece of black velvet, whose diagonals are 2 3-5 inches, and 1 4-5 inches with embroidered edging. 2 large buttons one at each hip, one at the end of each skirt, and one intermediate, between the hip and skirt buttons.

Epaulettes: Gold according to rank in army.

Buttons: Gilt convex palmetto & of an inch in diameter. Cap: Black beaver 7½ inches deep, with lackered sunktip, &c., as in the Artillery of the Army, substituting the palmetto for the eagle, and omitting the cross cannon and number.

Plume: Black, of swan or cock feathers, falling from

an upright stem 8 inches long, with gilt socket.

Trowsers: From 1st October to 30th April, sky blue cloth, to come well down over the boots, and made perfectly plain, except a black velvet stripe down the outer seam, 1½ inches wide, and welted at the edges; from the 1st May to the 31st September, of white linen or cotton, without the stripe.

Boots.

Sword: As the Artillery sword of the U.S. Army, with metal scabbard, covered with black leather, gilt mounting, with waist belt of black patent leather 2 inches wide, with sliding frog, to be worn over the coat, and clasped in front with a round clasp. For dress, black velvet, with sprigs of laurel and palm, may be used.

Sword Knot: Crimson and gold, with bullion tassel.

Sash: Crimson silk net, with silk bullion ends, to go twice around the waist, and to be tied on the left hip, the pendent part to be uniformly worn one foot in length from the tie.

Stock: Blue silk. Gloves: White.

Frock Coat: Dark blue cloth, single breasted, with 10 large palmetto buttons down the front, at equal distances, and 2 small palmetto buttons at the fastening of the cuff; plain stand up collar; 2 large buttons at each pocket in the skirt, one of which at the hip, and the other at the bottom of the folds of the pockets, making 4 buttons behind. Lining of the coat black. Shoulder straps of black velvet, one inch in breadth, bordered with an embroidery of gold; of an inch wide; for a Captain, 3 gold embroidered palmetto trees of of an inch in length, two at the ends and one in the centre, the centre tree pointing towards the head, and the exterior trees pointing inward. The 1st Lieutenant same as Captain, except the omission of centre tree. The 2nd Lieutenant same as 1st Lieutenant, omitting the trees.

Forage Cap: Of black velvet, with black patent leather visor, encircled with a band of leather, covered with black velvet, 1½ inches wide, with gold embroidered edges ¼ of an inch wide, with cross cannon and shell in front, encircled

with a double wreath of palm and laurel.

UNIFORM.—(Cadets.)

Coatee: Grey cloth, single breasted, three rows of 8 gilt convex palmetto buttons 3 of an inch in diameter, at equal distances, and button holes of black silk cord in a herring bone form, with a festoon turned at the back-end; a standing collar, trimmed with black silk lace, to fit the neck, and hook in front; the cuffs 4 inches wide; the bottom of the vest and hip buttons to range; on the collar one blind button hole of cord, formed like that of the breast, 4 inches long, with a button on each side; cord holes in the like form to proceed from three buttons placed lengthways on the skirts, with three buttons down the plaits; the cuffs to be indented, with three small gilt buttons and cord holes likewise on each sleeve, corresponding with the indentation of the cuff, in the centre of which is to be inserted the lower button.

Vest: Of grey sattinet for winter, single breasted, small flat gilt palmetto buttons, trimmed with black silk lace, White for summer.

Trowsers: Of grey cassinett for winter, with black velvet stripe down the outer seam, 1 inch wide. Cotton drilling for summer, without the stripes, in form same as for winter.

Fatigue Dress: (for Winter)—Grey Jacket of cassinett, with standing collar, plain, single breasted, with one row of 9 palmetto buttons. Pantaloons of the same material, plain. (For Summer)—Jacket of unbleached Russia drilling, made as the winter Jacket, except the collar, which will be stand and fall, with 1 gilt button ½ inch in diameter on each side of the collar. Pantaloons of the same material, to be cut full, without trimmings.

Shoes: Monroe.

Stock: Black Bombazine. Gloves: White Cotton.

Forage Cap: Blue cloth, with black patent leather visor. Dress Cap: Body of black felt, 7½ inches high, a black sunk leather crown, extending down and over the body ¾ of an inch; a black leather band on lower edge, 1½ inches wide; a chin strap of black patent leather § of an inch wide. Ornament: a brass tulip, shell and flame, with a brass palmetto tree in front; a black pompon.

Cherrons, distinctive of rank in the corps of Cadets, to be

worn.
