To convert the Arsenal at Columbia, and the Citadel and Magazine in and near Charleston, into Military Schools.

[PASSED 20TH DECEMBER, 1842.]

1. Be it enacted, by the Senate and House of Representatives, Appropriation now met and sitting in General Assembly, and by the authority of for Military the same, That the sum of eight thousand dollars be, and the same is hereby appropriated annually, for the establishment of a Military School at the Arsenal at Columbia, and the sum of sixteen thousand dollars be, and the same is hereby appropriated annually, for the establishment of a Military School at the Citadel at Charleston, in lieu of the like sums heretofore appropriated for the Arsenal and Magazine Guard at Columbia, and the Citadel and Magazine Guard, in and near Charleston.

Organization and Duties of Officers.

1. A school is established at the Citadel in Charleston, to be Citadel Acadeknown as "The Citadel Academy;" and a school is also established emy and Arsenal the Arsenal in Columbia, to be known as "The Arsenal Acadeconst tute Citamy:" the Professors and pupils of which schools, shall constitute adel and Mag. Guard, and the Citadel and Magazine Guard of Charleston, and Arsenal and Magazine Guard of Columbia, respectively.

Mag. Guard.

2. There shall be to each Academy one Superintendent and such Professors as may be employed by the Board of Visitors, who shall constitute the faculty of the Academy and officers of the Guard re-Faculty. spectively, with such titles and relative ranks, in the Academy, as may be conferred by the Board: one Surgeon and one Bursar.

3. The pupils shall be known as Cadets, and shall constitute the Pupils known non-commissioned officers and privates of the respective Guards.

as Cadets.

4. The Superintendent will have the immediate government of General duthe Academy, and be held responsible for its correct management ties of Princi-All Professors, Teachers, Academic Officers, Cadets, and others be-pal Professor. longing to or employed about the Academy, shall be under his command, and subject to his orders. He shall be charged with the safe keeping and preservation of the Arms, Ammunition, and other public stores and property confided to his care: and shall report

their number and condition, and render all returns, estimates, and communications, concerning the Academy, to the Board of Visitors, as often as required by them. The Superintendent of the Arsenal Academy at Columbia, shall be Arsenal keeper and powder receiver.

5. The Superintendent, and all other Professors and Teachers, shall perform such Academic duties as may be from time to time

prescribed by the Board of Visitors.

Notice of resignation.

6. The Superintendent will be required to give six months, and other Professors and Teachers three months previous notice to the Board of Visitors, before resignation.

Respect to Professors.

7. The Professors and Teachers shall receive every mark of respect to which their rank and office may entitle them, respectively.

Cadets acters.

8. The Superintendent is authorized to detail as many Cadets as ing as Teach. may be required to act as Assistant Teachers, and the appointment will be considered an honorable distinction.

Duty of Surgeon.

9. It shall be the duty of the Surgeon to attend promptly in person upon the Cadets and others employed about and belonging to the Academy, whenever called upon professionally for that purpose, by any officer of the Academy. He shall make careful examination of all applicants for admission into the Academy, and report to the Superintendent, in writing, all deformities, diseases, or infirmities, with which any of them may be afflicted, and generally their physical qualifications for military service He shall, at the requisition of the Superintendent; examine into, and report in writing upon, the health of any Cadet, who, complaining of sickness, may ask on that account to be relieved from any of his duties; and shall do generally whatever is proper to be done by him, as health officer of the institution.

Duty of Bursar.

10. It shall be the duty of the Bursar, upon the requisition and under the supervision of the Superintendent, to purchase all necessary supplies of food, clothing, fuel, oil and candles, furniture, medicines, and books and stationery, and to issue the same according to such regulations as may be adopted; to hire cooks and waiters, and superintend the cooking and serving of all food and articles of diet for the Cadets; and shall keep his table at all times supplied in the neatest manner, with the articles required in the bill of fare prescribed by the Board of Visitors. He shall act as Quarter-Master. and, under the direction of the Superintendent, shall have charge of the public lands, and buildings thereon: of the control of the workmen employed in the erection or repairs of the public buildings, or in the improvement of the grounds, of the materials for the erection of buildings, and for repairs and improvements, and of

all other public property for which no other person is especially responsible. He shall render quarterly accounts of his expenditures, accompanied by the proper vouchers, to the Superintendent, who shall examine the same, and make up from them an annual account of expenditures, which he shall lay before the Board of Visitors, together with the quarterly accounts of the Bursar, at the regular annual meeting of the Board. The Bursar shall give bond and security, in the sum of five thousand dollars, for the faithful performance of his duty and responsibility for all money confided to his charge.

11. The Superintendent shall keep a Register, in which he shall record the name of every Cadet as soon as he shall enter the Academy, with his age, height and general description, and the district from which he may come, distinguishing the beneficiary from the pay Cadets; a transcript of which, so far as may relate to the Cadets for the time being, shall be laid before the Board of Visitors at every annual meeting.

12. The annual meeting of the Board of Visitors will be held in Annual Meet-Columbia, on Friday after the fourth Monday in November in ing of Board. each year.

Arsenal Acad-Academy. Cadets.

15. The Arsenal Academy is to be considered auxiliary to the emy auxiliary Citadel Academy: and all Cadets of that Academy who, from their standing and conduct, deserve to be continued in the Institution, Transfer of will, at the expiration of the first year of their term, be transferred to the Citadel Academy.

Time and nation.

16. All applications for admission into the Academy shall be manner of applying, and addressed to the Board of Visitors at Columbia, accompanied by time of exami-written testimonials of fair moral character, and of the claims and qualifications of the applicant, on or before the annual meeting of the Board, and the candidates selected will repair to the Academy indicated by the Board by the first of January then next ensuing. and report themselves to the Superintendent, by whom they will be examined. Admissions will not be permitted at any other time, except under special circumstances, of which the Board of Visitors will be the sole judge.

20. In making selections of Cadets from beneficiary candidates, Beneficiary the Board of Visitors will give preference to those recommended by Cadets recomthe Commissioners of Free Schools. But whenever the full quota Commissionto which any District may be entitled, shall not be recommended by the Commissioners of Free Schools, the Board will consider the claims of those that may be otherwise recommended.

21. No Cadet will be admitted who does not submit testimonials of fair moral character, or who is less than fifteen or more than nine- Moral & phyteen years of age, or who is below five feet in height, or deformed, sical qualificaor afflicted with any disease or infirmity which would render him unfit for military service; or who may bring with him, at the time of presenting himself, any disorder of an infectious or immoral character.

22. No difference shall be made in the treatment or duties re-No distinction quired between the pay Cadets and beneficiaries; nor shall any dis-known among tinction between Cadets be known in the Academy, other than that arising from merit.

April; fifty dollars on the first day of January; fifty dollars on the first day of April; fifty dollars on the first day of July; and fifty dollars on the first day of October: which sum of two hundred dollars shall be in full of subsistence, clothing, tuition, books and stationery, medical attendance, and all charges and expenses whatever, for the year. Upon failure to pay the sum required, within one month after the time specified, the Cadet shall be discharged.

Matriculation promise.

26. The term of service of the beneficiary Cadets shall be four years, and they shall subscribe, in a book to be kept for that purpose, the following matriculation promise:—"I hereby engage to serve as a State Cadet for the term of four years, and promise, on honor, to obey all legal orders of the constituted authorities of the Academy, and discharge the duties as Cadet with regularity and fidelity, while I continue a member thereof."

Clothing.

Articles required.

27. No Cadet shall be furnished with any article of clothing, furniture, shoes, or equipments of any kind, by the Bursar, without an order in his account book, expressed by the initials of the Superintendent's name, or the senior officer commanding.

28. The memoranda presented by the Cadets to the Superintendent, with their account books, shall be neatly and correctly written,

otherwise such wants will not receive attention.

29. Each Cadet shall be required to keep himself supplied at all times, with the following articles of clothing and toilet, which shall be issued to him by the Bursar, viz:

Cuffs of black velvet, without indentation, 3 inches deep; slashed flap on the sleeve, of black velvet embroidered with gold-for a Captain 4½ inches long, with 3 buttons; for a subaltern, 3 inches long, with 2 buttons—the width of the flap, in each case, to be 23 inches at the point, and 21/8 inches at the narrowest point of the curve. Epaulettes—Gold, according to rank in army.

Buttons—Gilt convex Palmetto 7 of an inch in diameter.

Cap—Black beaver $7\frac{1}{2}$ inches deep, with lackered sunktip, &c., as in the Artillery of the Army, substituting the Palmetto for the Eagle, and omitting the cross cannon and number.

Plume—Black, of swan or cock feathers, falling from an upright stem, 8 inches long, with gilt socket.

Sword-As the Artillery Sword of the U.S. Army, with rietal scabhard, covered with black leather, gilt mounting, with waist belt of black patent leather, two inches wide, with sliding frog, to be worn over the coat, and clasped in front with a round clasp. dress, black velvet, with sprigs of laurel and palm, may be used.

Sword Knot-Crimson and gold, with bullion tassel.

Sash-Crimson silk net, with silk bullion ends, to go twice around the waist, and to be tied on the left hip, the pendent part to be uniformly worn one foot in length from the tie.

Stock—Blue Silk.

Gloves—White.

Frock Coat.—Dark blue cloth, single breasted, with 10 large Pal- Frock Coat. metto buttons down the front, at equal distances, and two small Palmetto buttons at the fastening of the cuff; plain stand up collar; two large buttons at each pocket in the skirt, one of which at the hip, and the other at the bottom of the folds of the pockets, making four buttons behind. Lining of the Coat, black. Shoulder straps of black velvet, one inch in breadth, bordered with an embroidery of gold & of an inch wide; for a Captain, three gold embroidered Palmetto trees of 3/4 of an inch in length, two at the ends, and one in the centre—the centre tree pointing towards the head, and the exterior trees pointing inward. The first Lieutenant same as Captain, except the omission of centre tree. The second Lieutenant same as first, omitting the trees.

- Debts forbidden. 33. No Cadet shall contract any debt, or open any account whatever, except such as is prescribed, with the Bursar.
- Bursar to keep 34. The Bursar shall keep a clothing account open with each clothing Account.

 Cadet, in which he shall annually credit the Cadet with the sum of sixty dollars, and charge him with all articles of clothing issued to him at the cost price; and at the expiration of the term of service of the Cadet, he shall be entitled to receive in money any balance to his credit on such account.
- 35. No article of clothing shall be issued to any Cadet without the permission of the Superintendent, expressed by the initials of Acct. Books. his name, under the specification of such article, entered in a Check Book to be kept by each Cadet. The check books of the Cadets shall be examined quarterly by the Superintendent, and if found correct, shall be vouchers to the Bursar for his issues.
- 36. No Cadet who shall leave the Academy before the expiration Not to receive of his regular term of service, or be discharged for misconduct, shall be entitled to any balance standing to his credit upon his clothing account.
- To inspect his 37. Any Cadet will be permitted to inspect his accounts on appliaccounts. cation for that purpose during office hours.
 - Money to be deposited in Bank.

 38. All moneys received by the Superintendent at Charleston on account of pay Cadets, or on any other account whatever, shall be by him deposited in the Bank of the State; and all moneys received by the Superintendent at Columbia, shall be by him deposited in the Branch of the Bank of the State at Columbia; subject in both cases to the order of the Board of Visitors.
- Not to receive 39. No Cadet shall apply or receive money or any other supplies supplies with-from his parents, or from any person whosoever, without the permission of the Board of Visitors, on recommendation of the Superintendent. Any infraction or violation of this rule will be considered a disobedience of orders, and punished accordingly.
- Discharged 40. No pay Cadet, who may be discharged for misconduct, shall Cadets not re- be entitled to be refunded any part of the money paid in advance. funded.

Course of Instruction.

41. The Cadets shall be arranged by the Superintendent in four distinct annual classes, corresponding with the four years of service and study. The Cadets employed in the first year's course shall

constitute the fourth class; those on the second year's course, the third class; those on the third year's course, the second class; and those on the fourth year's course, the first class.

42. The following shall be the prescribed course of study in the Studies. Academy:

Fourth Class.—Arithmetic, Algebra, English Grammar, History, French; the duties of a private soldier.

Third Class.—Geometry and Trigonometry, Descriptive Geometry, Surveying, Analytical Geometry, Universal History, French, Topography, Tactics.

Second Class.—Calculus, Natural and Experimental Philosophy, Rhetoric, Chemistry, Mineralogy, Topography and Tactics.

First Class.—Civil and Military Engineering, Moral Philosophy, National and Constitutional Law, Chemistry, Mineralogy, Geology, Architectural Drawing, Artillery and Infantry Tactics.

43. The time to be employed in each branch of Instruction, daily allowance of time for the class studies, and hours of recitation, shall be prescribed by the Superintendent; and a programme of such arrangement shall be submitted by him to the Board of Visitors annually, they reserving the right to make such alteration as they may deem proper.

Time employed prescribed.

44. The classes shall be considered as taking their commence-commencement on the 1st of January annually, when the result of the Examin-ment of course ation held in the preceding November shall be announced.

45. Each instructor shall keep daily notes of the progress and Class Reports. relative merit of each pupil in the classes under his immediate charge, and at the end of each week he shall make report thereon to the Superintendent, according to such form as he may prescribe.

46. Each Professor and Instructor at the head of a separate de-Manner of Inpartment shall be the judge of the proper mode of conveying instruction in his own department, and shall be held responsible for the correctness of that mode.

General Examinations.

47. An annual examination of all the classes, preparatory to their advancement, will be held at the Citadel Academy on the third Monday in November, and at the Arsenal Academy on Tuesday after the fourth Monday in November in each year, at which time the Cadets shall be examined by the Superintendent and Professors of the Academy, in presence of the Board of Visitors and such liter-

48. Any Cadet found deficient at the annual Examination, in the studies of his class, shall not be advanced to the next higher class; and if, in the opinion of the Superintendent, his deficiency is to be attributed to the want of capacity or habitual want of applica-

Dismissed, if wanting capacity.

tion, or his conduct be grossly or generally immoral or improper, his case shall be reported to the Board of Visitors at their annual session, to the end that he may be discharged.

Semi-annual.

49. A semi-annual Examination shall be held, in the presence of such members of the Board of Visitors as may attend, commencing at the Citadel Academy on the third Monday in April, and at the Arsenal Academy on the last Monday in May in each year; and no pupil hereafter admitted by the Board of Visitors in either of the Military Academies shall be considered a Cadet, or furnished with any article of Uniform clothing, (except such articles of undress as may be needed,) until after the semi-annual examination next succeeding such admission, at which time the Superintendent and Professors of each Academy, respectively, shall have power to dismiss from the Institution all such probationary pupils as shall have shown utter incapacity, or whose conduct shall have been grossly immoral, or generally improper, or insubordinate. And if any pupil should be admitted at any other time than at the regular annual meeting of the Board of Visitors, he shall be subject to a like probation of four months, before he shall be admitted to the grade of Cadet.

Distinguished Cadets.

50. The Board of Visitors, in conjunction with the Superintendent, will annually, immediately after the general examination, select for publication the names of such Cadets as have most distinguished themselves in the examination, not exceeding two in each class, and will specify the studies in which they particularly excel; and the standing both for conduct and scholarship of each Cadet shall also be at the same time communicated by them to their parents or guardians.

Diploma.

51. After the annual examination, a diploma, signed by the Board of Visitors and the Professors of the Academy, shall be granted to each Cadet of the first class desiring it, who shall be found to have deserved it, as well by his moral deportment as his proficiency in his studies.

Merit Rolls.

52: At every examination the Superintendent shall lay before Rolls.

53. At every examination the Faculty shall form rolls, in which the names of the Cadets shall be arranged in their respective classes in the order of their merit or proficiency in each branch of instruction upon which they are examined.

54. At every November examination, the Faculty shall, in addition to the aforesaid rolls, form others, in which the merit of each Cadet, in each branch of instruction upon which he is examined, shall be denoted by a number proportional to his proficiency, and to the importance of the subject; and in which the names of the Cadets shall be arranged in their classes in the order of aggregate merits, as determined for each, by the addition of the numbers expressing his merit in each particular branch; but in forming the final merit roll of the first class, the result of the actual examination shall be incorporated with those of former examinations.

55. At every semi-annual examination, a roll similar to the one described in the last paragraph, omitting conduct, shall be formed for the fourth class.

56. The relative weight to be given to the different subjects in forming the general merit roll of each class, is represented by the following numbers—viz:

Conduct Rolls.

57. Rolls exhibiting the relative merit of the Cadets in conduct, shall be formed by the Faculty from the register of delinquencies at the November examination for the whole of the academic year, in the following manner:

1st. All the recorded delinquencies of the Cadets shall be arranged in seven classes, each of which shall comprise those of nearly the same degree of criminality.

2d. The degree of criminality of an offence of each of the classes so formed, shall be expressed as follows:

For each year (after the first year) that a Cadet may be a member of the Academy, his offences shall be made to count more, by adding to the number expressing the degree of criminality of each offence, one-sixth for his second, one-third for his third, and one-half for his fourth year.

3d. The total demerit of each Cadet will be expressed by the sum of the products of the number of offences of each class, by the number which expresses the criminality of one offence of that class.

Deficiency in conduct

58. When any Cadet shall have a number expressing his demerit on the general conduct roll, greater than 200 for any one year, such Cadet shall be declared deficient in conduct, and be reported by the Faculty to the Board of Visitors for discharge.

59. Copies of all the merit rolls will be forwarded to the Board of Visitors, and the rolls shall also be copied into the register of merit kept at the Academy.

Copies.

60. A copy of the merit rolls shall be sent to the parents or guardian of each Cadet.

61. Besides the merit rolls, the Superintendent shall cause to be Official Regismade out and published annually, a "Register" containing the name of each Cadet, arranged according to the order of general merit in each class; exhibiting the District from which appointed, date of admission, age when admitted, and order of merit in their respective studies.

Furloughs.

62. There shall be a suspension of the Academic studies for the How granted. month immediate succeeding the semi-annual examination, and in December in each year; and the instruction of those months shall be exclusively Military. During these months, the Superintendent may, at his discretion, on the application of parents or guardians, grant furloughs to such of the Cadets as may have deserved such indulgence, for a length of time not exceeding fifteen days. ded, that such a number of Cadets shall at all times be retained at the Citadel Academy at Charleston, and at the Arsenal Academy at Columbia, as will be fully sufficient to discharge the duties of public guard for the Arsenals efficiently; and no leave of absence shall be given at any other time, except in cases of strong necessity.

63. Any Cadet who shall overstay his furlough or leave of absence, will subject himself to dismissal; unless he shall produce, on his return, certificates satisfactory to the Superintendent of his having been prevented from returning by sickness, or some other unavoidable cause.

64. No Professor or officer shall absent himself from the Acade-To Professors. my, for a longer time than one day, without the permission of the Board of Visitors; nor shall any Professor or officer be absent from his duty any time, without the assent of the Superintendent.

Library.

65. A member of the Academy shall act as Librarian, who shall be responsible for the property in his charge; he shall attend at the Library at such hours, and under such by-laws, as shall be prescribed by the Superintendent.

- 67. No person except members of the Academy, shall be allowed to draw books from the Library.
- 68. For every book drawn from the Library, a receipt shall be given.
- 69. No officer shall be allowed to have in his possession, at one time, more than four volumes, and no Cadet more than one, with accompanying plates, except by the special permission of the Superintendent.
 - 70. No person shall lend any book drawn from the Library.
- 71. No person shall keep any book more than one month, without special permission.
- 72. All persons drawing books from the Library shall be responsible for any damages done to them, the amount of which shall be estimated by the Librarian, and reported weekly to the Superintendent; no person shall be allowed to draw books from the Library while a fine remains unpaid, or while books, previously drawn, are retained beyond the prescribed time.
- 73. All books drawn from the Library shall be returned on the 2d Saturday in April, annually; from which time until the 1st of May following, no book shall be taken out without the written permission of the Superintendent.

Discipline.

Military Discipline. 74. The Cadets of the Academy shall constitute a Military corps, and shall be subject to Military discipline, under the command of the Superintendent, or, in his absence, the next Professor in command.

Punishments.

- 75. The punishments to which a Cadet shall be liable, are comprised in the seven following classes, viz:
 - 1st. Privation of recreation, extra tours of duty.
 - 2d. Private reprimand.
 - 3d. Public reprimand, or reprimand in orders.
 - 4th. Arrest and confinement to prescribed limits.
- 5th. Imprisonment in a light room—imprisonment in a dark room.
 - 6th. Suspension until the Board of Visitors can act upon the case.
 - 7th. Dismission or expulsion.

76. The Cadets are not only required to abstain from all vicious, Gentlemanly immoral, or irregular conduct, but they are enjoined to conduct themselves on every occasion with the propriety and decorum of gentlemen; and any Cadet who shall be guilty of conduct unbecoming an officer and a gentleman, shall be dismissed, or otherwise less se. verely punished.

77. No Cadet shall be allowed to keep a waiter, horse, or dog.

78. Any Cadet who shall drink, or have in his possession any wine, porter, or any other spirituous or intoxicating liquor; or shall go to any inn, public house, or place where any of those liquors are sold, without the permission of the Superintendent; or shall play at cards or any other game of chance, or have any cards or materials used in any game of chance in his possession; or use tobacco, or have it in his possession; or insult a sentinel by words or gesture; or answer for another at roll call, or engage another to answer for him; or behave indecently or irreverently while attending divine Answering for service; or profane the Sabbath; or use any profane oath or execration; or insult, traduce, or defame or strike, or in any manner Defaming. offer violence to another Cadet; or shall enter into any combination Combination: or agreement to hold no friendly or social intercourse with another Cadet; or shall be guilty of any disrespect or disobedience towards Disrespect to the Superintendent, Professors, or constituted authorities of the Academy-shall be dismissed, or otherwise punished, according to the nature and degree of his culpability.

79. Any Cadet who shall wantonly damage any building, quarters, or other appurtenances, or lose, damage or destroy, sell or otherwise public properdispose of the arms, accoutrements, books, instruments, or other public property, shall, besides paying for the same, be otherwise punished according to the nature of the offence.

80. Attendance upon divine service on the Sabbath, shall be imperative; and the Superintendent is required to prescribe such regulations upon the subject as shall enforce strict obedience from every Cadet.

81. All immoralities, disorders, misbehaviour or neglect, of which Misbehavior. any Cadet may be guilty, to the prejudice of good order and discipline, though not herein expressly mentioned, are to be punished according to the nature and degree of the offence.

82. All combinations, under any pretext whatever, are strictly Combinations.

Any Cadet who, in concert with others, shall adopt prohibited. any measure, under pretence of procuring a redress of grievances, or enter into any agreement, with a view to violate or evade any regulation of the Academy, or shall endeavor to persuade others to enter into such concert or agreement, shall be dismissed.

Limits.

83. The Superintendent shall prescribe such limits around the Academy, as he may deem proper, beyond which no Cadet shall go without his permission.

Redress.

84. If any Cadet shall consider himself wronged by another, or by a Professor or officer, he is to complain thereof to the Superintendent, who is hereby required to examine into such complaint, and to take the proper measures for redressing the wrong complained of. Should the party complaining be refused redress, he may appeal to the Board of Visitors.

Communications.

85. All communications to the Board of Visitors, from any person belonging to the Academy, shall be made through the Superintendent, whose duty it shall be to forward them to the Board, with such remarks as he may think proper.

86. It shall be the duty of every Professor, Teacher and Assist-Officers report ant Professor, who is knowing to any violation of the rules and regulations, or to any crime, irregularity, neglect or other improper conduct, of which a Cadet has been guilty, to report the same without delay to the Superintendent.

Superintendent may prescribe rules, &c.

87. The Superintendent shall have full power to prescribe such rules and regulations of interior police and discipline, as he may deem proper, to insure regularity, order, cleanliness, propriety of conduct, and strict attention to, and due performance of duty by every Cadet; to regulate the times of parades, inspections, mounting and relieving guards, the duties of guards and sentinels, and generally every other thing necessary for the good government and well being of the Academy, not herein specifically mentioned-subject, however, to the revision of the Board of Visitors.

Interior Police and Discipline.

88. The Cadets shall be organized into a company, to consist of one Captain, two Lieutenants, two Sergeants and four Corporals.

89. The commissioned and non-commissioned officers shall be appointed, by the Superintendent, from those Cadets who have been most active and soldier-like in the performance of their duties, and most exemplary in their general deportment. In general the commissioned officers will be taken from the first class; Sergeants from the second class; and the Corporals from the third class. In the first two years, temporary details will be made as acting officers, but in all cases the appointments will be made from those most distinguished for general good conduct and soldier-like deportment.

90. From the 1st of March to the 1st of December, there shall be an infantry or artillery drill every day, when the weather is favorable, (Saturdays and Sundays excepted,) at such regular hour of the day as the Superintendent may appoint, and for the residue of the year at his discretion.

91. Each drill shall continue one hour at least, and shall not ex-Duration. ceed one hour and a half.

92. There shall be a dress parade at retreat, when in barracks, Evening Paraccording to the form prescribed in the general Army regulations.

93. There shall be an inspection of the company under arms, Saturday Inevery Saturday morning, (when the weather permits,) at ten o'clock, according to the form of the Army.

94. No Cadet shall be excused from any duty whatever, without Excuses from permission from the Superintendent, unless excused by the Surgeon.

95. Reveille-Will be regulated by the beating of the Picquet Hours for dai-Guard. ly duties.

Retreat-At sunset.

Tattoo-At 10 P. M. from 20th March to 20th September, and 9 P. M. from 20th September to 20th March.

"Pease upon a Trencher"-Signal for Breakfast, at 8 A. M., from 20th March to 20th September, and at 7½ from 20th September to 20th March.

"Roast Beef"—The Signal for dinner, at 1 o'clock, P. M. Surgeon's Call-At 1 past 6 o'clock, A. M.

96. From Reveille till breakfast call; from 9 till 12, A. M.; from 2 till 4 P. M.; and 30 minutes after returning from Supper till Tattoo.

Roll Calls. 97. There will be five general roll calls daily, and invariably:
The 1st at Reveille, 2d at Breakfast, 3d at Dinner, 4th at Retreat,
and 5th at Tattoo; at which all Cadets not on duty, or absent by
permission, or excused by the Surgeon, are required to attend.

98. No Cadet shall retain in his possession any articles of dress, other than prescribed by the regulations, without permission.

99. The Jacket shall only be worn in quarters, on class parade,

in section room, and within the Citadel grounds when not on duty.

100. Cadets shall have their hair trimmed close behind; Mus-

Hair trimmed. 100. Cadets shall have their hair trimmed close behind; Mustaches and Whiskers shall not be worn.

Arms. 101. No Cadet shall lend or exchange his arms or accouragements.

101. No Cadet shall lend or exchange his arms or accourtements, nor use those of another Cadet, nor shall the arms be taken from quarters, except for duty, without permission.

102. No Cadet shall alter his musket by filing or scraping or varnishing the stock, or remove the lock without permission of one of the Professors or the Superintendent.

103. Cadets are prohibited from having in their possession any description of fire arms, or other weapons, not issued by the proper authority.

104. No Cadet shall remove from the room or bed assigned to him, without permission of the Superintendent.

Police of quarters. 105. Every Cadet, on rising in the morning, shall roll up his matrass, with the bed-clothes neatly folded in it, put it into the bed-sack and strap it. He shall hang up his extra clothing, put such articles in the clothes bag as it is intended to contain, clean his candlesticks, and arrange all his effects in the prescribed order.

106. Every Cadet shall attend to the good order and arrangement of his own arms, accourrements, clothing and other effects; the Orderly shall attend to the general police of the room, and shall require each occupant to discharge his proper duty.

107. Cadets must prepare their clothes for the laundress, before 7 o'clock on Sunday and Thursday mornings of each week.

109. No Cadet shall keep any unauthorized article of furniture.

110. No Cadet shall keep a light after Taps, except when on duty and authorized so to do.

111. No Cadet shall play on any musical instrument on Sunday, nor in study hours on any other day, (this applies to all persons in the Citadel,) nor shall they play at cards or other games of chance at any time, nor keep implements used in such games in their rooms.

112. Cadets shall walk the halls and galleries of the barracks, and pass up and down stairs in study hours, with as little noise as possible: running, loud talking, or scuffling in barracks is strictly prohibited.

113. Cadets will habitually ascend and descend by the staircase over the wood house. The stairs ascending under the archway are appropriated to the officers, private persons, and such as come on business.

114. Every Cadet having permission to be absent, must leave his name with the Sergeant or officer of the guard on going out and returning to quarters, who will report the same, with the time absent, on his daily reports.

115. No loitering or idling around the barracks, in the guard room, or archway, or any other place, can be allowed during study

hours.

116. No Cadet shall post up any placard or notice upon the public buildings without permission, nor shall he mark, cut, deface, or injure any of the public property whatever.

117. No Cadet or other person shall introduce a citizen into the barrack rooms, during study hours, without permission from Superintendent of barracks.

118. There shall be an Orderly detailed for each room occupied by the Cadets, who shall perform the duties for one week.

119. The Orderlies of each room shall see that the names of all their room mates are on the orderly board, with those of themselves at the *head* of the list; and that the board is hung in its appropriate place.

120. They shall be held responsible for the cleanliness of the room, and for the strict observance of all regulations and orders therein; every violation of which they shall promptly report. They shall be responsible for all public property therein, shall police and sweep

out the rooms, daily, fifteen minutes after reveille roll call, and shall attend to the fires and see that there are lights in their rooms, within ten minutes after the evening call to quarters.

121. Every night, at or before Taps, they shall see that the lights

are extinguished, and fires secure, if there be any.

122. Every other Saturday, between 6 and 10 o'clock, A. M., they shall, with the assistance of their room mates, wash the floors of the rooms, the wash-stands, mantel pieces, and shelves, &c., and put the rooms in complete order.

123. They shall answer promptly and fully every question put to them by any officer or Cadet on duty, and when the Orderly detailed for the week is absent, the Cadet longer off duty shall be respon-

sible as Orderly.

Superintendents of rooms

124. The first and second officer of Cadets, shall be Superintendents of rooms, and are charged with and responsible for their police and the preservation of good order therein.

125. They shall visit and inspect the rooms of their divisions, at least once during the day, at Taps at night, and see that all is well.

126. They shall prescribe the order in which the room and furniture shall be arranged, shall change Orderlies, and shall require the Orderlies, who have not kept their rooms in good order, to perform an extra weekly tour of duty, and shall report daily, in writing, all delinquencies which have come to their knowledge since last report, with the condition of the rooms, to the Superintendent of the Academy.

127. They shall suppress all noise and scuffling, or other improper conduct in the rooms under their charge, and forthwith report the case to the officer in charge.

128. They shall communicate to the occupants of the rooms, all orders given them relative to the police, and shall cause them to be observed.

129. They shall inspect the rooms, and see that the beds are duly arranged as prescribed, 30 minutes after Reveille; and shall visit every room after Taps, and see that all the occupants are in bed, and fires secure; reporting all delinquencies to the officer in charge.

130. The Superintendent of the Academy will inspect the quarters, at least once a week, and oftener, when there should appear

to be a necessity for so doing.

131. Each officer of the Faculty shall be detailed in turn as officer in charge for the day, his tour to commence at guard mounting.

132. He shall superintend the performance of all the duties of

139. He shall cause the Sentinels to be posted at the proper times, and shall visit them ten minutes after they are posted.

140. He shall cause all the Academic signals to be sounded at the proper times.

141. He shall superintend the formation of the classes and sections, and require the marchers to report the absentees, and to preserve good order on parade, and while marching to and from the section room.

142. He shall then immediately seek all who have been reported to him as absent, (except those properly excused,) and order them to repair forthwith to their respective recitation rooms, or wherever their duty may require their presence. He shall report immediately to the Superintendent or officer in charge, all whom he does not find, and all such as fail to obey his orders.

143. During the season in which fires are permitted in barracks, he shall frequently visit the rooms during recitation hours.

144. He shall take prompt and effectual measures for suppressing all irregularities and disturbances that may occur in or near the barracks.

145. He shall station himself in or near the guard room, between Reveille and Tattoo, constantly, except when absent on duty or at meals.

146. He shall be held responsible for all public property deposited in the guard-room.

147. He shall, fifteen minutes after Taps, visit the rooms of all Cadets, who are reported absent, and he shall repeat his visits at intervals of fifteen minutes, to the room of each absentee till his return.

148. On the back of his guard report, he shall note all violations of the regulations, which may have come to his knowledge during his tour; stating the name of each delinquent, with a clear and precise description of his offence, and the circumstances of time and place, when they are not necessarily understood; he shall also state particularly the orders given him by any authorized officer, and the time at which each absentee, at Taps, returned to his room; and he will subjoin to his report the word "Certified," with his signature.

149. At evening parade, each Orderly Sergeant shall warn the Cadets of his company, who are detailed to mount guard the ensuing day, always taking those for this duty first, who have been longest off

Guard mounting. 150. The ceremonies of mounting guard shall be performed as prescribed in the general regulations of the Army of the United States.

151. Every Cadet of the guard, shall appear at guard mounting in perfect order.

152. Cadets detailed for guard, shall not, during their tour, leave the barracks for a longer period than ten minutes, except on duty or for meals.

153. Every Sentinel shall obey the orders of the Superintendent, officer in charge, officer of the day, and of the officers and non-commissioned officers of the guard.

154. As soon as a Sentinel is posted in the barracks, he shall visit every room under his charge, see that the fires are secured in such as may be vacant, and order (if it be in study hours) every Cadet, whom he may find visiting, to go to his room.

155. Every Sentinel on post, when the call "to quarters" is sounded, shall immediately visit the rooms under his charge, and report those Cadets who shall not have obeyed the call.

156. No Sentinel shall permit a violation of the regulations to take place within the limits of his post, without taking proper mea-

sures to prevent it; nor shall he fail in any case to report to the Corporal of the guard, every such violation which comes within his observation or knowledge whilst on post, and the name of every Cadet who, during his tour, shall have been absent from his room, in study hours, longer than ten minutes.

161. No Cadet shall be released from arrest, except by authority of the Superintendent, or the commanding officer of the post; and every Cadet proved guilty of a breach of arrest, will be suspended, or otherwise less severely punished, at the discretion of the Superintendent.

162. At the Surgeon's call, the sick, not in the hospital, will be conducted to the hospital by the first Sergeant of the Company, who will present to the Surgeon the company book, with the names of the sick registered; and no Cadet shall report, or be reported to the Surgeon, or be excused by him, whose name is not registered.

187. All officers shall duly acknowledge the salutations, in the form and manner prescribed in the regulations aforesaid. Those compliments and salutations shall also be observed by all enlisted persons employed about the Citadel.

Societies.

188. No society shall be organized among the Cadets, without special license from the Superintendent; nor shall any assembly of Cadets be held, for this or any other purpose, without his express permission promulgated in orders.

Limits.

189. The recreation ground for athletic exercises, such as walking, jumping, running, and playing ball, (in all of which the Superintendent would recommend practical exercise,) will be bounded by the fence surrounding the green—commencing on the east of the Citadel, and continuing to the brick wall in front, and on the south; thence in a direct line to the Citadel, by the front of the gun-house, but not to include any ground west of the front of the gun-house.

190. The lot on the southwest of the Citadel, on King-street, is not included in recreation grounds, and no Cadet must enter it without permission.

191. No Cadet will be allowed to walk on recreation grounds, when he is on guard, sick, or during study hours.

192. A permit to walk on recreation grounds, or for any indulgence, will be rendered invalid if the individual's name is on the sick report, unless it be so expressly stated.

193. The strictest attention to study and all other duties is required. Every Cadet, therefore, who shall absent himself from duty of any kind, and fail to render a satisfactory excuse in writing, for such absence, shall be reprimanded, put on extra duty, or confined, according to the circumstances of the case; and demerit marks, in number proportioned to his offence, will be recorded against him.

194. All delinquencies, for which Cadets have been reported, for any one week, will be read out on Friday afternoon parade.

195. Any Cadet having a satisfactory excuse for such delinquencies, shall express it in writing, after the form prescribed, and submit it to the Superintendent within his first orderly hour, after the publication of the report on parade. No excuse shall be made by any Cadet, in any other manner, nor at any other time, unless unavoidably prevented from complying with the above directions, in which case the cause of delay shall be annexed to the excuse.

197. The class sections shall assemble at their respective hours of Recitations. recitation, on the barrack parade ground, where the roll will be called, after which they will be marched to the section room. Silence and soldier-like deportment are required of all Cadets, while on class parade, and while marching to and from the section rooms.

198. Every Cadet, unless he is an assistant teacher, or excused by

the Surgeon, shall assemble and march with his section.

199. Every Cadet permitted to leave the section, shall return as soon as possible; and any one who remains out more than ten minutes, shall be reported, by the marcher, to the officer of the guard, and on the weekly class report by the instructor.

200. Whenever an officer or Professor enters a recitation room, or Cadets' barrack room, all Cadets will rise, and silence and deco-

rum will be observed while they are present.

201. The Cadet whose name stands first on the class roll, at the commencement of the term, shall be marcher of his section during the whole term, unless otherwise ordered; and as soon as the signal is given, the marcher shall form his section, at the place appointed, in two ranks; shall call the roll, note each absentee, and immediately thereafter report the names of all absentees to the officer of

202. The marcher shall march his section in a soldier-like manner, and upon being dismissed from the section room, he must march it back to the parade ground in the same manner and dismiss it.

203. Every instructor shall note, in his weekly class report, the name of each Cadet of his section, who has been dilatory, with the time and description of his offence. He will also state, in his report, the progress made during the week by his section, and the subject on which he has been engaged, as prescribed in the regulations of the Military Academy of West Point.

204. No instructor shall dismiss his section before the proper signal is made, without mentioning the same on his weekly report, with reasons therefor.

205. The instructors shall hand in their class reports to the Superintendent, on Saturday, between 7 and 10 o'clock, A. M.

206. The Superintendent will transact business, with the Cadets, Office hours. between the hours of 8 and 9 o'clock, daily, and at no other time.

Marchers.

207. The Superintendent's office shall be open on Tuesday and Friday of each week, from 1 till 2 o'clock, P. M. for the visits of Cadets to examine such rolls and records as may be left open for their inspection; but no Cadet shall visit this office at any other time than above prescribed, and at regular orderly hours, unless specially permitted by the Superintendent.

Miscellaneous.

208. No Cadet will interfere with or interrupt any soldier of the guard, in any way whatever; and no Cadet must speak to or interrupt a sentinel on post.

209. No Cadet will be allowed to pass out of the Citadel gate after Retreat or before breakfast, except by special permission from

the commanding officer.

210. No loitering about, or crowding in the archway, or before it, so as to interrupt the guard, or its officers, will, at any time, be allowed, and especially not at Tattoo.

211. Cadets are particularly enjoined to conduct themselves, when on recreation grounds, in an orderly, gentlemanly and soldierlike manner, and any conduct other than such, will be punished according to the nature of the offence.

212. And generally, in all their intercourse with their officers, each other, and all persons whosoever, it is expected of them to preserve the high toned feeling and courtesy which ever distinguish the soldier and gentleman.

Citizens, &c. not to introduce, &c.

213. No Cadet will introduce any citizen, lad, boy or other person into the barrack rooms, without permission from one of the Professors or the Superintendent.

214. Any Cadet who shall be habitually neglectful of his studies and duties, shall be dismissed from the Academy.

Professors, ble for instruments, &c.

215. Each Professor and Instructor, at the head of a separate &c. accounta-department, will have charge of and be accountable for the instruments and apparatus supplied for the use of his department.

Certificates

216. No Professor, Assistant Professor, or Teacher, shall give a & statements, certificate, or make any statement or report, relating to the qualifications, standing, conduct, or character of any Cadet, or of any person having been a Cadet, or concerning the examination of any candidate for admission, unless required so to do by the special direction of the Principal Professor.

Newspapers, &c.

217. The Cadets are prohibited from taking any newspaper, or other periodical publication, without special permission from the Superintendent; and no such permission shall be given for more than one newspaper, or periodical, to each Cadet, and then only on condition of its being paid for in advance.

ARSENAL ACADEMY.

Interior Police and Discipline.

218. The Cadets shall be organized into a Company, the officers of which shall be appointed, by the Superintendent, from those Cadets who have been most active and soldier-like in the performance of their dutiers, and most exemplary in their conduct.

219. There shall be an infantry or artillery drill every day, when the weather is favorable, (Saturdays and Sundays excepted,) at such regular hour of the day as the Superintendent may appoint; to continue not less than three quarters of an hour, nor more than one hour and a half.

220. There shall be a dress parade at retreat, when in barracks, Dress Parade. according to the form prescribed in the general Army regulations.

221. There shall be an inspection of the Company, under arms, Saturday Inspections. every Saturday morning, (when the weather permits,) at nine o'clock, according to the form of the Army.

222. No Cadet shall be excused from any duty whatever, without Excuses from permission from the Superintendent, unless excused by the Surgeon.

223. The hours for daily duties will be as follows:

Reveille—At 5 o'clock from 1st April to 30th September; and at ly duties and 6 o'clock for the remainder of the year.

"Peas upon a Trencher"—Signal for Breakfast, at half past 7 o'clock.

"Roast Beef"—The Signal for dinner, at 1 o'clock. Surgeon's Call—On the arrival of the Surgeon.

Retreat—At sunset.

Tattoo-At half past 9 o'clock from 1st April to 30th September, and at 9 o'clock for the remainder of the year.

Taps—30 minutes after tattoo.

Church Call—At a quarter to ten o'clock, A. M., on Sundays.

Call "to quarters"--For study, in barracks, at 30 minutes after returning from supper, and on Sundays at 3 o'clock, P. M.

Hours for study will be from Reveille till breakfast call, and from 9 till 12 M., from 2 till 4 P. M. and 30 minutes after returning from supper, till tattoo.

There will be five general roll calls daily, and invariably: The 1st at Reveille, 2d at Breakfast, 3d at Dinner, 4th at Retreat, and 5th at Tattoo; at which all Cadets not on duty, or absent by permission, or excused by the Surgeon, are required to attend.

224. No Cadet shall retain in his possession any articles of dress, other than prescribed by the regulations, without permission.

225. The Jacket shall only be worn in quarters, on class parade, in section room, and within the Arsenal grounds when not on duty.

Hair trimmed.

226. Cadets shall have their hair trimmed close behind; Mustaches and Whiskers shall not be worn.

Arms.

227. No Cadet shall lend or exchange his arms or accountrements, nor use those of another Cadet, nor shall the arms be taken from quarters, except for duty, without permission.

228. No Cadet shall alter his musket by filing or scraping or varnishing the stock, or remove the lock, without permission of the Superintendent.

229. Cadets are prohibited from having in their possession gunpowder or any description of fire arms, or other weapons, not issued by the proper authority.

Police of quarters.

230. No Cadet shall remove from the room or bed assigned to him, without permission of the Superintendent.

231. Every Cadet, on rising in the morning, shall roll up his matrass, with the bed-clothes neatly folded in it, and strap it. He shall put such articles in the clothes bag as it is intended to contain, clean his candlestick, and arrange all his effects in the prescribed order.

232. Every Cadet shall attend to the good order and arrangement of his own arms, accourtements, clothing and other effects; the Orderly shall attend to the general police of the room, and shall require each occupant to discharge his proper duty.

233. Cadets must prepare their clothes for the laundress, before 7 o'clock on Monday and Thursday mornings of each week.

234. No Cadet shall throw stones, water or any other articles from their windows, or in or about their quarters, or on the Arsenal grounds.

235. No Cadet shall keep any unauthorized article of furniture, and no Cadet shall keep a light after Taps, except when on duty and authorized so to do.

236. No Cadet shall play on any musical instrument on Sunday, nor in study hours on any other day, nor shall they play at cards or other games of chance, at any time, nor keep implements used in such games in their rooms.

237. Cadets shall pass up and down stairs, in study hours, with as little noise as possible: running, loud talking, or scuffling in barracks is strictly prohibited.

238. No loitering or idling around the barracks, or any other place, can be allowed during study hours.

275. The sick Cadets, who remain in quarters, shall not leave their rooms except for the purpose of performing some duty, or taking such exercise as the Surgeon may have prescribed, with the approbation of the Superintendent.

276. But no Cadet shall, for any purpose whatever, be absent from his room during any drill, parade, or roll call, from which he

may have been excused by the Surgeon.

277. The sick, in the hospital, shall obey the orders of the Surgeon, and all such police regulations as he may prescribe, with the approbation of the Superintendent.

278. No person is allowed to visit the hospital, unless by permis-

sion of the Superintendent.

Commons.

279. The senior officer of Cadets present, shall be commandant of the mess hall; he shall preserve order in the hall, and a due observance of the mess regulations; and shall see that the mess squads are conducted to and from the mess hall in a military and soldier-like manner.

280. The Cadets shall be divided into as many squads as there are tables, with a first and second carver to each, who shall cause the regulations of the hall to be observed by all in their squad, and shall report all delinquencies to the Superintendent.

281. At the respective signals for meals, the squads will be formed on the company parade ground, by the first carvers of each squad, as squad marchers, under the superintendence of the commandant of the hall, who shall march them to and from the hall.

282. The squad shall be formed and marched by the second earver, in the absence of the first; but in other cases, he shall march at the head of his squad. He is also responsible for any violations of the regulations in his squad, and shall report all such to the commandant of the hall.

283. All Cadets shall march to and from their meals, (except the sick in the hospital,) and they shall leave the hall at the signal given by the commandant of the hall.

284. Each Cadet shall have a particular place assigned him at table, by a number, corresponding to his position in the squad, and

shall not change it, except by permission of the Superintendent. 285. All unnecessary talking is strictly prohibited in the hall, and the carvers alone shall call on the waiters.

286. Wasting provisions, or taking them from the mess hall, or injuring or abstracting mess furniture of any kind, is strictly prohibited.

287. The commandant of mess shall see that no Cadet takes his seat in the hall before the command "seats;" and also, that every Cadet leaves the hall after the command "rise;" but for the better preservation of order, each table will be made to rise in turn, and form in squad in front of the hall, and march back in the same order as marched to the hall.

288. No Cadet shall go into the mess hall, (except on duty,) at any other time or in any other manner than is herein prescribed—nor into the kitchen, nor tailor shop, without permission from the Superintendent.

289. All deficiencies in or complaints of the mess hall, will be reported immediately, through the commandant of messs, to the Superintendent of the Academy.

290. The academic limits, between reveille and evening study call, will extend to that part of the Arsenal grounds lying on the west side of a line drawn from the middle of the fence connecting the officers' and Cadets' quarters to the middle of the south fence of the enclosure. Between evening study call and reveille, the limits will extend only to the night privy, the well, and the Superintendent's office, and to no other parts, on pain of suspension.

291. Climbing or jumping the fence around the Arsenal grounds,

is strictly prohibited.

292. Cadets are required to pass out and in, by the large gates or doors, on the east and west sides of the Arsenal lot; and in going out of the east gate or door they will pass on the south side of the Arsenal.

293. No Cadet shall go into Town, at any time, except with per-

mission of the Superintendent.

294. No excuse whatever will be taken from any Cadet who shall leave the Arsenal grounds without permission from the Superintendent; he will most positively be *suspended*.

295. Every Cadet shall pay to his superior officers the compli-Compliments. ments prescribed by the general regulations of the Army to be paid to officers.

296. All officers shall duly acknowledge the salutations, in the form and manner prescribed in the regulations aforesaid. Those

compliments and salutations shall also be observed by all enlisted persons employed about the Arsenal.

Societies.

297. No Society shall be organized among the Cadets, without special licence from the Superintendent, nor shall any assembly of Cadets be held for this or any other purpose, without his express permission promulgated in orders.

Visiting.

298. No Cadet will be allowed to visit the room of another, during study hours.

Sundays.

299. On Sundays, the Cadets are enjoined to relinquish their sports; to devote their spare hours to study and reading; and to conduct themselves in a peaceable and quiet manner. The Cadets can have permission to go to Church in the afternoon: but any abuse of this permission will be severely punished.

Excuses.

300. The strictest attention to study and all other duties is required. Every Cadet, therefore, who shall absent himself from duty of any kind, and fail to render a satisfactory excuse in writing for such absence, shall be reprimanded, put on extra duty, or confined, according to the circumstances of the ease; and demerit marks, in number proportioned to his offence, will be recorded against him.

Delinquencies.

301. All delinquencies for which Cadets have been reported, for any one week, will be read out on Friday afternoon parade.

302. Any Cadet having a satisfactory excuse for such delinquencies, shall express it in writing, after the form prescribed, and submit it to the Superintendent within his first orderly hour, after the publication of the report on parade. No excuse shall be made by any Cadet in any other manner, nor at any other time, unless unavoidably prevented from complying with the above directions, in which case the cause of delay shall be annexed to the excuse.

303. No Cadet shall address an officer or Cadet, who has reported him for delinquency, on the subject of such report, unless specially permitted by the Superintendent; and no officer or Cadet having made such report against a Cadet, shall hold any conversation with him relating to it, unless referred to with the proper permission.

Marchers.

304. The class sections shall assemble at their respective hours of recitation, on the barracks parade ground, where the roll will be called, after which they will be marched to the section room. Silence and soldier-like deportment are required of all Cadets while on class parade, and while marching to and from the section rooms.

305. Every Cadet, unless he is excused by the Surgeon, shall assemble and march with his section.

306. Whenever an officer or Professor enters a recitation room. or Cadet's barrack room, all Cadets will rise, and silence and decorum will be observed while they are present.

307. The Cadet whose name stands first on the class roll, shall be the marcher of his section, unless otherwise ordered; and as soon as the signal is given, the marcher shall form his section, at the place appointed, in two ranks; shall call the roll, note each absentee, and immediately thereafter report the names of the absentees to the Superintendent.

308. The marcher shall march his section in a soldier-like manner, and upon being dismissed from the section room, he must march it back to the parade ground in the same manner and dismiss it.

309. The Superintendent will transact business with the Cadets, Office hours, at 8 o'clock, A. M. daily, and at no other time.

310. The Superintendent's office shall be open on Monday of each week for the visits of Cadets to examine such rolls and records as may be left open for their inspection; but no Cadet shall visit this office at any other time than above prescribed, and at regular orderly hours, unless specially permitted by the Superintendent.

311. No Cadet will interfere with or interrupt any soldier of the guard in any way whatever; and no Cadet must speak to or interrupt a sentinel on post.

312. Cadets are particularly enjoined to conduct themselves, when in the streets of Columbia, in a quiet and gentlemanly man-Any Cadet misbehaving, while in Town, will be suspended. And generally, in all their intercourse with their officers, each other, and all persons whomsoever, it is expected of them to preserve the high toned feeling and courtesy, which ever distinguish the soldier and gentleman.

313. The Cadets are forbid to go into the Arsenal, or to make any application so to do, unless in company with those friends or relatives who may come to visit them.

314. No Cadet shall apply for or receive money, or any other Money not to supplies, from his parents, or from any person whomsoever, without be received, the permission of the Superintendent. Any infraction or violation of this rule will be considered a disobedience of orders and punished accordingly.

Miscellane-

OHS.

315. Any Cadet who shall be habitually neglectful of his studies and duties, shall be dismissed from the Academy.

Habitual neglect.

316. Ignorance of any published order or regulation, will not be considered a sufficient excuse for misconduct.

APPENDIX

The following is a general form of application, for admission into the Military Academy as a beneficiary Cadet; which may be varied to conform to circumstances. If the application is for a pay Cadet, the word pay must be substituted for the word beneficiary, and the statement as to pecuniary means, and certificate of the Commissioners of Free Schools omitted:

FORM OF APPLICATION.

To the Chairman of the Board of Visitors:

I apply for the admission of (name in full) as a beneficiary Cadet in the State Military Academy. He is a resident of District, years old, feet inches high. He can read and write with facility: is of fair moral character, and free from all physical defect or deformity, and is not afflicted with any disease or infirmity which would render him unfit for military service. He is without pecuniary means in his own right, and his parents are unable to pay for his education.

The following certificate must be annexed:

We, the Commissioners of Free Schools, for the District of (or Parish of) recommend the above named (name of the boy for whom application is made) for admission as a beneficiary Cadet into the State Military Academy. He and his parents are without sufficient pecuniary means to educate him, and we consider him worthy of the beneficence of the State.
