- \* The Senate is in recess. Paul is in Massachusetts. The Senate will next be in session at Noon on Wednesday, July 8, when it will resume consideration of S. 951, the Justice Department Authorization bill.
- \* Legislative Quote of the Day (Wall Street Journal): "There is a feeling that the Presient's economic policies will help the mink coat set. But do they trickle down, do they create jobs? Someone has said 'mink coats don't trickle down, they just shed'." --- thank you, Missy.
- \* On June 19, the President sent a "fire sale" recission/deferral request for FY81 to the Congress for approval. There are 6 recission proposals totalling \$321 million in FY81 authority, and 13 budget deferrals totalling \$220.1 million. In addition, 5 previously requested deferrals are increased by a total of \$78 million. The recission and deferral proposals cover programs in the following Departments and Agencies: USDA, Education, HHS, HUD, EPA, DOD, Interior, State, and the National Endowments. This brings to \$15.1 billion the Presidential recissions for FY81, and to 8.9 billion the Presidential deferrals for FY81.
- \* The Senate Select Committee on Ethics plans daily meetings for three weeks starting July 14 to consider disciplinary action against Sen. Harrison Williams arising from the ABSCAM case. The charges against him are expected to include violations of the Senate rules on financial disclosure, conflict of interest, and improper conduct that reflects on the Senate. Williams has demanded that the hearings include consideration of government investigative abuses, but Committee members agree that the issue is not within their jurisdiction.

The Senate Governmental Affairs Committee will begin markup July 8 of S. 1224, a bill to revise the CONGRESSIONAL FRANKING PRIVILEDGE. The bill would permit Senators to use the frank to make statewide mass mailings (postal patron).

A House Appropriations Subcommittee voted June 24 to give the Legal Services Corporation \$239 million for FY82-- \$2 million less than the House authorized June 18 in HR 3480, which reauthorized the LSC for two years. Also June 24, the Senate Labor and Human Resources Committee voted 9-7 to reauthorize the LSC for three years at \$100 million annually even though President Reagan eants to kill the Corporation.
