A BILL

To amend the Local Public Works Capital Development and Investment Act of 1976 to authorize funds for certain smaller cities and townships.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the Local Public Works Capital Development and
4 Investment Act of 1976 is amended by adding at the end
5 thereof the following new section:

6 "SEC. 112. (a) (1) Notwithstanding any other provi-
7 sion of this Act, the Secretary is authorized to make grants
8 under this Act from funds authorized to carry out this sec-

1 tion, to any city or township of fifty thousand population or
2 less which is located in a county or labor market area which
3 contains a city of more than fifty thousand population. The
4 aggregate of all grants made under this section to any such
5 city or township shall not exceed the amount which such
6 city or township would receive, based upon the percentage
7 contribution made by such city or township to the total num-
8 ber of unemployed persons in the State in which such city
9 or township is located, and to the average unemployment
10 rate of such State, of the allocation which would be made
11 under this Act to such State if all of the funds authorized in
12 section 111 of this Act for the period ending December 31,
13 1978, were allocated among the States without any set-aside
14 for administrative or other purposes, reduced by the amount
15 of all grants made to such city or township under any sec-
16 tion of this Act other than this section.

17 “(2) Amounts available to such a city or township for
18 grants under this section shall be in addition to, and not in
19 lieu of, amounts otherwise available for grants to such city
20 or township under this Act.

21 “(b) There is authorized to be appropriated to carry
22 out this section \$196,927,000.”
