I am writing again to add my support to the application for political asylum filed with your office by Dennis Brutus.

Dennis Brutus is a distinguished poet, academic and activist who was exiled from South Africa for his outspoken and steadfast opposition to racism and oppression. Professor Brutus has developed a national and international reputation as an authority on African literature and culture. He is admired and respected for both his achievements in his profession and his commitment to the pursuit of human rights.

Professor Brutus' literary works have been widely published. His works and activities opposing the apartheid movement in South Africa have also been documented and are easily available. Professor Brutus is a highly profiled spokesman on the antiapartheid movement. I trust that sufficient documentation can be made available to you to support this concern.

I have been informed that the South African Secret Police have hunted Professor Brutus across several continents because of his well known opposition to the system of apartheid practiced by the South African government. I personally have been interested in South Africa for many years. I have followed closely the political and economic development of this country, and I have concluded that the Nationalist Party government is not proceeding toward significant reform of apartheid. With this in mind, I feel that Professor Brutus would be in great danger if he is to be deported to the region of South Africa. Historically, his actions have shown blatant opposition to this government and have placed him in serious physical hardship. I am convinced of Professor Brutus' claim to be granted asylum in the United States. I hope therefore that you supporting his claim are overwhelming.
