Whereas the Government of the Soviet Union in taking these actions against Mrs. Ida Nudel has violated fundamental human rights, including the right to freely emigrate, and has disregarded the spirit of the Final Act of the Conference on Cooperation and Security (commonly known as the Helsinki Accords); and of the Universal Declaration of Human Rights; and

Whereas the courage of Mrs. Ida Nudel and others serves as an inspiration to people throughout the world and calls for the Congress to address the unconscionable repression of individual freedom by the Government of the Soviet Union: Now, therefore, be it
