COLLOQUY RE: APPROPRIATIONS FOR LOCAL ENERGY CONSERVATION

SENATOR TSONGAS:

I WONDER IF THE SENATOR FROM WASHINGTON AND THE SENATOR FROM KENTUCKY WOULD TAKE A MOMENT TO CLARIFY A POINT. THE SENATOR FROM NEW JERSEY AND I ARE HOPEFUL THAT OUR COMMUNITY ENERGY CON-SERVATION LEGISLATION, WHICH IS PART OF S. 1280, THE ENERGY MANAGE-MENT PARTNERSHIP ACT, CAN BE ENACTED IN THIS SESSION OF CONGRESS. WE ARE NOW ON THE VERGE OF PROVIDING THE MISSING LINK IN OUR NATIONAL ENERGY STRATEGY, BY MAKING GOVERNMENT OUR PARTNER IN FFFORTS TO DEAL WITH THE ENERGY CRISIS. THE SENATOR FROM WASHINGTON IS A CO-SPONSOR OF THAT LEGISLATION, AND HE HAS BEEN TREMENDOUSLY HELPFUL TO US ALONG THE LONG ROAD TO ESTABLISHING THIS NEW PROGRAM. I WONDER IF HE OR THE SENATOR FROM KENTUCKY WOULD CLARIFY FOR US THE SITUATION WITH RESPECT TO FUNDING FOR THE ENERGY MANAGEMENT PARTNERSHIP ACT FOR FY '31.

SENATOR HUDDLESTON:

I WOULD BE PLEASED TO EXPLAIN THE COMMITTEE'S UNDERSTANDING

OF THE SITUATION FOR THE SENATOR FROM MASSACHUSETTS AND THE SENATOR

FROM NEW JERSEY. THE ADMINISTRATION, AS THE SENATORS KNOW, REQUESTED

A BUDGET ITEM OF \$25 MILLION FOR THE LOCAL ENERGY CONSERVATION PROGRAM, ON THE ASSUMPTION THAT WE WILL AUTHORIZE SUCH A PROGRAM IN THIS CONGRESS. THE COMMITTEE BELIEVES THAT THE EFFORT TO INVOLVE LOCAL GOVERNMENTS IN THE DEVELOPMENT AND IMPLEMENTATION OF OUR NATIONAL ENERGY POLICY IS HIGHLY DESIRABLE. THE COMMITTEE'S DECISION TO DEFER ACTION ON FUNDING FOR THIS IMPORTANT PROGRAM WAS BASED ON THE FACT THAT THE AUTHORIZATION PROCESS IS NOT YET COMPLETED. IT IS MY UNDERSTANDING THAT WE ARE WAITING FOR THE FULL HOUSE TO ACT ON LOCAL ENERGY CONSERVATION LEGISLATION, AND THAT WE WILL REQUIRE A CONFERENCE ON THIS LEGISLATION. SO, THE COMMITTEE PROVIDED NO FUNDS FOR THE COMMUNITY ENERGY CONSERVATION PROGRAM IN THIS APPROPRIATION BILL.

SENATOR TSONGAS:

I APPRECIATE THE SENATOR FROM KENTUCKY'S EXPLANATION FOR WHAT I FEEL WAS A SIGNIFICANT OMISSION IN THE COMMITTEE'S DELIBERATIONS THIS YEAR. I KNOW THAT THE SENATOR FROM NEW JERSEY ALSO HAS SOME SPECIFIC POINTS TO RAISE WITH RESPECT TO THIS FUNDING; BUT I WOULD SIMPLY LIKE TO ASK THE SENATOR FROM

KENTUCKY IF HE WOULD FURTHER CLARIFY WHAT THE COMMITTEE WOULD EXPECT TO DO ONCE THE AUTHORIZATION LEGISLATION IS ENACTED.

SENATOR HUDDLESTON:

I WOULD BE GLAD TO INDICATE FOR THE SENATOR WHAT THE

COMMITTEE'S EXPECTATION IS. AS THE SENATOR KNOWS, THE ADMINISTRATION HAS EXPRESSED IT'S STRONG SUPPORT FOR A LOCAL CONSERVATION PROGRAM, AND HAS INDICATED THAT IT WILL SEEK FUNDING
ONCE THE LEGISLATION IS ENACTED. WHEN THE SUPPLEMENTAL APPROPRIATION
REQUEST IS TRANSMITTED BY THE ADMINISTRATION, I WANT TO ASSURE
THE SENATOR THAT THE COMMITTEE WILL CONSIDER IT EXPEDITIOUSLY.

SENATOR WILLIAMS:

I APPRECIATE THE COMMENTS OF THE CHAIRMAN. I WOULD LIKE
TO POINT OUT THAT THIS LEGISLATION RECEIVED THE UNANIMOUS
ENDORSEMENT OF THE SENATE LAST JULY 25, AND WE ARE INDEED ANXIOUS
TO GET THIS PROGRAM OFF AND RUNNING IN OUR CITIES AS SOON AS
POSSIBLE. I KNOW THAT THE CHAIRMAN IS WELL AWARE, AS I AM,
THAT ANOTHER WINTER IS COMING ON AS WE OBSERVE, WITH APPREHENSION,
THE IRAQI-IRANIAN CONFLICT. DRASTICALLY INCREASED FUEL PRICES

FORCE COMMUNITIES AND CITIES TO DIVERT SCARCE FISCAL RESOURCES
TO MEET UTILITY BILLS AND THE HUMAN TRAGEDIES OF COLD AND
SUFFERING. THE LOCAL ENERGY CONSERVATION PROGRAM HAS DIRECT
BEARING ON EFFORTS TO OFFSET OR ALLEVIATE THE SPECIAL BURDENS
OF DISTRESS IN OUR URBAN AREAS. THE PROGRAM CAN HELP PUT OUR
CITIES BACK ON A STRONG ECONOMIC FOOTING. IT IS A MONEY SAVER
AND A JOBS PRODUCER. THE SOONER WE CAN GET THIS SUPPLEMENTAL
APPROVED, THE SOONER WE WILL GET THE FUNDS OUT WHERE THEY ARE
SO BADLY NEEDED.

SENATOR MAGNUSON:

I DO AGREE WITH THE SENATOR FROM NEW JERSEY THAT WE SHOULD

MOVE AS QUICKLY AS WE CAN TO IMPLEMENT THIS IMPORTANT NEW INITIATIVE.

ENERGY COSTS ARE BECOMING AN INCREASINGLY IMPORTANT FACTOR IN

THE MONTHLY BUDGET OF THE AVERAGE FAMILY. THE ENERGY MANAGEMENT

PARTNERSHIP ACT IS DESIGNED TO PROVIDE ASSISTANCE DIRECTLY TO

LOCAL GOVERNMENTS THAT ARE WORKING TO CUT ENERGY COSTS. I AM

PLEASED TO BE A CO-SPONSOR OF THIS IMPORTANT LEGISLATION.

I LOOK FORWARD TO WORKING WITH THE SENATORS FROM MASSACHUSETTS
AND NEW JERSEY AND THE MEMBERS OF THE INTERIOR APPROPRIATIONS

SUBCOMMITTEE FOLLOWING THE ENACTMENT OF THE AUTHORIZATION BILL.

SENATOR WILLIAMS:

AGAIN, I THANK THE CHAIRMAN, AND WOULD LIKE TO SAY THAT
THE SENATOR FROM MASSACHUSETTS AND I WERE STRONGLY HOPEFUL THAT
THIS APPROPRIATION BILL WOULD CONTAIN FUNDING FOR THIS IMPORTANT
PROGRAM, BUT I THINK WE CAN NOW FEEL THAT WE HAVE ASSURANCES
THAT THE COMMITTEE WILL ACT WITH ALL DUE SPEED TO APPROVE A
SUPPLEMENTAL ONCE THE AUTHORIZING LEGISLATION IS ENACTED.
