

- * The Senate is in recess. Paul is in Massachusetts.
- * Highlights of Paul's schedule today: Speaking to the student body at the Brooks School in North Andover.
- * The NRC Authorization Bill reported by the HOUSE Interior Committee on April 10th prohibits the use of funds in the bill for the cleanup or repair of Three Mile Island.
- * The Senate ENERGY COMMITTEE, Subcommittee on Energy and Mineral Resources will hold hearings on off-budget funding methods for the Strategic Petroleum Reserve today (also April 22, 29 and 30).
- * The Senate Banking Committee will begin its hearings on major banking and consumer protection laws on April 28.
- * The House has blocked a Senate move that would allow President Reagan to appoint Dr. C. Everett Koop, an ardent opponent of abortion, as Surgeon-General. Koop is 64 years old. Existing law requires that a person named Surgeon-General must be under 64. Sen Helms attached an amendment removing the age limit to an unrelated bill passed by the Senate in March. Speaker O'Neill referred the bill to the Energy and Commerce Subcommittee on Health, whose Chairman, Henry Waxman, opposed the Senate tactic. Waxman refused to approve the amendment and the House sent the matter to a conference committee.
- * Attached is a chart published this week by CONGRESSIONAL QUARTERLY which shows the major cuts in programs for the poor proposed by the Reagan Administration for Fiscal Year 1982. It lists major programs affected, a brief description, the Carter request, the Reagan cut, and an explanation of how the cut is to be achieved:
