"Thursday before the second Friday in August," 1874, at 11 o'clock, A. M. After singing and prayer, Elder Asa Routh, of Sullivan county, preached the Introductory Sermon from Phil. II, 9; Theme—"The Excellency of the Name of Jesus." Elder W. A. Keen offered prayer, after which the Association adjourned till 2 o'clock, P. M. Benediction by Elder J. T. Kincanon.

# BOOKS AND PERIODICALS.

That the circulation and reading of good religious books and papers among our people is a matter of the very highest importance, will not be questioned, yet how sadly true it is. that a large majority of our families are without such books as teach and defend our peculiar faith and practice, and as we claim the faith and practice of the gospel. Few are in possession of even a religious newspaper, such as would prove a means of keeping members of the church posted and interested on all matters of importance to our denomination. It it a matter of universal experience that those who read most. and hence are the best informed with reference to the great interests and enterprises of the denomination, are the most easy of access, and come most promptly to the moral and pecuniary support of every interest. How can they be interested in that of which they have not heard and how shall they hear if they do not avail themselves of the ordinary means by which such information is communicated? Our people must be a knowing and an intelligent people, if they would be an efficient people; and in order to possess such knowledge as will make them interested supporters of every good word and work, they must read such books and papers as teach and defend our doctrines and keep before the people the enterprises, great and small, which, as a denomination we are trying to carry forward.

Among the many religious papers that might be recommended, your committee would call the attention of the Association to The Baptist, at Memphis, and The Christian Index, at Atlanta, Ga., as able exponents of Baptist doctrine and practice. We especially commend The Monthly Messenger, published at Bristol, Tenn., as a medium of communication for this and neighboring Associations.

Dungan moved to amend this motion so as to read—to suspend the consideration of the subject of Education till 2 o'cl ck. and in the meantime take up other items of business on the pr gramme. The amendment prevailed.

## SUNDAY SCHOOLS.

Wheneas, the Sunday School C ovention having maintained a eparate existence from this Association, does now for satisfactory reasons desire to be re-united with the Association; we, therefore, respectfully recommend that the Sunday School Convention be re-organized in connection with this Association as it existed before its separation.

After earnest remarks by Elders Lee and Moore and brethren Dungan, King and Kilday, on in tion seconded, the rep rt was unamimously adopted.

#### AMENDMENTS

Amendment to the 5th Article of Constitution was offered by Elder Buckles. Amendment:—"The officers of this Association shall be one Moderator, one Clerk and a Treasurer. None of which shall be eligible to office more than two years in succession, all of whom shall be elected by ballot, and the majority of votes cast shall be necessary to a choice. The election shall take place annually as soon after the delegates

convene as practicable." [Words italicised indicate the change contemplated.—CLERK] The motion was lost.

Amendment to 10th Rule of Order of Business was offered by Elder W. N. Buckles. Rule: "All Resolutions must be reduced to writing before received." Adopted.

An amendment to 11th Rule of Order Business was offered by same. Rule: "No member shall be allowed to speak more than thirty minutes, unless by permission of the body." Adopted.

On motion of Bro. J. S. Hamilton, adjourned for one hour. Benediction by Elder Asa Routh.

# AFTERNOON Session.

2 o'clock, p. u.—Re-assembled at the sound of singing; prayer by Elder B. F. White.

Elder J. H. Moore moved that the appointment for preaching at the stand this evening be re-called. The motion, duly seconded, was lost.

Pursuant to previous motion, resumed the discussion of the subject of Education. After a full and animated address on the subject by Elder J. T. Kincanon, who spoke with special reference to the claims of Bristol Female College, the report as amended was unanimously adopted.

# REPORT ON EDUCATION:

Brethren, your Committee on Education has nothing of much interest to report. The subject has been discussed from the stump, the pulpit, and the press, until little more remains to be said. What more then can we expect in a report on Education than the repetition of a dull formula. The subject, however, is one that is full of interest. Every citizen, every parent, feels or should feel a deep interest in the education of his children.

Much has been done already for the education of the masses. Our public men are doing much to arouse and quicken an interest in our public schools. Many intelligentent, erprising men and women are devoting their time and talents to raise the standard of education in our midst, among whom are some of our own brethren.

Your Committee think it superfluous to urge upon this body

the necessity and importance of educating our children. A few thoughts, however, suggest themselves. Should we be content to give our children a partial instead of a thorough course of mental training? No my brethren, we should not stop here. Indeed we should not begin here. We hold that education should be First, Physical; Second, Religious; Third, Moral and Fourth, Mental.

Your Committee is of the opinion that as touching the subject of Education we as an Association of Baptist Churches overlook the most important feature of the subject, viz:

## MINISTERIAL EDUCATION.

As a consequence much precious talent is lost to the church and many of our most promising young ministers, are kept down for want of a helping hand, or forced to go from among us to find succor in more liberal fields of labor, whilst many others struggle on under great disadvantage. The consequence is the churches are not thoroughly educated in doctrine and practice. Errors prevail, and the church is crippled in her efforts to convert the world. Then as Christian parents let us educate our own children. As Baptist Churches, let us aid our young brethren that we ordain and set apart for the work of the Ministry. Then may we pray in hope for the good times that are coming from the presence of the Lord. We further and heartily recommend to this Association the Bristol Female College, Col. Dungan's School, at Jonesboro', and Mossey Creek College as institutions worthy of your fostering care and at which you may successfully educate your sons and daughters. J. H. KING, Ch'n.

Elder W. N. Buckles moved that Bro. S. H. Ball, standing Committee on Ministerial Support, be relieved from duty on said committee. Carried.

On motion of Elder Keen another committee was appointed to report on this subject to-morrow. Committee—Elder R. N. Lee and Bro R H. Dungan.

Dr. Wm. Smith, Standing Committee on "Our Duty to Freedmen" being absent, Elder W. N. Buckles moved to pass that subject for this session. The motion, being seconded was lost. Elder A. Routh moved that another committee be appointed to report on this subject to-morrow. Carried.

Enon.—Has built a house of worship and received fortythree by baptism, and has a Sunday-school of 105 members.

Mt. Olivet.—Has a weekly prayer meeting and an "Evergreen" Sunday-school.

McPheter's Bend.—"We are in a healthy condition. Our

membership has increased under the faithful labors of our beloved pastor—Elder Eli Ratliff. We are at peace among ourselves. Have kept up a prayer meeting, but regret that we have no Sunday-school. We contribute for Home Missions \$10 00"

OAK GROVE.—We are without a pastor. Have had no preaching during the year. Our condition is spiritually gloomy. Have a house of worship nearly completed, but are unable to finish it.

HARMONY .- Contributes for Home Missions \$1.

BUFFALO RIDGE.—Contributes to Home Missions \$10; to Foreign Missions \$5 90. Received an entire household of five members to day—July 25th.

CLEAR FORK -Pledges to Foreign Missions \$3.

BLOUNTVILLE.—Has an "Evergreen" Sunday-school which averages thirty pupils and three teachers. Takes four copies of Baptist Teacher and twenty copies semi-monthly "Kind Words."

GREENEVILLE.—"Dear Brethren: pray for us. We are a weak and feeble band, having great difficulties to contend with. A debt of \$600 yet hangs over our church house, which we are unable to pay. Brethren, may we not ask you to provide some way to liquidate this debt?—E. W. Headrick, C. C."

Elder Joseph Flora represented the claim of this church, setting forth minutely her condition and prospects. A collection was at once taken up amounting to \$18. Eight brethren volunteered to raise \$25 each, if possible, to be paid by 1st October.

A church has been recently constituted at Carter's Station with Jas. L. Murray, Clerk, and a total membership of twenty. She has not yet united with the Association, but sends 70 cents for printing minutes.—CLERK.

# POREIGN MISSIONS.

Elder Ratliff read the report of the committee.

After remarks by Elders Keen, Ratliff and Moore, and brethren Bachman and Faw, the report was amended by striking out the last sentence and inserting another. The report as amended reads—

# FIRST AFRICAN MISSIONS.

The convention at its last meeting suspended most of our Missionaries in Africa, but notwithstanding the suspension the Missionaries have continued their labors at their own expenses and with much suffering. Here is what they say: We do not deem it right to omit duty because the the Board has forsaken us. We have continued to preach to the natives, for woe is us, if we preach not the gospel. Our Mission in Africa is suffering greatly for want of means to support it."

## CHINA MISSIONS.

Our Missions in China is in a more flourishing condition. Bro. J. B. Hartwell and wife are at Chefoo. The following is from his pen. "We have at out evening family prayers a company of twenty Chinese." Bro. T. P. Crawford under date of November 17th, 1872, writes: "We feel no misgivings as to the ultimate success of our work in China." Bro. R. H. Graves and wife write, "We begin to see the glory of God made manifest. Eventhe children in the yard as soon as they can speak are singing Happy Land." He says the word of God is being sounded abroad throughout all that wide plain. Let us praise the Lord for his glorious work.

# OUR ITALIAN MISSIONS.

Bro. G. B. Taylor writes under date of December 17th, 1873, "I am just in receipt of letters from all five of our Evangelists. I think we may now feel that the only troubles are well over and that things are moving on with fair prospects. In Rome we have a flourishing Evangelical School: I do not despair of a living Church here." Our Missionaries in Italy are doing a glorious work. The seed of the woman is bruising the serpents head.

There is now before the Board of Foreign Missions applicants for mission work from eight States of the South. The prayers for laborers have been heard, and shall we refuse to send them into the field? To our earnest calls, each has said, "here I am! send me," and who will say, thou can'st not go, and yet, if the means are not offered to send them, does not the fearful charge of forbidding them rest upon us all? This year's toil has been saddened by the fall of two of our Missionaries, viz: Dr. A. SNEED and Dr. A. G. WORTHAM. These two brethren died at their posts. They fell asleep about the same time. In their death they were not divided. Who will fill their place in the Master's vineyard? Your committee advise that the amounts contributed by churches and individuals to Fereign Missions be at once forwarded by the Treasurer of this Association to Dr. M. T. Sumner, Cor. Secretary S. B. C., Marion, Ala., with instructions to appropriate the same to the support of our African Missions.

OUR DUTY TO FREEDMEN.

Your committee recommend that the spiritual welfare of the colored population within the bounds of this Association should not be neglected by us. It is evident that the great majority of them are in the depths of poverty and ignorance, and have not the facilities within themselves to meet the great and pressing wants with regard to the salvation of their souls. We therefore recommend that the churches and pastor of this Association do all they can to instruct them in the way of truth and righteousness, remembering the words of our blessed Lord: "That unto the poor the gospel is preached." Respectfully submitted.

HOME MISSIONS.

Elder Wm. A. Keen, Standing Committee read:

Your committee on Home Missions offers the following: Home Mission work is of the first importance to the general interest, and activity of the churches and their ministry. But to make it successful we must have a zealous and thoroughly awakened pastor for each church who will take hold of this holy work with a hearty good will, and pray and work till he gets his church or churches thoroughly aroused to the great importance of this department of Christian labor. Your committee is convinced that the want of system is the chief cause of our failure to accomplish more desirable results in our missionary operations. Resolves and reports have been offered and adopted year after year, but notwithstanding all this we have not advanced one step—rather gone backward.

We have proved to ourselves and to our readers that Home Missions is a good thing. We have been telling ourselves and our people that we have large districts of unoccupied territory till we have all needful information in regard to the destitution in the bounds of the Association.

In order to success, we must have an Executive Board which will make it a point to attend all the meetings of the Board and join prayerfully in the deliberations of those meetings: then faithfuly, and energetically strive to carry into execution all the plans of the Board to raise money and employ the most effective talent upon which to expend the resources of the Board. Then we may reasonably expect to see the good cause of Home Missions taking hold of society with that deep and moving force which is necessary to give tone and character to the whole Baptist popula-

tion in our bounds. The Board should have a Corresponding Secretary who ought to be a live man, one that will keep the churches posted in regard to all the wants of the Board and the Missionaries. The Board is the Association's agent or executive, to act in its behalf while it is not in session. The Secretary is the organ of the Board through which it makes its wants known to the churches and appeals for help and co-operation. A man ought not to accept the position of Secretary unless he is willing to do this work and do it thoroughly.

The mode of raising money with us is as destitute of system as anything can well be. A few churches pledge a few dollars each and a few individuals pledge from a few cents to a few dollars and the Board waits twelve months for the money. a considerable margin of which is never paid into the hands of the Treasurer; but is lost to the Board and the cause. Yet in this unsuccessful way we continue to drag the heavy years along, doing but little. This plan is offered for the consideration of this worthy body. Let each church be canvassed by the deacons and see what each member will give weekly as God has prospered him, and let this become the basis of pledge to the Board. One-fourth of the whole amount obtained to be appropriated to the Foreign Mission Board. By thus uniting the Foreign and Domestic Mission work it will be a stimulus to Pastors, Churches, Deacons and Executive Board. Thus all may be brought into harmonious co-operation in the great work of Missions, making the Home Mission work the basis of the whole. This plan has this advantage, it is Scriptural. Paul endorses it. See 1 Cor. 16: 2. WM. A. KEEN, Chm'n.

The subject of Home Missions was discussed at length and with much energy by Elders Keen, Kincanon, J. H. Moore and brethren Crouch and Faw; after which the report was unanimously adopted.

Moved by Brother Faw that the "Circular" published by Holston Baptist Association held at Lick Creek, Greene county, Tennessee, the 2d Friday in August, 1816 be published in our Minutes immediately after Elder Keen's report on Home Missions. The motion prevailed.

## CIRCULAR.

The elders and delegates of the Holston Baptist Association, convened at Lick Creek meeting-house, Greene county, on the 9th of August, 1816—to the churches they represent, sendeth christian salutation.

DEARLY BELOVED BRETHREN, through the preserving dis-

pensation of God, we have once more enjoyed the privilege of assembling ourselves in a social capacity, and having by your letters discovered your state, we were led to mourn or rejoice according as it was declining or prosperous; and having gone through our business, permit us now to address you on the important subject of the duty of the household of fath contained in two particulars, viz, the laity to the clergy, and the clergy to the laity, or rather, first the clergy to the laity, and then the laity to the clergy, or the particular duty of ministers or preachers to the members, that the holy ghost have made them overseers over; and then (2) the duty of such members to their preachers, &c.

DEARLY BELOVED BRETHREN, the minister being put upon his work, proceeds first to preach the word of God unto them, thereby to feed the flock, and therein ought to be faithful and laborious, studying to show himself a workman that need not be ashamed, rightly dividing the word of truth, 2 Tim. II, 15, As he is a steward of God in the mysteries of the gospel, 1 Cor. IV, 1, 2. Feeding the flock of God with knowledge and understanding, Jer. 111, 15. He must be faithful in declaring the whole counsel of God, Acts xx, 20. He is to instruct them in all practical Godliness, laying before them their manifold duties, and urge them upon their consciences, Titus II, 1-15; Tim. IV, 6. Secondly: He must watch over them, as one that must give an account to God, Heb. xIII, 17. Such must have an eye upon every member to see how they behave in the house of God, where the presence of the Lord is more eminently, and where the angels do always attend, and also their behaviour in the families they belong to, and their conversation abroad; according to their capacities, they are not to sleep under their charge. Thirdly: He is to visit his flock, to know their state, in order to minister suitable doctrinal relief unto them, that the unruly may be reproved, Prov. XXVII, 23; 1 Thes. v, 14, 15. Fourth: He is to administer all the ordinances of Christ among them, as baptism and the Lord's supper, and herein he must be careful to follow the primitive pattern, thereby to hold forth the great end, whereof they were ordained. He must be constant with God in his prayers for and with them, as opportunity may serve; he must show them a good example in precepts, in conversation, sobriety and charity, faith and purity, 1 Tim. IV, 12. Behaving himself impartial unto all, not prefering the rich before the poor, nor lording over God's heritage, nor assume greater power than God hath given him, James II, 4; 1 Tim, v, 21; 1 Peter v, 3, and 5.

Ministers, who are the stewards of the mysteries of the gospel, are in an eminent manner to be regarded, as being the embassadors of II. Cor. v: 20, though they are not to hunt for it, as the Pharisees of old, Mat. XXIII, 5, 6, 7. The duties of church members toward their teachers, ministers and pastors, may be included in their (1st) praying for them, that would open a door of utterence unto them, to unfold the mys-

teries, Eph. 6, 18, 19, 20.

2dly. To obey them in the Lord, in whatsoever they admonish them, according to the word of God, Heb. XIII, 17, 22. (3.) in following their examples and footsteps, as far as warranted by the word of God. I. Cor. IV, 16, chap. XI, 1, Phil. III. 17, Heb. XIII, 7. (4.) in standing by them, in all their trials and afflictions, and in defending them in all good causes. as far as in them lies; in II Tim. 1, 15; of Isaiah are blamed for turning away, or not standing by the apostles, (5.) in not exposing their persons for their infirmities as far as may be, considering the prosperity of the gospel much depends on their good report, Acts XXIII, 5. (6) in contributing toward their maintenance, that they may attend wholly on teaching, and give themselves to the ministry of the word and to prayer, Acts vi, 6, 4. The reason thereof is evident, by a threefold law, (1) the law of nature from whence the apostle argues, I Cor. 1x, 7, 11. (2) the Levitical law, I Cor. 1x, 13. (3) the gospel enjoineth and requireth the same, Gal. VI, 6; I Cor. Jx, 14,

Let the above cited places of scripture be considered with many others of like importance, and the nature and tendency of the work of the ministry be well weighed, and it will be clear that it is a duty required of God himself; and that not in a way of alms, as to the poor, but it is to be performed in love to Christ, and in obedience to his laws, in order to support and carry the interest of the gospel; yet this is not to be given to any that may pretend to be a minister, or thrust himself upon a church, or such as run without a mission for filthy lucre sake. But churches ought to take a special care who to call forth to the ministry, according to the rule of instruction given by inspiration of God, be they learned or unlearned as to human learning, be they rich or poor as to worldly wealth, the liberality of the people (if they be able) should surmount the necessity of the minister, so as that he may exercise those acts of love and hospitality, as is required of such, that therein he may be exemplary in good works, &c. Moreover it is a duty on all those that attend on their ministry, to assist therein, Gal. vi, 6, and as people do sow, so they shall reap, Gal. vi, 7, 8. When people neglect their duties toward their ministers, such ministers must neglect their reading and studies and betake themselves to other secular employments to support themselves and families, or be worse than infidels; then such people must be great spiritual loosers in their edifications; yet when and where a church is not able to raise a comfortable maintenance for to support their minister, there it is not only lawful but the duty of such ministers to labor with their hands; for to leave such a congregation destitute, to languish without the ministry, would be very uncharitable and smell very much of filthy lucre; and to expect from a people more than they are able to pay would be oppression or extortion.

"Since my appointment as Missionary at your last annual session I have labored 120 days; preached 62 sermons; delivered 4 addresses; made 20 visits to the sick; made 60 other religious visits; held 4 prayer meetings; received 16 into the church; witnessed 25 conversions; administered the Lord's Supper 3 times; attended 2 funerals; preached 1 funeral; traveled 554 miles; distributed 1000 pages of Tracts; received on the field \$3 18.

On motion, the Association appointed Elders G. W. Murrell, J. H. Moore, and Dr. J. B. White, a committee to secure a title in the name of the Trustees—Elijah Kilday, O. B. Headrick and L. B. Ball—to the property at Stony Point, which Brother Thomas McAmes, sen., designed for the benefit of the Missionary Baptist denomination.

## MINISTERIAL SUPPORT.

The Scriptures clearly teach that the Gospel must be preached. The Minister must disseminate the word of God to the people; must feed the flock and therein should be faithful showing himsely a workman that needeth not to be ashamed, rightly dividing the word of truth. II Tim. xxvII: 28. He must administer the ordinances of Christ in the churches, and how shall he do these and his manifold other duties, unless he give his time and talents to study and preparation? Must be neglect his study and betake himself to secular employment for the support of his family, that he may not become worse than an infidel? What then must be done? Manifestly the churches should support the Ministers. This duty is plain and practicable. The law of nature requires it, "for who feedeth a flock and eateth not of the milk of the flock"-"He that ploweth, should plow in hope."-I Cor. IX, 7-11. The law of Moses demands it: "do ye not know that they which minister holy things, live of the things of the temple and they which wait at the altar are partakers of the altar?" I Cor. IX. 13. The law of the gospel enjoins it: "let him that is taught in the word communicate unto him (the minister) that teacheth in all good things-(his substance among others). Gal. VI. 6. Let us then, brethren, heed the teachings of the Scriptures, our professed rule of faith and practice. We can support our ministering brethren on their mission of love. We must do it, if we would imitate the spirit of our blessed Master. He gave Himself fou us. Let us then sustain the messengers of His gospel by our affections, our prayers, and a reasonable share of our worldly goods, even as the Lord has prospered us. R. H. DUNGAN.

6th. Resolved, That we urge all Sunday-schools within the bounds of this Association to send Delegates and full statistics to our next annual meeting with a view to re-organizing the Sunday-school Convention and its re-union with this Association.

7th. Resolved, That we tender a vote of thanks to the Clear Fork Church and community for hospitalities extended us during our session.

8th. Resolved, That in the judgment of this Association, the permanent establishment of Bristol Female College for the liberal Education of our daughters is a matter se essential to our proper denominational influence and standing, that we earnestly recommend our brethren to aid it as far as possible and further to pledge to our brethren of the Lebanon Association our hearty co-operation in endeavors to make this School a perfect success.
