# HISTORICAL/ADMINISTRATIVE INFORMATION

In the early 1980s, the Cold War between the U.S. and Soviet Union was ongoing. In January 1981, Ronald Reagan was sworn in as the 40<sup>th</sup> U.S. President, and later that year talks began with the Soviet Union over nuclear arms reductions. In March 1982, the officers of the Garrett Park Citizens Association wrote a letter to the Town Council and Mayor requesting that they place on the May 1982 town ballot the following referendum:

"The people of this town hereby declare the town of Garrett Park to be a Nuclear-Free Zone. No nuclear weapon shall be produced, transported, stored, processed, disposed of, nor used within Garrett Park. No facility, equipment, supply or substance for the production, transportation, storage, processing, disposal or use of nuclear weapons shall be allowed in Garrett Park."

Eugene McDowell, who served as Vice President, and later President, of the Citizens Association presented the letter at a Town Council meeting and explained that the purpose of the ordinance "is to publicize the concept of a nuclear-free zone, to send a message to the national leadership that the Town favors actions to reduce the threat of nuclear warfare, and to show other local jurisdictions that they can make similar gestures." A motion was passed, and the referendum was added to the May ballot. It passed overwhelmingly on May 3, 1982, making Garrett Park the first town in the U.S. to declare itself a Nuclear Free Zone.

# **SCOPE AND CONTENT**

This collection contains the personal papers, photographs, and memorabilia of Garrett Park resident, Eugene McDowell. The bulk of the collection relates to McDowell's (and others, including Ray Pinkson's) efforts to have the town designated as a Nuclear Free Zone in the

General processing procedures included arranging and organizing documents in folders, as well as disposing of duplicate materials and discarding non-archival binders, metal clips, rubber bands, and other supplies. We placed oversized documents and memorabilia in separate storage containers. Separation sheets were inserted in the original location within the folder to indicate the new locations for these items. We made preservation copies of newspaper clippings when feasible. Unless otherwise indicated, we arranged records in folders in forward chronological order.
