Dear Mama and Papa:-

I have been playing tennis some this week- the evangelist and his helpers who are running the meeting have fixed up courts and of course I could not keep away. Have had some good games. Have been working most of my spare getting our boxes fixed up. Sent one box Thursday, a box of clothing etc. and then I finished fixing up the fruit box yesterday- you should see the box and then I

think you would agree that we will not want for fruit this year. About thirty quarts of fruit, preserves, butters, besides the jellies and tomato catsup. The county fair has been going on this week but no one except Harlan and Clarence have gone. Guess it was quite a success.
