Dear Ora and Porter:

this is Sunday p. m. 2:40 o'clock. After dinner, according to my usual custom, I went to P. O. for my mail and as the same was not distracted. I went on up to the office. Have been reading some paper for awhile and will enjoy myself for a time writing to you. Mama, your card was received this morning, and I assure you it was greatly appreciated. Glad to hear you had arrived on time at Kansas City and had made the change successfully, and "had found" Porter. I was so afraid something would happen so you would miss you each other, and make the trip for both of you unpleasant. Glad you look neither just "head present book nor yourself." Sure you win luck.
