The purpose of the Council is to coordinate and promote fair housing activities across the State of Maryland and to sponsor a workshop conference once or twice a year to share ideas, encourage the formation of fair housing groups where needed, and hear experts from governmental agencies, American Friends, the National Committee Against Discrimination in Housing, etc.

The Council is not another civil rights or housing group but rather exists to make the programs of various groups more effective by stimulating cooperation and coordination where necessary. Fair housing activities will be carried out in the name of those member groups who desire to be involved in a particular activity. Therefore, any member organization which does not wish to participate in a particular activity can freely abstain from participation without the fear of being implicated by its membership in the Council.
