#### JOHN GLENN **ANTI GAY**

"... I will not advocate nor promote homosexuality."

United States Senator John Glenn, considered a front runner for the Democratic presidential nomination, has come out against protection of the civil rights of Lesbians and Gay men. In a statement given before a New York City audience, Glenn said that he was opposed to a Senate bill which would extend Title VII of the Civil Rights Act to include sexual orientation.

The following is the text of that statement:

"I firmly believe in civil liberties and social justice for all Americans and I have practiced that belief in the businesses I have operated, in my Senate office, and in the campaign. But I will not advocate or promote hornosexuality.

"Americans' beliefs about the acceptability of sexual preference or lifestyle reflect their personal values and convictions. I do not feel that it is appropriate for the federal government to extend the reach of Title VII of the Civil Rights Act to govern those questions of personal conviction.

"Title VII now covers matters of race, creed, sex, color and national origin. These are all matters of religious or genetic attributes. I do not believe it is advisable to broaden and extend Title VII into areas of personal behavior.'

Prior to that statement, Glenn's position had been somewhat tenuous, not saying that he specifically supported the legislation but

leaving that option open. He has always said that he is personally opposed to discrimination on the basis of sexual orien-

Virginia Apuzzo sent a mailgram to Glenn on November 9 expressing her "shock and dismay". "Guaranteeing the civil rights of Lesbians and Gay men," she said, "is no more 'promotion of homosexuality' than protecting the rights of believers of a particular religion is promotion of that religion. 'Deeply held

beliefs' do not exonerate people from examining their prejudices."

Tom Chorlton, executive director of the National Association of Gay and Lesbian Democratic Clubs, has worked closely with all of the presidential campaigns, and is concerned about Glenn's statements. He indicated that the Association has had contact with over a dozen Glenn campaign staffers since initial contact was made in May of

Chorlton said that he had found Glenn's staff to be "friendly and realtively cooperative," but not always well organized. Glenn's staff has, in fact, undergone ignificant morganization of the last six

It has been reported by reliable sources within our own community that sexual encounters have been taking place openly and in broad daylight in many of these places.

Sex between consenting adults can be a very beautiful thing, however, it has it's place.


**Gay Skate** FEB. 27



#### **EDDIE MURPHY'S** REMARKS — ANTI GAY

Movie and television star Eddie Murphy, the nation's hottest young comedian, is the target of a sophisticated media campaign criticizing what organizers call his "appalling" anti-gay routines. The group - The Eddie Murphy's Disease Foundation - bought ads in Rolling Stone, Billboard and Cashbox magazines to enlist support and let the star of NBC's Saturday Night Live know he can be cured of homophobia fear of homosexuality. Peter Alexander, a spokesman for the Los Angeles campaign, said the group of six young professionals formed spontaneously after the Home Box Office special Eddie Murphy: Delirious was broadcast on the cable network last year. "We just decided to do something," Alexander said, stressing that the "foundation" was not made up of gay activitists. Murphy, 22, began his career in New York clubs and became a hit on Saturday Night Live. His first two movies - 48 HRS. and Trading Places — were box-office gold mines. Last spring he signed a \$15 million deal with Paramount for five movies. During the HBO special, which was taped during a Washington performance, Murphy repeatedly refers to homosexuals as "faggots" and implies that casual contact with gays can spread AIDS, an incurable disease that destroys the immune system and has killed hundreds of homosexuals. Later in the routine, again talking about AIDS, Murphy says: "It petrifies me 'cause girls be hanging out with 'em (homosexuals)," implying women could pick up the disease and later spread it to heterosexuals.



#### MISS GOV. CLEARED

JURY DROPS CHARGE. A Hinds County grand jury has dismissed a murder charge against one of three male prostitutes who once claimed to have had nomosexual relations with Mississippi Gov. Bill Allain. Donald Ray Johnson, 22, of Jackson and the other two men since have denied they were involved with Allain, saying they lied in exchange for money. Johnson's share: \$1,400. He was arrested Jan. 6 in the stabbing death of Richard Simon Walker, 38, also of Jackson. A second man arrested in the case, Kenneth Dale Hughes, 17, of Jackson, has been indicted.

paign indicating disappointment with Glenn's "limited response" to the Gay issue.

Nonetheless, ChorIton is not totally pessimistic: "In my judgement, John Glenn is not a homophobe. Glenn is, however, grossly misinformed on our issue despite the best efforts of many. Glenn clearly views our issue as a question of lifestyle, preference, behavior. Based upon that view, he believes that the Gay rights bill is inappropriate. Several other candidates were at that same spot not so long ago. Glenn also moves at a glacial pace."

Although it is uncertain just how much Lesbian and Gay support Glenn actually has, it appears he has little organized support to Iose. Most partisan political groups in the Gay and Lesbian community has been gravitating to Senator Alan Cranston and former Vice President Walter Mondale.

Nonetheless, several prominent supporters of Gay rights support Glenn, including Ohio Governor Richard Celeste and Massachusetts Senator Paul Tsongas. Tsongas introduced the bill which Glenn now opposes.

Of the Presidential contenders besides Cranston and Mondale, Senator Ernest Hollings (D-SC), Jesse Jackson and George McGovern are on record in support of Gay rights. Senator Gary Hart (D-CO) has not endorsed the Senate bill, but says he would vote for it were it to come to that. Former Florida governor Reuben Askew has, in the past, opposed Gay rights but has said he is re-



It's twenty miles to our motel near Disney and it's almost two a.m." (to the side out of Jim's hearing......one of the three is heard to say, "See, I told you. Late at night you can always spot the one who's got no way to get home." "Hot Damn! Let's get outta here before somebody else grabs him."

## Gay "widow" wins \$25,000 judgement

CALIFORNIA — A homosexual was given \$25,000 in taxpayers' money because he lost his sole means of support when his gay lover committed suicide.

Legal experts said the decision by the California Workers' Compensation Appeals Board was the first of its kind in the nation.

In a hearing held in Los Angeles Earl H. Donovan claimed that he depended entirely for support on his homosexual lover, Thomas P. Finnerty Jr.

Donovan said he and Finnerty had lived together from 1949 until job-related stress led to Finnerty's suicide in 1976.

After Finnerty's death Donovan filed a claim for benefits under the state workers' compensation law.

In 1978 a hearing judge ruled against Donovan's claim, ruling that a homosexual lover fails to qualify as a "good-faith" dependent who would be eligible for benefits under the state law.

But Donovan appealed the ruling and won when the Workers' Compensation Appeals Board decided homosexual couples must be granted the same rights as unmarried heterosexual couples.

The board based its decision on a California Supreme Court ruling in the palimony case filed by Michele Triola Marvin against the actor Lee Marvin.

California courts do not allow unmarried lovers, either heterosexual or homosexual, to automatically inherit from deceased partners who leave no will.

But worker compensation cases are concerned with the question of dependency rather than legal inheritance rights.

The appeals board found that since Donovan was Finnerty's primary dependent, he was entitled to the award.

#### Legislator wants to bar high AIDS risks blood donation through Florida law!

TALLAHASSEE — People with a high risk of having AIDS should be barred from donating blood in Florida, a state legislator has said.

"My reason is not to discriminate against anybody or any groups," said Rep. Tom Woodruff, R-St. Petersburg. "It's simply to keep innocent people who need blood from getting a deadly disease."

AIDS, acquired immune deficiency syndrome, is often a fatal disease believed to spread through body fluids in sexual contact, intravenous injections and blood transfusions.

Woodruff's bill, which has been filed, singled out homosexuals, Haitians and drug abusers.


As of Jan. 16, 215 AIDS cases had been reported in Florida, according to the U.S. Public Health Service. Florida trails New York and California in the number of reported cases, the agency said.

Woodruff said passage of his legislation is necessary to avoid playing "Russian roulette every time you receive blood." The 1984 Legislature convenes April 3.

The measure would require blood donors to sign sworn statements indicating they are not in a high-risk category for AIDS before they could donate blood.

Under the bill, lying in the sworn statement would be punishable by up to a year in jail.

ALL-AMERICAN BOYS

I've known that I was gay since I was thirteen. Does that surprise you? It didn't me.

According to one of the lousy books I read back then, I'm supposed to tell you it came as some sort of huge shock. Actually, it was the most natural thing in the world. I thought everyone was. At least until I hit high school the next year. That's when I finally realized all those faggot and dyke stories referred to people like me. . . . So hearing All American Power the story of a

So begins All-American Boys, the story of a teenage love affair that should have been



simple — but wasn't. In language that is remarkably clear, yet strong, Frank Mosca tells the story of Neil Meislich, a cheerful but highly closeted high school student. Although he has begun to come to terms with his gayness on a personal level, Neil is completely isolated from anyone else who is gay until Paul Carrington moves into town. Soon Paul helps Neil break out of his isolation — perhaps a bit faster than the town is ready for.

The two, Neil and Paul, go thru the terror, with the "secret" out, of facing their peers, several of which band together to let the "faggots" know just what the feelings of the group are.

Neil and Paul go through the uncertainty of telling the truth to their parents and the reality of much of today's world.

All-American Boys is especially important because it is one of the few books around that provides gay teenagers with unequivocably positive role models. It will also be enjoyed by many adults who would like to relive their teen years through the eyes of someone who's doing it a bit more openly than they ever dreamed possible.

This book is a large type, easy to read book which shows compassion and the awakenings of a teen. A good book.

#### Are They Arresting Legally OR Just Trying To Look Good?


Just recently, a member of the legal profession stated that many of the recent arrrests have been on very shakey grounds.

"The officers and courts know that most of the people arrested will plead 'guilty' rather than to open themselves to exposure, ridicule, job loss, etc. More of the people who have been arrested are beginning to fight, however, most still plead guilty."

"The unfair practices used to arrest people are a scare tactic to keep people away from these areas and harassment is prominent," stated another


