A CONVERSATION WITH MABEL BUTLER The County Commissioner with Class & Brass

I called Mabel Butler's office and requested an appointment for the opportunity to interview her. Her Aide, Count Barnes, asked how much time I would need and I replied about one half hour. When I arrived and was seated in Mrs. Butler's office, I was immediately and totally charmed by a woman who is filled with laughter and personality, knowledgeable about her position and aware of the needs of her constituents. She is full of life and filled with living.

The woman casts a spell of charm for l looked at my watch and saw that two hours had passed and suddenly I had to apologize for exceeding my time allotment only to be told that she had allowed more time than requested. And we continue a few minutes more.

Before the interview was done, the skies were cracked open with thunder and lightening and heavy rain was washing across the glass roof and windows of the County Commissioner Building. She asked if I had an umbrella and I admitted I left it in my car some four blocks away because the sky seemed clear. "I'll just get wet," I said but she was not to allow that. When the interview was done, she located an umbrella for me which got me to my car dry and I was able to return the loan.

That consideration is a reflection of the consideration she has for her people - the citizens of Orange County.

C-Fold: Throughout history, your race has been subjected to segregation and denial of rights. It is claimed today that we now have integration of the races and yet, if we are to be honest, we must admit that what we really have is but token integration. How do you relate to that?

Butler: That is true. While the black folks marched and died for the civil rights, on checking the records you find more of the white females utilized the civil rights more than anyone else. A second group is white males because they are placing blame on reverse discrimination. When one

group benefits, all benefit. Whatever rights gays fight for, we benefit.

C-Fold: So your efforts helped other minorities?

Butler: We didn't 'help', but others realized the power that was there. I have long maintained women are not a minority, because, if nothing else, they have had Pillow Power.

I call myself a People Person, but I'm called many things: The Black Commissioner, "Riverboat

Annie Lady" because I'm not afraid to cuss. And I answer to all the names I'm called.

Life has been good to me. I've raised a family of five; I've buried a mother, a brother. I buried a son and a husband. My husband and I lived until "death do us part," and I have no regrets; because I loved all of them to death. Every day I'm blessed and every morning I waken and say, "help me do something for else somebody."

My needs are so little. My wants aren't worth a damn: I want a man that's 55 or older who can feed himself and walk. But I don't want a husband. I have a good time out there looking for that man who can feed himself

and walk, and all my friends are out there looking for me, too. They ask me it makes any difference what color and I said, "No. Not as long as he can feed himself and walk and is over 55."

C-Fold: When did you decide you wanted to get into elective politics?

Butler: I didn't decide. I've always been active. The only way I could open the door for my people was to go in the back door and open the front door. So I got involved in coordinating campaigns, working hard in campaigns. I had been a

social worker so I enjoyed recognition. I was never paid.

C-Fold: You just started at precinct level. Butler: That's right. And people would come to me and say they wanted to run. So I asked if they ran would they hire blacks, would they work to change so and so - that we need this or that in the community. You know, I got some promises. Most times, if they didn't come through, they didn't win anymore. It was a wheel and deal kind of situation.

I could stand on my soapbox in the

community because I'm so sure in my profession and I took that mentality to the city and to the people because cities are more than brick and mortar: Cities are people.

Whites are trained with college with and experience of working with candidates to learn the ins and outs of politics. So they go into the field with training - we go with

In the state

commissioners who are black, and Bob Graham appointed 18 of them when he was governor. Some of them have maintained their seat and others, while no longer in office, those seats have remained filled by blacks. In the entire state of Florida, there is only one black Supervisor of elections and that's in St. Lucie County. Most of the counties do not have

of Florida there are 67 counties. In those 67 counties there are 367 county commissioners. But there are only 23 blacks to run for office but it is not because the

come in and make an appearance. When I walk in, you know I'm there. That's the way I live.

blacks won't run. Until I ran, there had never been a black run for county commissioner in Orange County.

C-Fold: We need to stop being race and ethnic specific when we speak of candidates.

Butler: We need to stop labeling people. We need to support the person and not the party. I have been a democrat all my life and have given the democratic party my sweat and my tears and my money. But I look at the person, the candidate, not the party because the party is only a label.

C-Fold: You have made major inroads into the complacency of the black people. How do you encourage and hearten the black community to participate in their government?

Butler: I run all the time. Every candidate out there is selling himself to the voters and I do that every day. There isn't any purpose of my coming up here every day if I am not serving the people. So I have to go to the community and educate them on the issues. I reach out to them and have them articulate their concerns and their concerns. I tell them they sent me because they say they don't have

C-Fold: Did you encounter any advice to "get along" with the existing powers?

Butler: No. I don't go along to get along. There are people who can walk into a room and you know they are there. There are those who have to

Now, I can disagree with you and I will fight you. But I can fight and love at the same time - I'm real good at

that. Many people will dislike you if they disagree with you on an issue. But that has nothing to do with liking or living someone.

I don't think I have met anyone I don't like. Now, there's a lot of folks that my vibes don't jive with, but I don't dislike them. There are people whose vibes are evil - I don't want those kind of vibes. I don't look at ugly things on television or go to ugly movies. I like movies like "Driving Miss Daisy." I deal in problems every day - people's problems. I don't need fictional problems.

I've had the riches of life - like loving and caring and fighting like hell for what I believe in. And like helping people. You can't help one person without helping someone else at the same time.

Nobody does anything by themselves. There's a board of seven people up here that I try to sensitize every Tuesday. I try to make this board to change their plantation mentality, their yesterday mentality or sometimes their no thinking mentality. The area that I inherited in 1990 is, I feel, a neglected area. And I remind the board all the time, Urbia and Suburbia go together. Not enough walls tall enough around suburbia to keep urbia out.

We must protect urbia right along with suburbia.

People don't make slums - government makes slums, neglect makes slums, . I talk about this all the time with the Board. The things I have to say may not be what they want to hear - but I don't lie to them either. I believe this board is a better board

because of the sensitivity I bring to it. But all of us on the board know that's what we are here for.

It's been a challenge. I've been here two years in November and I tell them - they ride through these areas, I live in them. I feel the hurt - I hear the pain.

We have a chairman who is very sensitive to some of the issues that are brought forth.


C-Fold: A tactic often employed to disenfranchise groups is to keep them divided within their own ranks. There is a division in the younger blacks today that is reflected in their "gangs." Is this a result of "limited" integration where full opportunity is denied, is this an effort to maintain a division by in-power politicians.

Butler: You have to go back to yesterday to realize the plantation bosses did a hell of a job on the minds of people; black, poor Hispanic, Puerto Ricans. Unlike Haiti which was a was a plantation with one master, we had plantations with lots of masters. They instilled in the people that the house was better than the yard and the yard was better than the field. But none of them got a damn thing because they all were slaves under the master and that's how the master controlled the house, the yard and the field.

Now slavery was long ago, the mindset is still here in some. And we know the only way we can change that mindset is through education. Some were hungry for learning; Booker T., George Washington Carver educated himself because of this thirst for education.

As black people, we have learned that we will change this mindset by educating our boys and

featured among the Rollins' College Music In the Chapel Series, performing Brahms' "Alto Rhapsody, Op. 53." The event marks the Chorus' first public appearance at a non-gay event. There is much pride in OGC as

a musical entity, regardless of the sexual orientation of its members or the political correctness such a selection connotes.

The Rhapsody for alto, male chorus, and orchestra is a setting of Goethe's poem "Harzreise in Winter," which describes the bleak mountain journey of a solitary wanderer, searching to find himself; the piece also seems to express Brahms' own existence as one drawn toward a selfchosen solitary life, proving to be one of his most romantic and deeply personal works. The Alto Rhapsody is perhaps the nearest thing by Brahms to the Classical concert aria, as well as one of the high points of Brahms' choral works.

Dr. Charles Callahan is the Composer-in-residence at Rollins' College, as well as its Director of Chapel Music. Director of the Orlando Gay Chorus as well, Dr. Callahan chose the Orlando Chorus because he felt its sound to be welladapted to the musical demands this piece requires. (Also, one cannot

Who needs a will?

have a will. A will is one of the devices used to insure that the people you want to receive your property upon your death, will receive it.

What would happen to my property if I don't have a will?

Without a will or other device, state law determines who receives your property upon death. State law provides that your next of kin will receive your property. If that is not what you want, making a will is

Funeral A: wishes should be contained in your will. If possible, you should also let your next of kin

know of your desires so that no surprises occur at the time when family members can least cope with them.


Where should I keep my will? Who needs to know where it is?

Your will should be kept in a safe place, such as a safety deposit box. Some people elect to have an attorney hold the original will in a safety deposit box maintained for that purpose. The will can be obtained from the attorney upon request. The personal representative, the person or persons who will administer the estate, must know where the will is located and have

How can I protect those whom I want to receive my property from estate taxes?

A: There are techniques that can be used to reduce estate taxes upon death. Those methods require the services of an attorney. Generally speaking, if your gross estate is less than \$600,000 and you are a Florida resident, there will be no Federal or Florida tax involvement. Florida has no inheritance tax and in essence has no estate tax. You can designate in your will which persons will bear the burden of estate taxes and costs of administration of your estate. The other persons named in the will can then receive your property free of those expenses.

What is a living will?



A living will is a declaration containing your desires as to what medical treatment is to be provided to you in the event you are suffering from a terminal condition from which physician vour determined there will be no recovery and from

making medical decisions for yourself as long as you are able to do so. You may also designate another person to make the medical decisions for you under certain

Is it expensive to have a will prepared?

The cost of preparation of a simple will is small, often \$150 or less. Most attorneys prepare simple wills as an accommodation to their clients. Of course, complex and involved wills and trusts are more expensive. It is essential that a qualified attorney prepare your will or other estate plan documents. It is also important to have an attorney prepare papers concerning joint ownership of real property because expertise is needed when dealing with mortgage lenders in particular

Do I include in a will my car, clothes, jewelry, furniture, bank accounts and other personal property? Sure. There are also other methods that can be

used to be certain that your property is received by the proper persons, such as creation of a trust or joint ownership of property.

What about insurance policies, military or Q: company benefits.

Life insurance policy death benefits will be paid directly to the beneficiary named in the policy. IRA plans usually allow you to choose beneficiaries in the event of death. These types of benefits pass directly to named beneficiaries outside the provisions of your will and probate process. If your estate is your named beneficiary, the property will be paid to your estate and will be distributed pursuant to the terms of your will.



C-Fold: I often write of this ability of the gays to stay in the closet

as opposed to blacks who cannot hide. It is this failure to stand up for ourselves, and the internal prejudice within our community that keeps us divided and weak and unable to enjoy a strong political voice.

Butler: I have another radical friend: Alfredo Garcia Martinez. My son had AIDS and Alfredo would come to my home and spend time with my son.

Alfredo would come to the house and lay on the floor with Wayne and talk to him and that would calm him. When a crisis came up I always knew who to call. AIDS organizations work 9 to 5 but my crisis would come at four o'clock in the morning.

But Alfredo could help just by being there. He could tell Wayne, "Just admit you've got AIDS." Alfredo could say that to him - mama couldn't say that to him, not loving him the way I did. Alfredo would tell him he was going through stages. "You go through the denial, the embarrassment - through different stages."

Alfredo came to me and asked how he could reach the black community in dealing with AIDS. I told him we were having an NAACP meeting that night and that I would introduce him if he would come along. He wanted to get involved with the Black community because nobody else was doing anything about it. He wanted to tell our people that AIDS was passed through sharing sex and sharing needles. So I was able to get him a few opportunities to speak at clubs and churches and a couple of sororities.

I didn't know about my son having AIDS. My husband had taken

Wayne to see about his eyes - to get glasses. When he returned home, my husband said the doctor said my son was loosing the sight of one eye. Then my son told us he had another doctor who might put him in the hospital and save his eye.

He took many tests while in the hospital and he had to sign papers that we were unaware of, papers advised him there was the possibility of serious complications due to his health. We did not yet know he had AIDS.

Whenever I didn't give him the AZT he acted normal.

C-Fold: You and I crossed paths once before. In 1991 both of us read names of AIDS victims at Lake Eola. You were immediately in front of me and we only exchanged hellos.

Butler: That was a very solemn occasion. They invited me that time because I had just lost a son. But I've lost so many friends, and friends of my son.

THE HUMAN RIGHTS CAMPAIGN FUND BLASTS REP. DANA ROHRABACHER'S ATTEMPT TO INTIMIDATE PRIVATE COMPANIES OPPOSING DISCRIMINATION AGAINST GAYS

WASHINGTON, DC Tim McFeeley, Executive Director of the Human Rights Campaign Fund-the largest national lesbian and gay political organization, today condemned Rep. Dana Rohrabacher (R-CA) for his recent attempt to their bans on funding thr Boy Scouts of America.

The Boy Scouts of America currently

a policy enforces of discrimination against gay and lesbian Americans. Because of the refusal of the leadership of the organization to change this policy, corporations such

as Levi Strauss, Wells Fargo Bank and the Bank of America are withholding funding for the Boy Scouts of America.

Rep. Rohrabacher Monday in a recent letter to Levi Strauss and Company expressed his outrage to their boycott claiming that "if <their> interference is successful it could

well kill Scouting in America." He is currently seeking others in the House and Senate to cosponsor his appeal.

"This action reeks of hypocrisy and demagoguery, stated McFeeely. "Rohrabacher and the Republican Party make claims to represent a history of personal freedom over governmental intervention and then attempt to dictate morality not only in our bedrooms, but

now in our boardrooms as well. How can they justify this?"

Boy Scouts of America is only national youth organization that discriminates against gay and lesbian Americans as leaders and members. The Girl Scouts, Big Brothers and Big Sisters and the National 4-H do not discriminate.

"Americans support the traditional values of tolerance and discrimination," oppose "CAPITOL BEAT"

stated McFeeely. "The Boy Scouts stand against these traditional American values. What message are they

teaching our youth? Activities that support lesbian and gay youth support family values

> because they encourage these youth to remain healthy, in school and at home."

> McFeeely also noted that Rep. Rohrabacher voted against the Family Leave Act, which would require private

companies to grant leave to employees who need extended time to care for children and other family members. "Mr. Rohrabacher wants to tell private corportations where to contribute their money, but does not want to tell them to help their employees take care of family members,' McFeeely said.



to the polls and vote for other candidates so they are counted as a voter who leaves the presidential slot empty.



LESLIE KILLE: Red Sky In Morning!

Leslie Kille's older sister was forever getting into a piano was the proposed remedy. Unfortunately, Leslie's sister never learned to play the darned thing. At the age of four, Leslie Kille sat down at the piano and began practicing her sister's rehearsal material. Nine years later, Ms. Kille was a church organist, rehearsing an original band, late in the evenings. Today, Leslie can be heard on the airwaves of the Tampa Bay area, or on-stage at the Lighted Tree, a cozy, little neighborhood bar located on Pass-a-Grille beach, just South of St. Petersburg.

Her debut recording Storm, released a year ago, sports an odd title for an album filled with such peaceful, easy music. It is an album whose lyrics are brimming with recurring images of recovery and rebirth. The title cut represents the inner turmoil brought about by the glory of Love: "And I'll find you through the storm/ That seems to happen whenever I'm in your arms." The music carries you safely onward, as if aboard some sturdy vessel traveling all too rocky seas. Much of the album's compositions touch upon such support and guidance offered by a friend or loved one during a personal crisis.

Leslie's music very obviously reflects ber moonlighting career as a therapist for Professional Psychiatric Services in Clearwater, where she specializes in victims of physical and sexual abuse. Surprisingly, it's also great music! "Music is my life," she told me. "It is a vehicle to express the frustration and angst I feel as a tberapist."

Pain is a global issue. Ms. Kille focuses not on the pain and suffering (as far too many artists do), but rather on one's ability to cope, the how and wby of it all. "Choosing a Way" is a song borne of Leslie's own experience as a childbood victim of abuse: "Choosing a

way to go one step beyond/ All that I know and can feel/ Finding that step to risk what is known/ Praying I won't lose belief." In many ways, Leslie's songs are "poetic ways of recovering."

Leslie's debut recording is likely to be found in the Easy Listening section of your local music store, although it's terribly difficult to categorize ber as such. Her songs frequently border on Jazz, occasionally leaning toward pop. At best, her music is not intrusive; her melodies are infectiously humble and make for an excellent diversion from the common workaday. For instance, the title cut unfolds gently and dependably, reminiscent of Chris Williamson. "All I Want is More" demands a solid jazz treatment by the likes of Harry Connick, Jr.; the song swings as is but just screams for a severe brass accompaniment. "Hear Me Now" resembles Alternative or House Music, the likes of which Natalie Merchant of 10,000 Maniacs would probably enjoy (as

Of course, what else would you expect from someone who describes inspiration from Sara Vaughn, Patti Austin and Basia. "I appreciate the purity of the Indigo Girls and the guts of Mellisa Etheridge." Still, Leslie considers herself and ber unique brand of music more along a classical vein. (A particular fondness for Bach can be heard on "The Harpist".)

Ms. Kille is quick to point out one of the more alluring aspects of Tampa Bay: "You don't have to sell out. In the Bay area, you don't bave to write pop rock or guide lyrics in order to be people-pleasing." Leslie bas never felt the unnecessary pressure to perform pop music in order to entertain an audience; nor does she feel compelled to hide ber lesbianism, altbough she doesn't wear her sexuality on ber sleeve, like some heterosexuals

"I'm a woman first, a singer second, and a lesbian third. I don't introduce myself as, 'Hi. I'm Leslie Kille. I'm a lesbian.''

Leslie lives with her lover, Candy. "I've been this way since I was young, whatever 'this way' means." She is "out" at work, both as performer and therapist. If a gay or lesbian should walk through the doors of Professional Psychiatrist Services, Leslie feels there is a specialist on the grounds familiar with his or her particular needs.

Leslie's strength and security in her chosen lifestyle can be heard throughout Storm. The album includes an extremely touching love song which quietly shares ber own sense of pride as a gay woman, as well as the importance of expressing such. HUMAN RIGHTS CAMPAIGN FUND CALLS BUSH-QUAYLE RECORD ON AIDS "A LEGACY OF LIES"

WASHINGTON, DC (September 8, 1992) The Human Rights Campaign Fund, the nation's largest lesbian and gay political organization, today charged that the Bush Administration's response to the AIDS epidemic has been "a legacy of lies." Appearing at a Capitol Hill press conference coordinated by "AIDS WATCH "92", Tim McFeeley, executive director of the Campaign Fund, released a fact sheet analyzing the Bush-Quayle record of distortions on AIDS.

"President Bush repeatedly misleads American public and the Congress on the issue of AIDS," McFelley stated. "His distortions on spending have had a serious impact on the willingness of Congress to appropriate needed resources for AIDS research and the American public's understanding of how much needed research is not being done because of a failure in leadership. While hundreds of thousands of American families live with the reality of AIDS, the Bush-Quayle record is one of distortion, diversion and denial."

McFeeley cited the President's repeated statements that his Administration is "doing all that can be done" to find a cure

> for AIDS. "Four years ago, George Bush promised to implement recommendations of the National Commission on AIDS. Once in office, however, he failed to live up to his promise. Instead, he pits one disease against another, denies funds to research initiatives, and grossly distorts his own failure to lead" McFeeley noted the recent report by the Commission in which

they called the Administration's response to AIDS "tragically insignificant."

"Many members of Congress, along with the American people, believe George Bush when he repeatedly claims that the government is spending '\$4.3 billion on research and prevention this year,'" McFeeley said. "In fact, only \$841 million is budgeted for AIDS research this year at the National Institutes for Health, less than half that spent on cancer





A Department of Health & Human Services Report on Youth Suicide, has found that lesbian and gay youth are two to three times more likely to commit suicide. Ostracism from group activities such as the Boy Scouts is exactly what encourages these youth to attempt suicide.

Many local United Way Chapters and school districts are reviewing the Boy Scouts of America's position of discrimination. The Bay Area United Way has begun withholding funds from the



Boy Scouts until they change their policy Several area school districts have banned the Scouts from meeting on district properties.

This is not a religious or partisan issue. Republican Governor William Weld (MA) has created a state commission for lesbian and gay youth. School districts from around the country have also created programs to address the particular needs of lesbian and gay youth. Many religious organizations oppose the discrimination by the Boy Scouts including the Presbyterian Church (USA) and the Union of American Hebrew Congregations.

"We are proud of Corporations such as Levi Strauss for standing up for the traditional fairness American values of equality," exclaimed McFeeely. "Organizations which promote bigotry and prejudice have no place in America. We encourage Levi Strauss to stand up against these bigoted attacks. The majority of Americans is on your side. " V

research. Only \$480 million is spent on AIDS prevention at the Centers for Disease Control."

McFeeley explained that Bush Administration's claim of billions of dollars in AIDS expenditures is created through a process of "cooking the books." "George Bush creates the impression of billions of dollars in AIDS spending by including the funding levels for entitlement spending on AIDS care, spending for programs such as veteran's benefits, Medicare and Medicaid. This funding is not included in the totals for any other disease. It is not AIDS research and prevention spending. It is a ruse to mislead Congress and the public, a blatant deception that has cost American lives."

The Campaign Fund cited government budget figures showing that entitlement spending has been the only AIDS spending to increase significantly during the Bush Administration. "Entitlement spending makes up over 60 percent of George Bush's \$4.3 billion," McFeeley said.

Although AIDS makes up only a small portion of the Nation's total entitlement bill, spending for AIDS under entitlement programs is skyrocketing. "This is the legacy of Regan, Bush and Quayle," McFeeley charged. "Hundreds of thousands of poor Americans have been infected with HIV during the last twelve years, while our leaders have distorted their records and denied the funds needed for research for effective treatments and a cure."

McFeely called on the Senate to support full funding of the NIH 1993 budget request for AIDS research. He noted that more than 20,000 members of the Campaign Fund from around the nation would be contacting members of the Senate this week, through the Campaign Fund's Speak Out program, to encourage the Senate to increase funding levels for AIDS research.

"We do not believe that the AIDS community has asked for more than is appropriate to respond to an infectious killer disease. We question the motives of those who 'cook the books' to inflate the federal research and prevention budget, and we strongly object to the Bush notion that it is appropriate to pit one

disease group against another, "McFeeley stated. "The truth is that all diseases require a larger investment in research and prevention, as well as an equitable system of health care delivery." ∇




