Much of the entertainment on and around the main stage left a lot to be desired. I heard about Lea Delaria's comments about sleeping with the President's wife, and about women doffing their clothing and dancing from a straight friend -someone who cared enough about me and my lifestyle to tune in to CNN and watch the march coverage. I was mortified by what she told me.

Let me explain, I think Lea Delaria is hilarious. I also love to expose my nude body to the sun now and then. But there is a time and place for everything. I wouldn't have wanted to introduce my mother to my lifestyle by taking her to a Lea Delaria concert in the nude. And I don't think straight America got a very good first impression of our movement from the March on Washington.


We all use common sense in our everyday lives to moderate our behavior. Just as we wouldn't wear a bikini, high tops, and a "DYKE" button on our T-shirt during a job interview, certain situations demand certain forms of behavior. Unfortunately, in our zeal to display our cultural diversity, we failed in the basic tenets of manners and decency, of which our community has a wealth. But you could not tell that from the march coverage.

When the people of color marched in the 1960's for their civil rights, they didn't do it beating drums and wearing daishikis. They dressed and acted like everyone else, and supported leaders in their movement to state their case with


NATIONAL LESBIAN AND BI WOMEN'S HEALTH SURVEY

The Lesbian Health Project of los Angeles announces the launch of a National Lesbian and Bi women's Health Survey to help assess if Lesbians are at increases risk for cancer. Co-sponsored by Lesbian health organizations and Feminist Health projects around the country. the survey is being distributed to between 100,000 and 300,000 Lesbians and Bisexual women at the National March on Washington and at pride marches nationally. It will be the largest Lesbian and Bi women's health survey ever conducted.

"We hope to get a clearer understanding of Lesbians' true risks for cancers and other health concerns," says Suzann Gage, RNCNP, OB/ GYN nurse practitioner, director of the Lesbian Health Project of Los

Angeles and coordinator of the National Lesbian and Bi Women's Health Survey "We have very little health data on Lesbians: Women's health surveys never include questions about sexual orientation to see if Lesbians as a group, like other sub groups of women, may indeed be at greater risk for cancers and other major health concerns." Lesbian health activists for years have speculated that Lesbians may indeed be at increased risk for cancers and other health concerns. We hope this study will help shed more light on actual rates of breast cancer in Lesbians, as well as important directions in Lesbian health education, prevention and empowerment. We also hope it will reinforce what we already know to be a profound need for funding of Lesbian health care and research." Individuals and



dignity. We in the gay rights movement have to do the same. We have only recently gotten media attention and coverage because we'd cleaned up our image. Prominent people started coming out of the closet. We need to follow and support our leaders, rather than screaming for consensus and cultural diversity to the point that exhibitionists on roller skates are representing our movement. I'm kidding, or course, but we need to think about the way we represent ourselves, and the repercussions that could result.

Yes, the dykes and queens started Stonewall. And in so many years our movement went nowhere. It's up to us to lead the defense of our basic civil rights as the everyday, normal American citizens we are. Let's wake up, lesbian and gay America, and think before we act like a bunch of lunatics.

Our own Orlando Pride Parade is coming in June. With David Caton and the American Family Association lurking with civil rights exclusions for lesbians and gays, we need to be careful. Let's get our rights first, let's protect ourselves before we become further objects of hatred, ridicule, and violence.

Please come out to the Orlando Regional Pride Parade on June 26, 1993. If you are having a hard time deciding what to wear, purchase a "By Design -- A Family of "riends" T-shirt. Wear a "DYKE" button if you wish. But please, leave the clothes on, keep the buns covered, and act as if your mother was watching. The civil rights you save may be your own.

STATE AND LOCAL NEWS

LOCAL GROUP FORMS TO FIGHT DISCRIMINATION

Orlando, Florida.

A local group group, tentatively named Floridians Unified Against Discrimination, Central Florida chapter, has organized to fight discrimination. encompassing Orange, Seminole, Brevard, and Osceola counties, the chapter held a planning meeting on Saturday, May 15, 1993.

The current focus is on the amendment proposed by David Caton, American Family Association., as well as a similar proposal by Andrew Martin, Christian Action Council, who is also a gubernatorial candidate. Caton's amendment reads as follows:

1. Article I, section 2 of the Constitution of the State of Florida is hereby amended by: a) inserting "(a)" before the first word thereof and, b) adding a new subsection "(b)" at the end thereof to read: "(b) Neither the state, nor its political subdivisions, shall enact or adopt any law regarding discrimination which creates, establishes or recognizes any right, privilege or protection for any person based upon any status or alleged trait other than race, color, religion, gender, natural origin, age, handicap or marital status." 2. All laws previously enacted which are inconsistent with this provision are hereby repealed to the extent of such inconsistency. 3. This amendment shall take effect on the date it is approved by the electorate.

The effects of this amendment, if passed, would be to legalize discrimination in employment, housing, restaurants, and public accommodations for reasons not relevant to job performance or ability, thereby allowing no legal recourse for discrimination on the basis of sexual orientation -- homosexual or heterosexual.

Committees are currently being formed in the areas of fundraising, communications, and planning. A.P.O. 





History of the Lambda

The lambda is the Greek "L" for liberation. Originally, it was a pictographic symbol for the scales of justice and, in time, it began to represent

the concept of balance. Spartan soldiers painted the lambda on their battle shields as a symbol of their unity and as a representation of the delicate balance they believed must exist between the demands of the state and the freedom of the individual. Romans borrowed the lambda from the Greeks, using it as a symbol for "lampas" the Roman word for torch.

In 1970, without knowing of the historical significance of the letter, the Gay Activists Alliance of New York designated the orange lambda on a blue field as a symbol of gay liberation. In December, 1974, the lambda was adopted as the international symbol for gay and lesbian rights by the International Gay Rights Congress meeting in Edinburgh, Scotland. Display it with pride, and shed a little light on the darkness of bigotry.


