# Warning! A Dead Battery on I-4 Could Get You Arrested!

that a nervous glance at the clock in the dashboard, he was uncomfortable with the late hour. Thinking there never seems to be enough time, he had hoped to be home before midnight and here it was after 2 and he still had a distance to travel.

So often when something goes wrong with the car, one drives faster as if hoping to outdistance the problem, hoping to arrive at a destination before the engine stops. But it is a race that is lost – it is as futile as escaping one's own shadow. The headlights were becoming dimmer and dimmer and he had opened the windows to turn off the air conditioning and turned off the radio – anything to reserve the battery power.

Just ahead a glow in the misty morning air gave comfort in the knowledge that a reststop would offer a refuge from the fear of being stranded in the blackness on the interstate. Pulling off to the exit, he brought his car to a stop as near the building as possible and cut off the ignition.

"What to do," he thought. "Just what in the hell am I going to do at 2:35 in the morning with a car that has a problem with the battery or the alternator – or who knows what. Who can I call at this hour to come pick me up and besides, I can't just abandon my car." And so he decided to call no one; he decided to catch some sleep in the car and call one of his friends after dawn hoping to catch someone before they left for work.

He hadn't been there too long and was dozing off when a sharp tap on the window startled him awake. He saw a young man gesturing for him to lower the window so he opened it an inch or so. The man asked him what he was looking for and he replied that he was having car trouble and was waiting only for daylight.

"Don't give me that shit, man," the newcomer said.

"You're here lookin' for kicks. Open the door and you can drive us over there away from the building. We'll have fun, you an' me."

"I'm here 'cause I'm having car trouble," he responded and reached to close the window, but the young man put his finger in the window opening.

"Hey, man. You got any stuff? Ya know, something to make a guy feel good. Lemme get in and we'll do some, and then we'll have fun and feel good. What's a long night for anyway?"

He opened the window to speak, to tell them he was having car trouble. One of the officers reached in and unlocked the door and opening the door ordered him to step outside. ### Planning Starts for March on Wash'

rganizers of a massive march on the nation's capitol to fight homophobia are set to launch a major fund-raising campaign and open up a national office in Washington, D.

The Executive Committee for the "1993 March on Washington for Lesbian, Gay and Bi Equal Rights and Liberation" held its first meeting in Washington, D.C., on Feb. 15 and 16 to lay the groundwork for a national fund-raising strategy.

The march, which is scheduled for Sunday, April 25, 1993, is the third of its kind. The first, held in 1979, was

followed by a record-breaking march in 1987 that drew over half a million participants.

Organizers estimate the upcoming march and rally will cost \$500,000

"Fund raising is a primary focus right now," said Billy Hileman, the march's treasurer. "We are tapping major donors, gathering support from national organizations, and we want to generate a lot of grassroots financial support."

The committee also established a volunteer support committee in Washington to begin preparations for a national

Hope and Help continues to sponsor and receive fund-raising activities. On April 1, the Parliament House sponsored its annual Employee Turnabout Night. Star Trek VI was presented April 30 at the Park II Theatre on Lee Road at 17-92.

Chuck Hummer said he realized that not everyone could afford tickets to a dinner theatre but hoped that almost everyone could afford \$5 for a movie. If attendance warrants, future movie benefits will be scheduled. daughters.

Every segment of society suffers depraved and perverted members; our gay community suffers from the diabolic Jeffrey Daumer while the straight world witnessed the evil of Ted Bumby. Neither of these men represent the hetero and homosexual societies, but simply illustrate the monstrous depravity of these two men.

The indifference that we witness by an apathetic public over entrapment of gays or set-up sting operation is a result of this image many people have of our gay community. The general public is unaware of just who we are and subconsciously defines us by the stereotypical and tired Hollywood version of a gay. After all, we are so omnipresent and the straight world doesn't have any idea who we are because so many of us are hidden.

It is this silence and this invisibility that is the seed of our suffering the many injustices heaped upon us. It is the willingness of the general public to believe that we stalk the land looking for innocent victims to satisfy a lust. This misconception empowers law enforcement agencies to violate our freedoms and our rights because there is not a substantial voice raised in our defense – not even our own. Too may of us feel the image problem of the gay community is not our personal concern. Some will say

that radical factions of the gay

community currently making headlines are expressing gay concerns but in truth, these activities only precipitate the reaction: "I told you so, hysterical homes are all alike."

The young man who stands accused of pandering at a reststop should not have been arrested and should not have been charged. You should not be harassed or persecuted because you walk in a park at night alone, but you are

And as long as you remain unconcerned about the image of your community, all of us suffer injustice. If you display outward rejection toward the gay community for the purpose of obscuring your participation – to create your personal image – then perhaps you should leave the gay world and join the straights whose approval you seek. You are certainly not a participant in Gay Pride. But you won't fit in straight life, because you're not straight.

None of us should suffer the fear or intimidation of police actions by sting or any other means just because we are gay or suspected of being gay. But our community is too disconnected and fearful to implement any considerable influence.

The sad truth is that there is the possibility that a future sting operation will result in your being charged with soliciting sex or some other embarrassing accusation. And even if there is there is no prosecution, the image you so carefully cultivated will be shattered and your mask stripped away.

A dead battery will be your least concern.

### One Man's Quest to Find Out His HIV Status

# So You Want Get Tested?

world's population. Some of us have tried to make anyone who is willing to listen realize that AIDS is sexually transmitted disease that can and will affect everyone in the world. You know this and I know this but perhaps you have been afraid to know, for whatever reason, if you are directly affected or in other words, infected with the HIV virus. Now, however, you have overcome that fear and you want to get tested and finally find out if you are infected.

There are many reasons to find out your status. Most are obvious, such as: preventing the spread of the virus and/or prevention of life through early detection, but these topics aren't why we're here today. Right now, we just want to know for sure if we're HIV-positive. "So what do I do?", "Where should I go?", "How much will it cost?", "How soon will I get the results back?" – these are the questions we're going to try to address, the process of being tested for HIV.

Now, you would think that this wouldn't be such a problem. You go to the doctor's office, throw down your hard-earned money, they draw your precious blood, send it to the lab, which runs the "latest" test and returns the results to the doctor's office and the doctor gives you the results, good or bad (hopefully good). Dr. Welby would be proud if you thought it was that simple. I talk from first-hand experience.

I had been tested for HIV before, but not since I moved to the Orlando area. After being here two years, I decided to get tested again. I know, I know, you should be tested every six months but those of us without medical insurance can't afford it and since I was in a monogamous relationship, blah, blah. (Pardon me, I digress)

I'm not stupid, just broke and had other pressing issues on my mind like keeping a roof over my head in these tough economic times. OK, OK, enough of my lame excuses.

First, I called the GLCS Hotline and was transferred to the "live" operator. I told him that I was looking for some place to get tested for HIV.

The operator gave me the number to the Orange County Health Department, which does anonymous testing for \$20 and gives you the results in about two weeks. I also wanted to know if there were any doctors who were gay- and lesbian-sensitive and could provide the same service. I was given me a few names based on where I lived and how far I was willing to travel.

I was reminded that GLCS doesn't recommend any doctor or service but only provides the information as a service to our community. I asked when these doctors were open but the operator didn't have that information; however, he said he would find out so that others who call will have access to the information.

Since it was still early Friday evening and there was a walk-in clinic at the end of my street, I decided to see if I could be tested there. I walked in, waited to be waited on and finally got to ask how much it would cost to have a "blood test" done. (You should be discreet when other people are around who may be a little less sensitive to the term HIV.)

I was told there would be a \$45 fee to see the doctor and I would have to see the doctor if I wanted to have any blood test done other than a cholesterol test. I said thanks but no thanks. Why would I want to pay someone \$45 just to say "Hi, how are you doing? Why do want to be tested? Are you in the 'high risk groups'? Blah, blah, expensive blah. Nurse, please draw this man's blood."

Well, I put it off. Not for long, I just wanted to see if I

could get it done for a little less money. OK, it's now Monday. My car was in the shop and since I couldn't get to work, I decided to call the doctors whose names GLCS had given me Friday night.

I called the first one and got the "walk-in-clinic-shuffle" again. They wanted \$50 for the physical, then the cost of the test and re-test if it came back positive. Thanks, but no thanks, gay-sensitive or not.

I called the second doctor. It got worse. They wanted \$50-\$100, then the cost of the test and then the cost of the re-test. (Hold on here, I just wanted to have a little blood drawn and a test run, not "open wallet" surgery.)

I thought I got clever. I tried to cut out the middle man, namely the money-sucking doctors. I picked up the Yellow Pages and called a few of the medical labs in the area. Unfortunately, the money-sucking doctors beat me there. All the labs that I called said: "Yes, we do the test. But no, we don't do it without a little slip from the doctor." (And we already know how much that little slip of paper costs, don't we?)

All this wasn't in vain. At the last lab that I talked to, a woman clued me into a little-known way of getting tested, which was to give blood. Whenever you give blood now, they test it automatically for HIV and various other diseases. They have too. Well, thank you for the tip, but let me talk to the Orange County Health Department and see if it could offer any advice.

I called the AIDS Counseling/Testing number in the blue section of the Yellow Pages. I finally spoke to a woman who told me the same thing that GLCS had told me about the cost of \$20 for the test (and any re-tests) and that the result would take about two weeks. Now for the kicker, she didn't have an appointment (it's appointment only) available till early or mid January (it was mid-December when I called).

When you added the wait for the results with the backlog of appointments, you are talking about a month to a month and a half to find out if you are positive or negative. I know the first time I was tested, it took two days to get the results back and I was an emotional wreck during that time. (Not to say that I'm not an emotional wreck now, but it was a heightened state of hysteria.)

I told her that I wasn't concerned about my name being kept in a secret hiding place that only the CIA could find.

I asked if there was any other way of getting the test done any sooner or cheaper. She told me that the county has a walk-in clinic for sexually transmitted diseases that is open Monday through Friday from 8-10:30 a.m. at the County Health Department building (second floor) on Central Boulevard in downtown Orlando and the cost is only \$7. The clinic is first come, first served and the results (which are anonymous and confidential) are available two weeks from the date you have the tests done. You have to go back to the clinic to get the results.

ell, I liked the price but the wait for the test and the wait for the results really didn't appeal to me. I knew that you should be able

to get the results more quickly than that. There are enough labs in the area. I know because I personally called over a half dozen.

I decided to call some of the other walk-in clinics, the ones that the blood suckers own. The prices varied like the decision-making process of a flaming drag queen on prom night. (Just kidding, everyone knows that female impersonators wear fire-retardant undergarments and have no problems deciding what to wear on any

occasion.) I called one of Florida Hospital's Centra Care Walk-In Urgent Care Centers and found that there was a \$48 charge for the office visit, a \$49 charge for the first test and a \$18 charge for handling, and if the test came back positive, they would charge you an additional \$115 for confirmation testing and finally it would take 10 days to get the results back. What a bargain!

Another clinic said that it would be \$75 for the test and \$40 for the first office visit, less for "a little office visit" if you've been there before. (Once you've seen the office, obviously the decor wasn't what brought you back for more but \$5 off the price of admission would.)

Some of the walk-in clinics, such as Park Care Community Health Center and the Walk-in Medical Care Centers, don't even do HIV testing. The woman at one of the Walk-in Medical Care Centers said the reason was that their charts are in the open (and the other bloodsuckers can smell a lawsuit a mile away. I said that, not her.)

Well, I did find a couple of walk-in clinics that have a little more reasonable rate. One was the Pine Castle Walk-in Clinic which offered the test for \$41 and a \$15 office visit, with a week-10 day waiting period.

The other was Executive Health Services, which offered a flat rate of \$60 (cash only, please) with results in two to three days to no longer than a week. Executive Health Services is open from 8 a.m. to 4 p.m. Monday-Friday.

These are not the only places, but after spending a good part of a morning looking for a place to be tested, it should give you a place to start if you decide to be tested.

I came to several conclusions through this little ordeal:
• Insurance companies should support a national

- health care plan that would require some control over the cost of basic services.
- Since this plan isn't likely to happen any time soon, buyer beware. Do not accept the cost of health care like sheep to the slaughter, shop around, shop around, shop around.
- If you have the time and very little money, then seek out the County Health Services. It will save you bucks and only take up a good chunk of time to get the results.
- If you have a little cash and want to know a little sooner than a couple of weeks, seek out one of the walkin clinics or see a doctor who doesn't charge an arm and a leg to visit their wonderfully decorated offices.
- If money is no object and time isn't either, then flip through the Yellow Pages and let the fickle finger of faith lead you to the slaughterhouse that makes millionaires out of people who saw you coming. As W.C. Fields said, "There's one born every minute."

All kidding, politics and personal issues aside, get tested for HIV and make the ones you come in contact with get tested. The life you save may be your own.

P.S.: Give to AIDS research, we can't wait for someone else to find a cure. We have to make it happen by focusing our efforts to protect our community and ourselves.

### Catching the 'Big One'

(Editor's Note: The following essay is the fourth contribution to The Center Fold by one of its most unique and talented writers. The author was a modern-day storyteller – a folklorist, naturalist and realist – who loved all things God created. His stories are true; his words are simple; his messages are heartwarming and not easily forgotten. He would want to be remembered as the young lad, with the good memory, who remembered exactly how the "really big one" was caught. We hope you will enjoy this very special last essay of Brinson Perry, who died last month. He enriched our lives deeply. The beauty of his words, mind and soul will live forever.)

y father was always an active outdoorsman, spending his free time fishing, hunting and camping. One of our favorite places to go for a weekend was Redwater Lake, up near Hawthorne, Fla. Dad had a colleague who owned a campsite on the lake, and we were welcome to use it most any old time. We caught many fine fish, including nice, plump catfish, wonderfully sweet tasting bluegills and shellcrackers, and big, proud bass, the kind that would give you a grin 12 inches wide.

We had some great times camping on the shores of Redwater Lake. In fact, we had the best time I can remember ever enjoying. The lake was pretty remote in those days, and to reach it you had to have an adventuresome attitude. The county-graded road passed about a mile away, and the road in from the county road was just a crude trail.

The sand on the trail was formidable, and would have stuck any city driver up to his axles in a heartbeat, but Dad was highly experienced at driving in deep Florida sand, and we made it through nearly every time. I

remember staying up late listening to the music of a bidbarred owl, the finest hooter in the swamp. Dad told me tales about wild animals and legendary creatures of the swamp.

One trip that I remember in particular, we had Bruce and Chip with us. Bruce and Chip were neighborhood boys who sometimes came along on these weekends at the lake. They were about four years older than I, which made them about 14.

Late in the afternoon, Dad was sitting in a folding chair, on the little dock. He had four or five cane poles on the deck beside him, rigged with worms and bobbers. Fishing was a bit slow, so he was smoking and drinking steadily to make up for it. Then, one of his untended cane poles took off, leaving the dock so quickly that Dad could not respond in time to slow it down.

By the time the pole hit the water, it was moving like a runaway train, leaving a V-shaped wake in the surface of the lake. Dad jumped up excitedly, tipping his chair over behind him, and shouted that a fish had taken his pole.

Bruce and Chip ran to the boat, and jumped in to pursue the fish. It was a tired old plywood skiff. It leaked steadily, requiring almost constant attention to keep it from filling up and sinking. It was paddled with a paddle that was sawn from a 1-by-6.

Bruce took the bailing can and Chip took the paddle. Chip paddled fiercely to catch the cane pole in the water, and Bruce bailed for all he was worth to get the six inches or so of accumulated water out of the boat.

The cane pole was now about 150 feet from shore, still floating on the surface. As Chip maneuvered the boat near the pole, the pole took off underwater. A minute later, the pole resurfaced about 50 feet away. Bruce paddled like mad again, and Chip stationed himself to get the pole, as soon as he could get his hands on it. Every time the boat would approach the pole, the pole would disappear under the surface again. Dad and I stood on the dock and shouted encouragement. I jumped up and down to help things along.

The big fish towed the cane pole far out into the lake, made a wide sweeping turn, and headed back in to shore toward a neighboring place, where Mr. Jim lived.

Dad and I raced over to Mr. Jim's place to meet the boat and the fish. Dan took Mr. Jim's landing net, and waded into the water. The boat was still only chasing the cane pole, and had no control over it. The powerful fish clearly was leading the situation, and was seeking some cypress knees to tangle the line in, so he could break it off and laugh at us.

Finally, in four feet of water, the boys in the boat got hold of the pole. The fish was tired, but still had a good bit of strength, and was towing the boat toward the shallows. Dad waded toward the fish from the left, and I waded toward it from the right.

The fish was getting spooked, and surged extra hard against the light wire hook, which straightened and pulled free from the fish's mouth. Dad was about two feet away on the left, and I was about three feet away from it on the left. The boat, with Chip and Bruce, was three feet behind it.

It took that fish about a full second to decide to make a break for deep water. The fish was heading for the high seas when Dad stuck the landing net down directly in front of it. The fish swam directly into the landing net, and was ours. Dad hoisted the net from the water, and everyone cheered.

That adventure was probably the finest example of unrehearsed teamwork that ever has happened. It took four people, ranging from boys to me, to catch it, and everyone had to do his part just right.

We had caught a very big catfish. Later, at the tackle store, we weighed the fish at nine-and-a-half pounds. When we left the tackle store, we estimated that the fish had lost about two-and-a-half pounds due to moisture evaporation. By the time we got home, were supremely confident that the fish was really a 14-pounder.

Now, we all are religiously honest, not given over to using any forms of the so-called "stretcher"... and the size of that fish has never been exaggerated in the 30 years since we captured it.

It was later found out that at the same time the women wished to have their picnic, the board opted to give the date to the IDQA - the International Drag Queens of America.


One of the directors was heard saying: "They look so much like our little honeybunches!"

### **Objections to Condom Use Can Be Minimized**



Dear Dr. Grieco:

I read in The Center Fold that you think everyone should practice safer sex, but my boyfriend and I really like anal sex, and we're not going to give it up. We both think we're not infected, so do we really have to use condoms? We don't

Yours truly,

Most objections to condoms are about decreased penile sensations and interference or "hassle" during lovemaking. Both of these objections can be minimized with patience, practice and creativity. If you are unaccustomed to them, use of condoms will, of course, seem awkward at first. Gradually, you can help make condom use an erotic part of sex play, such as providing teasing sensations while helping to put a condom on your man. Also, by putting a drop of water-based lubricant, like K-Y jelly, inside the tip of the condom, his sensations are increased. Another option is use of sex toys for insertion rather than a penis. (Don't share such toys.)

If you resolved, however, to continue with unprotected anal sex, I recommend you both get HIV testing at the county health clinic; there you can get confidential, anonymous testing. If you are both uninfected and have engaged in no risky sex or needle-sharing for the past six months, your risks of HIV infection with anal sex are about nil.

Dear Dr. Grieco:

My lover, Mark, is in very poor health with HIV. He is weak and not interested in sex. We have been together for over 10 years. I feel attracted toward this one other guy I know, but then I feel guilty. I am becoming impatient with Mark but I do love him. His needs are all we ever talk about. What about my needs?

Dear Harry:

When someone has a chronic or terminal illness, their family and loved ones are also affected. If you are trying to meet most or all of Mark's needs alone, and if you have little social support of your own, you will probably experience burn-out.






