He was last seen by his friends on Sunday, June 9 and when he was gone overnight concern rapidly grew. Dennis was a homebody who loved his home and rarely traveled any distance or for any length of time without his family of friends knowing of his plans. As the hours went into an-

other day, these friends began the usual path of inquiries to the police and hospitals. There was no news. Dennis seemed to have vanished.

It was a call from the police in Port Orange that first alerted his roommate, Bill Browning, that something was amiss. Dennis' car had been found seemingly abandoned and it appeared that efforts had been made to conceal it. That call came at about 4:00 p.m. on Tuesday, June 11, two days after having last been seen.

A second phone call from the police to advise Browning that the car was to be

e loved his home, his friends, impounded because Dennis had not been seen nor hear from. Browning's concern changed to anxiety.

> The third phone call was the tragic news that Dennis' naked body had been found in the trunk of his car. The estimate at that time was that he had been dead at least 10

When he died, probably on June 11, he was only years old, a victim of murder. His car, in which his body had been found was in Port Orange, miles from his home. His family of friends was left asking: " W h y ? When? Was he murdered

in his home and his body stuffed in the trunk of his car as it sat concealed in the attached garage, or at some desolate location over at the coast?

Clues - yes there are clues: While he was last seen Sunday afternoon or evening, the first photograph at an ATM of a man sitting in Dennis' car making a cash withdrawal on South Orange Blossom Trail. At 9:51 on the evening of the last day Dennis had been seen. His ATM card has been used also in Winter Park, Casselberry, Daytona Shores, Port Orange, and Ft. Lauderdale. People who may have seen Dennis out socially spoke with police, and volunteered the

name Stephan. Does it have a meaning in this crime? Is that the person he was having a conversation with in one of the local clubs? Is this Stephan actually the very last person to see Dennis alive?

Dennis Attkinsson was a graduate of the Boston Conservatory and from the core of his being was an entertainer - a man dedicated to the business of spreading joy and

good feeling and happiness. His beginning in Central Florida was at Circus World, and his resume includes Walt Disney World and Sea World and Universal Studios. He did promotional tours across Europe for Universal, and was constantly entertaining personal friends and most people he met. That was his enthusiastic personality and his love of telling jokes.

Sitting in Dennis' home with Browning and Tom Miller, a friend since high school in Michigan, I heard the sadness and plaudits and the questions that follow such a tragedy. The man had no enemies; it was impossible to bring him to anger. He

would simply excuse himself and walk away from unpleasantness. Generous to a fault - when he heard a friend was in need of assistance or even financial help - he simply appeared and filled the void. He loved to laugh and wanted his friends to share in his good nature.

Even though Dennis was in a profession that is by its nature, demonstrative, he was

an unassuming person. With all of his success Dennis was never a braggart so his family of friends do not know how to let all of his friends know of the tragedy.

There will be a memorial service held at The Mark II theatre and Bill and Tom are hoping many will learn of the memorial service that will be held for Dennis through this article. Services will be in The Mark II

Theatre on Edgewater Drive on July 16 from 7:30 to 9:30PM.

Detective Glen Gause of the Orlando Police Department is optimistic that the killer caught but a fear is that others will die at the hands of this man before being apprehended. He left Dennis in the trunk of his car in Port Orange but managed to travel to Ft. Lauderdale to use Dennis ATM card one more time before the credit

was stopped. In that instance the suspect was photographed in yet another car with a passenger at his side.
