Adult Entertainment rules demand workers' license

Orange County has moved to control adult entertainment with a barrage of new proposed regulations. The 30-page proposal was submitted to the Board of Commissioners last month. A public hearing on regulations has been set for Tuesday,, March 1, in Room 327 of the Orange County courthouse.

The rules are a result of the so-called "morality referendum" offered to voters last November by a coalition of churches and conservative citizens groups. Approval of the idea of regulating the location, operation, and advertising of adult entertainment was supported by a 2-1 margin. About 47 percent of the registered voters eligible to ballot went to the polls.

The proposal states its purpose is to, "reduce the adverse effects adult businesses have upon the morals, manners and property values of the citizens." The target of the legislation includes adult bookstores, massage parlors, adult motion picture theaters, and adult dancing establishments including those serving beer, wine and liquor.

County attorney Hugh-Trees, author of the rules, told New Direction that the proposals could be used against Gay establishments, although he claimed no one had raised issues during discussion of the proposal. William Hewitt, a grass roots organizer among the churches and conservative elements in the campaign, also claimed that Gay would not be a target for legislation unless "they were flaunting themselves on the street.'

The rules, in part, read like an X-rated novel. The list of specified sexual acts which is restricted from adult clubs and from being represented in adult bookstores includes adamitism, analingus, beastiality, buggery, cunnilingus, cuprophagy, coprophila, fellation, flagellation, frottage, masochism, masturbation, necrophobia, pedophilia, pederasty, sadism, sadomasochism, sapphism, sexual intercourse, sodomy, urolangia, or zooerasty.

The rules also restrict certain presentations by adult dancers and entertainers, defining prohibited movements and detailing certain physical actions not allowed, The rules also control what body parts may be exposed and how genital areas should be covered.

In adult massage parlors, apparently differently from medical of therapeutic centers, "massages of person of one sex by a person of another sex are prohibited and no person shall massage the genitals of another person.

Workers licensed

A proposed regulation requiring annual licensing of workers in adult entertainment operations could hold difficulty to persons working in Gay-related businesses. The rules demand a \$25 yearly license fee as well as fingerprinting and photographing by the Orange County Sheriff's Depar-tment. Gay men and women employees may be reluctant to identify themselves, forcing them to lo se employment.

Owners and operators of adult entertainment operations would also be forced to pay licensing fees as well as submit to investigation by the Sheriff's department.

The proposed rules detail specific distances that new adult entertainment businesses must be in relation to churches,

'New Century' fund-raising effort begins in March

Dufour. Joyce Drazen, press spokesperson for the Orange County Sheriff's Department, said Dufour would probably be returned for arraignment after his murder trial in Mississippi. She explained Florida has no statute of limitations on murder. She said Orange County would move against Dufour in bringing him to trial as soon as possible.

The dawn of the Gay Century begins in March.

"The purpose of the club is to finance efforts to better the Gay experience in central Florida," claims Jim Welch, president of GCS and Century Club campaign coordinator. "We'll be asking Gay men and Lesbians to donate \$10 a month for the next ten months of the year. That will be the first Century effort.' "We'll make it as easy as possible for donations, supplying pre-addressed envelopes for Century Clubbers to mail their monthly gift. At the end of the year, the GCS treasurer will provide a statement of the total donation for tax purposes," Welch said. GCS gifts are tax deductible. "GCS Century Club builders will be making contacts throughout the community in the months ahead. We'll be seeking out those people who, for a variety of reasons, have remained outside the mainstream of involvement in helping to better Gay life in central Florida," Welch said. GCS services include the Tuesday "rap" group, a weekly encounter session held in Winter Park, the 24-hour "crisis" telephone line that offers problem intervention, emphatic listening, and information about events in the Gay community.

Police - Gay citizens forum would open communication

Orange County, law enforcement officials have been asked to join an open forum with citizens of the Gay community. The meeting is expected to take place within the next two months.

In a recent letter to Orlando Chief of Police William Koleszar and Orange County Sheriff Lawson Lamar from Gay Community Services (GCS) leadership, a public forum concept was forwarded, asking the law officials to aid and identify members in their department that would be directly involved in the planning of the session.

Discussion in the forum will include crimes against Gay men and women and their property as well as the handling of Gay persons who are arrested. Other topics may include house or apartment security, "crime watch" techniques to increase neighborhood safety, and tips to help people be more "streetwise"

The meeting planners also hope to allow a question and answer peoiod for open dialogue between police and Gay citizens.

Actual place and time for the meeting has yet to be developed. Planners hope to stage the event on the "neutral ground" of an area meeting room.

Other efforts include the maintaining of

An open letter to the gay community on hepatitis B

Hepatitis B, a serious disease, may be sexually transmitted

Sexually transmitted diseases among the gay community are epidemic. Herpes has recently received a lot of attention; gonorrhea and syphilis are well known; but the Centers for Disease Control (CDC) recently issued a major recommendation for the prevention of another sexually transmitted disease: Hepatitis B. In their *Morbidity and Mortality Weekly Report*, the CDC stated: "Susceptible homosexually active males should be vaccinated [against hepatitis B] regardless of their age or duration of their homosexual practices."

Gay men are at a high risk of contracting hepatitis B

In one study, from 51% to 76% of 3,816gay men seen in five sexually transmitted disease clinics had evidence of past or present hepatitis B infection. Once infected, there's a 6% to 10% chance of becoming a carrier—capable of passing on the virus. The CDC estimated there are nearly 1 million carriers in the United States and that 100,000 of these carriers are gay men.

The hepatitis B virus can be passed on by contact with contaminated body fluids

such as saliva, urine, semen, and blood. The hepatitis B virus can be transmitted through tiny breaks in the skin or contact with mucous membranes. This can occur during intimate sexual contact and can lead to hepatitis B for the partner of an infected person. Although most patients recover and over half contracting hepatitis B do not get symptoms, there is no specific treatment and no known cure for hepatitis B infections.

Hepatitis B may lead to even more serious complications

For those who do get symptoms of hepatitis B, a mild or severe "flu-like" sickness may continue for weeks or months. Ten percent of all infections become long lasting (chronic) with potential complications that are sometimes more serious than those of other sexually transmitted diseases. The serious complications include the chronic carrier state, chronic active hepatitis, chronic persistent hepatitis, cirrhosis, and even cancer of the liver. Every year almost 4,000 carriers die of cirrhosis. In addition, carriers have a risk 273 times greater than that of the general population of contracting a usually fatal form of liver cancer.

Now this serious sexually transmitted disease is usually preventable by vaccination with the new hepatitis B vaccine After more than a decade of research and development, a new vaccine is available for prevention, *not treatment*, of hepatitis B. In clinical studies, the vaccine was highly effective in preventing hepatitis B infection and was generally well tolerated. No serious adverse reactions occurred in these studies.

The vaccination regimen consists of a series of three injections, the first two a month apart and the third, six months after the first. To be effective, the vaccine must be given before a person gets hepatitis B. The vaccine helps prevent the disease: It is *not effective as a treatment*. We suggest that you consult your doctor to determine if you should be vaccinated.

Why you should consult your doctor or clinic

The vaccine helps protect against infection caused by hepatitis B virus. This virus is an important cause of viral hepatitis, a disease mainly of the liver. Even mild forms of this disease may lead to serious complications and aftereffects, including liver cancer. There is no specific treatment for viral hepatitis.

Vaccination is recommended for persons who have a higher risk of becoming infected with hepatitis B virus because of frequent, close contact with infected people or exposure to body fluids from such people. It will not protect against hepatitis caused by viruses other than hepatitis B virus.

No serious adverse reactions were reported in over 6,000 individuals receiving the vaccine in clinical trials. The most frequent reaction was soreness at the point of injection; less common local reactions included redness, swelling, warmth, or formation of a hard, lumplike spot. The local effects were usually mild and lasted no more than 2 days after vaccination. Occasionally, low-grade fever (less than 101 °F) occurred. When it did, it usually lasted no longer than 48 hours following vaccination. In rare cases, fever over 102 °F was reported.

More generalized complaints including malaise, fatigue, headache, nausea, dizziness, muscle pain, and joint pain were reported infrequently. Rash was reported rarely. As with any vaccine, broad use may reveal additional adverse reactions.

Your doctor or clinic knows what special care must be taken when administering the vaccine and in determining who should receive the vaccine. The vaccine is not intended for persons who are allergic to any of its components.

Underground restaurant catering to Gay trade

A new central Florida restaurant and nightspot is taking root in underground Orlando. "Daisy's Basement" in downtown Orlando was reopened recently by Richard Hummel, former manager of Southern Nights entertainment complex. The eatery is billing itself as Gay owned and operated.

The basement location is on Gertrude's Walk, a brick promenade that connects West Pine Street and West Central Street, one block north of Church Street station. The business opened several years ago, offering food and mellowdrama entertainment on the room's large stage. Most recently, the room featured a variety of jazz artists before it was closed by the previous operators. The room has been dormant for about two months.

GO Sports meeting set

GO (Gay ORGANIZED) Sports planning meetings for the Spring line-up will begin Feb. 10. The group, founded last year to supply athletic and recreation opportunities to the Gay community, is open to all men and women. It is an program of Gay Community Services.

Several field days including softball, volleyball, and a picnic lunch were held by GO Sports last year. A bicycle tour was also held through Orlando and Winter Park

GO Sports planners will also be looking at development of a field day as part of the 1983 Gay Pride celebration in June.

Hummel said the club is currently offering lunches only, but plans all for full bar and dinner operation within several weeks.

He claims that the business will cater to the downtown luncheon crowd with an extensive sandwich and salad bar operation, offer an extensive dinner menu, and then operate as a membership club for late dinners.. Future plans include the spot operating 24 hours on Friday and Saturday with an all-night breakfast and sandwich menu.

Two special dinner dates have been announced to the Gay community.. An Italian Fest is set for Feb. 5, and will feature an Italian food buffet with free wine and Italian drinks. Price per person in \$9.69. Tax and gratuity are extra. Valentine's weekend, Feb. 11-12-13-14, the supperclub is offering a complete prime rib dinner, stuffed backed potato, house salad, vegetable, Yorkshire pudding, and choice of dessert table with free wine and champagne. Price of the meal is \$10.69 per person or \$19.69 per couple. Reservations for either weekend may be made by calling 423-9903 during daytime business hours.

Hummel said the dining entertainment is currently open from 11-4 p.m. Monday through Saturday. Several former employees of Southern Nights are staffing Daisy's Basement, Hummel said.

Principals in the operation are Jim Mc-Cready and Thomasville, Ga. attorney H. Gabhart. The operators hope to book entertainment into the club in the near future. Consideration is also being given to limited dancing for members of The Basement, a private club, according to Hummell.

Hummel and McCready are plantiff's in a lawsuit against the owners and operators of Southern Nights, James and Charles Veigle, in which they are seeking some \$45,000 in damages for a business contract they alledged was breached. (See New Direction/January) Mc Cready's Southern Changes Inc. operated the South Bumby Ave. location before the Veigles, owners of the property, regained control of the Gay club last year.

Dismissal of civil suit hinges on missing data

Numerous records, receipts, contracts and other data requested by the attorney for one side of a civil lawsuit involving a nightclub serving the Orlando Gay community have, at presstime, were yet to be delivered according to Bruce Bogin, attor-

ney for the Evelyn Corp., object of the \$45,000 damage suit. The court action was brought last month by Southern Changes, Inc. against Charles and James Veigle who Evelyn, Inc. operates Southern Nights, 375 South Bumby Ave., Orlando.

Bogin said he had asked for substantiating documents from the claiming party to prove expenditures and other charges. He said the deadline for the delivery of the data was Feb. 7, which allowed for a 10 day extension granted Southern Changes

by Orange County Circuit Court Judge Frank Kaney. Bogin said if the records were not forthcoming he would file a "motion to compel" saking Judge Kaney to order delivery of the documents. If the records are not produced, Bogin said his

motion for dismissal of the lawsuit would carry added weight. A motion for dismissal

based on a different legal point presented by Bogin, is expected to be heard Mar. 25, by Judge Kaney.

The suit resulted after the Veigle's regained control over the bar operation when Southern Changes' president James McCready failed to close on the agreement to purchase the bar business for \$185,000. Mc Cready is lieu of the closing were illegally seized by the Veigles.

Jim Veigle said that action to regain the operation came after it became apparent to him that Southern Changes Inc., was unable to meet financial oblications made to his company in oral agreement. He claims a number of "bad" checks written by McCready's company were honored by Evelyn, Inc. in order to keep the popular club operating.

Former Southern Nights manager Richard Hummel, a director in Mc-Cready's company, left the Veigle's employment recently to manage Daisy's Basement, a restaurant venture by Mc-Cready and others recently opened in downtown Orlando.

Welch, 38, spent most of his working life in Michigan after being educated at Ohio University. In addition to owning and operating two sporting goods stores in Michigan for five years, Welch has worked as a newspaperman and editor for several publications. He is currently working in the retail sector.

Writing under the byline of Jay Wesley, Welch is the founder and managing editor of New Direction, the news tabloid published monthly by GCS. New Direction began serving central Florida in July, 1982

"I struggled deeply with my responsibility to the Gay press and maintaining credibility as a reporter while at the same time directing the efforts of the group making much of the news," Welch said. "Above all, I want to tell the truth about Gay life, the best and worst of it and all in between

Ronnie Sanlo could regain Florida Task Force post

The Florida Task Force, the state's Gay rights action group, may recall Ronni Sanlo, the Orlando woman who recently resigned her lobbyist post with the organization. The FTF's board of directors refused to accept Sanlo's resignation offered last month. Instead, the board asked her to be laid off until April.

Sanlo told New Direction that she would return to the lobbyist job on two conditions; that the board members pledged themselves to serious fund-raising efforts and that enough funds be escrowed to allow two months of active work in Tallahassee when the legislature is in session.

Sanlo, former president of Orlando's Gay Community Services said she urged the task force to dervelope a foundation that would allow tax-deductible donations to aid the work oof the Florida Task Force.

The Florida Foundation for Human Dignity is expected to be functioning in four to six months, Sanlo said. Her plan calls for the foundation to have offices in six major Florida population centers within a year, she said.

As part of the FTF fund-raising, Gay bars and night clubs in the state are being askes to donate \$1 per person paying a cover charge on Saturday, Feb. 12. The campaign is being billed as "Putting Your Heart on for the Florida Task Force." Details of possible central Florida participation in the effort were unknown at presstime.

Sanlo said that she is receiving unemployment compensation during her lay-off. She is also continuing her educaiton, doing graduate work at the University of Central Florida while living with her close companion, Carole Martin, in Winter Springs.

"I believe that Gay men and women should be citizens of a new Renissaince. We should be good workers, and good players; good dancers, good carpenters, good lovers, and good laughers. We should know how to appreciate a good poem as well as a good physique, to be able to know what is pornographic and what is erotic. We should revel in our diversity, cheer our difference, and celebrate our love for one another. We should take pleasure in our sexuality while realizing it is but one side of our complex human structure.'

Welch outlined several major goals for the coming year with Gay Community Services. "First we must begin to deliver real services to the Gay community.. health screening, job referrals, lifestyle improvement information, and political conscious-raising. Gay pride grows from self pride and we have much to be proud of in central Florida."

"Membership in GCS must be made more attractive through a series of social and service events", Welch claimed. "We'll be trying to provide a varied calendar of events for Gay men and Lesbian women to enjoy, experience, and enlarge upon."

Welch said the planned GCS "Century Club", a fund-raising effort to get underway in March will be the financial base for expanding services to the Gay community. "Our goal is to enroll at least 100 Gay men and women who will pledge \$10 a month for the next ten months... a individual total of \$100 for 1983. The first Century effort could raise \$10,000." Donations to GCS are tax-deductible, Welch said.

Other projects underway by the new GCS leadership include an open forum between the Gay community and the local law enforcement operations, enrichment of campus activities for Gay college students, support for local religious bodies serving Gay worshippers, and vitalization of recreation and sports activities through GO (Gay organized) Sports, a subgroup of GCS.

"I encourage any and all persons interested in improving the Gay experience in central Florida to join with GCS at the next meeting and to catch the excitement," Welch said. The meeting is set for Feb. 20, at 4:30 p.m. at the Parliament House Resort's Playhouse Theatre. The meting will last about one hour, Welch said.

Help with the health crisis

WHILE THE CRISIS IN HEALTH CONTINUES to grow for Gay men, especially in cities having large homosexual populations, a message is becoming clear...there is a way to redue the possibilities of contracting AIDS (Acquired Immune Deficiency Syndrome), Karposi's Sarcoma (the so-called Gay cancer) and the host of other venereal disease problems.

While no direct link has been found between recreational drugs and diseases, most doctors are now warning against the continued abuse of drugs, especially intravenous injection, for Gay men.

The other preventive prescription is to reduce the number of sexual contacts you may be having, especially if thery are with partners who are also involved in a large number of different people. Playing sexual roulette in dark places with large and continuing numbers of strangers raises the probability of disease contact.

Since central Florida is the number one destination spot for the nation's travelers, it will probably be a short time before one of the "Gay plagues" strikes a resident down. However, with simple precautions you can greatly reduce your chance of being that victim.

In this case, it is better to love wisely, so that we can stay well.

Building a stronger Gay community could be aided by one of the area's largest builders. A recent call to the GCS "hotline" has resulted in an offer for possible employment for area Gay men and women in all facets of construction from Labor to project supervisor. Related fields such as cost accounting, secretarial, and rental property supervision opportunities are also available.

Many of these positions are long-term spots with growth potential. The persons offering the job assistance are former residents of cities having a very large Gay population. They are familiar with the potential of a dedicated workforce of employees who are Gay.



Chief among them have been the reluctance of Gay business persons to use the publication and the slowness of some accounts to paying for the ads that are published. Both problems show a real flaw in how Gay businesses should work to aid each other.

I urge those entrepreneurs who have not used this publication to give more-thanserious consideration in doing so. To those who have and failed to pay, I can only urge to settle your accounts as soon as possible. Action on both counts will insure this publication's rightful place in the central Florida sun.

The group will be headquartered at the Parliament Resort.

a Central Florida blood bank acount for Gay donors to aid Gays in need of blood, GO (Gay Organized) Sports, a recreation development group, and social events such as parties and Gay pride celebration.

Welch said that new efforts for GCS in the year ahead will include a forum with local law enforcement, art shows featuring Gay artists, creation of a Gay Business Guild for owners and operators of local business, and the implementation of regular veneral disease screening for Gay men and women.

"In the face of continuing budget cuts of many of the services aiding the Gay community either directly or indirectly, it is only proper that we become our brothers

In addition, the regulations state that businesses now existing and in violation of the proposed distance rules "shall be required to discontinue...business within five years." This is apparently an effort to break the grip of adult entertainment businesses on the South Orange Blossom Trail.

Orlando studying rules

While the county morality proposal would include only unincorporated parts of Orange County, the city of Orlando is reportedly preparing its own package of adult entertainment restrictions to stem any move of the operations inside the city boundaries. The city's legal department is reportedly at work preparing its own A local member of the AUA described the group "as men dedicated to correctness and detail when wearing a uniform." The American Uniform Association provides a variety of publications and educational materials for its members including a travel directory detailing uniform museums and displays around the country. The local schedule of events also includes several dinner parties and "barracks party", usually the highlight of the gathering. Only members of the association and invited guests may attend the functions.

"In order to preserve the public peace and good order, to safeguard the health, safety and welfare of the community and the citizens thereof, it is necessary and advisable to regulate and restrict the conduct of the owners, operators, agents, employees, entertainers, performers, patrons and persons on the premises of the business operations mentioned (in the proposal)."

The County rules package is expected to come under court challenge if adopted. Author Trees said recently however, "he saw little chance to get around the rules."



regulations to present to city council.

The city already has ordinances controlling adult dancing in liquor establishments. Recently, two males dancers were arrested in Southern Nights, A Gay nightclub, for apparently showing too much buttocks. The men were released after they were taken to police headquarters for booking on the misdemeanor charges.

Should the city adopt an ordinance similar to the county's, the bookstore operaton at the Parliament House Resort could be affected. The county rules claim that its jurisdiction includes not only the bookstore but "to all other rooms in any building or structure which are closely connected as to allow free passage from said rooms to other rooms over which the licensee (owner or operator) may have dominion and control."

The basis for the rules package is stated in the opening pages of the proposed legislation: "When those (adult) activities...are present in the county, other activities which are illegal, immoral, and unhealthy tend to accompany them. Such activities include prostitution, pandering,



Hoffman's 'Tootsie' role has sweet meaning

I'm sure that a good deal of the people reading this have already seen "Tootsie." Those that haven't are missing a very entertaining as well as thought provoking film.

A brief summary of the movie for you who haven't seen it and a review for those who have. Dustin Hoffman in an out-ofwork actor who is too difficult to work with for his agent to get him work any longer. Coaching his girlfriend for a part in a soap opera, the idea comes to him to audition for the part as a woman and gets it. Michael Dorsey (now, Dorothy Michaels) falls head over heels for another girl on the set, Karen. Of course, for job sake, he can't do a thing. To complicate things, Karen's father falls in love with him. Take it from there.

Towards the end of the movie, when Michael is himself, Karen says, "I miss Dorothy." Michael replies, "You don't have to she's right here." pointing to himself. All the trouble he had being the way he wanted came out when he was Dorothy. Finally, he recognized the way he wanted to be with people and changed.

When I go into a room of people that I don't know or when I'm meeting a new friend, I'm quite different than with more familiar people. There's no reason except that I have an established "role" with them. With someone new, I want to make a good first impression-I want to come across a certain way. That's the real me inside being the real me beacuse, at this point, I haven't my defenses or my protective shield in place.

We're all like that to one degree or another. Michael wanted to be soft and caring, but the exterior that he'd already established didn't allow for it. Once you know somebody, it becomes very easy to slip into a familiar routine and take the

other people for granted. The compliments become sarcastic humor. Then, when I'm being me, I get asked why I being so nice-so different. I'm not. I just get my want-to-do's twisted around before they get done or said. We don't always come across the way we'd like.

I think the key idea to "Tootsie" is we can be who we wish to be. Getting rid of the tough guy image or the super lover idea may not be easy, but it can be done. Think about how you act around someone you really care about, the warmth, concern, the pure joy you feel with him or her and apply it to everybody. Not all at once, just a little bit at a time.

Pretend you have moved into town and you're starting a brand new world you're going to do it right. Maybe Dorothy won't be missed quite so much.

For a truly unique and enjoyable dining experience, I whole-heartedly suggest you make reservations at **Arigato**, a Japanese restaurant which opened one year ago at 3911 E. Colonial Drive in Orlando. Kimono clad waitresses and authentic Japanese trained chefs work as a team to serve you japanese style.

Imagine sitting at a hibatchi table, your chef less than four feet away, knives glistening in the light as they rapidly and expertly dice and mince your order to bitesized pieces, and spatulas flipping discarded shrimp tails and lemon into the air to be c_{n} aught behind the chef's back. The artistry of the chef's technique itself warrants a visit to Arigeto.

There are eight entrees to choose from—chicken, shrimp, scallops, lobster, and these types of steak, plus two combination dinners. The Samurai consists of sukiyaki steak and chicken; the Shogun, sukiyaki, chicken and scallops. Prices vary from \$6.95 for the chicken to market price for the lobster, which went for \$17.95 the night I dined a: Arigato.


You might wish to begin your dining experience with one of Argato's specialty drinks. The names are tempting—the **Ban**zai the **Tora Toar** or a **Saketini**—a martini made with sake instead of vermouth and served with a sliced cucumber. Sound disgusting? I assure you it's not. There are also your traditional bar drinks and a limited wine list to choose from. Dinner begins with the washing of one's hands with hot towels brought by your waitress. It's an old Japanese custom. First course—Shoyu onion soup—a clear beef broth with small amounts of onion and mushroom. Delicious, as is the lemonbased salad dressing. It's time to try the chopsticks when the salad is served. They're a challenge, but conquerable.

Now it's showtime. The chef wheels his cart into place opposite the hibachi table, deposits the ingredients onto the grill as it's proper cooking location and begins his wizardry—preparing and entertaining simultaneously. You'll find yourself eating various portions while the chef continues to cook. When he's through you'll have sampled your selected entree, mushroms, zucchini, onions, bean sprouts and rice. The accompanying sauce of horse radish, soy sauce, garlic and other spices complements the flavor of your entire meal.

As mentioned, you'll be seated at a hibachi table, which seats ten. For this reason it's wise to make reservations, as one is not seated until there are enough quests to fill a table. If you're squeamish about dining with total strangers, get together with nine friends, then make reservations. Remember **Arigato** is festive. Don't there for an intimate date.

"Arigato" means thank you in Japanese. To them I'd like to "Ah, sooo, arigato" for bringing their eating traditions to Orlando.




