No One Deserves to Be Abused

On Jan. 1,1992, the laws governing protective orders, known as domestic violence injunctions, changed and now include lesbians. Previously, only persons who are or were married or related by blood or marriage could obtain a domestic violence injunction. Other people needing protection had to get a repeat violence injunction, which required two instances of violence or threats of violence, and was not as comprehensive an order. The law has been expanded to include any persons who are or were residing in the same dwelling unit, as if a family, and any two persons who have a child in common, regardless of whether they've ever lived together.

This is important to the gay and lesbian community in two ways. First, it provides more extensive protection against abusive partners. Secondly, it

AMNESTY INTERNATIONAL TO ADOPT GAY/LESBIAN PRISONERS

Washington D.C. Sept.11,1991.

International gay and lesbian groups responded positively to a recent decision by Amnesty International to adopt as prisoners of conscience those imprisoned for their homosexuality, including those arrested for homosexual acts. The decision is a major development and victory in the more than 12 year battle to change the global human right's group's policy towards lesbians and gays.

AI made its decision to defend gays and lesbians at its biennial International Council conference in Yokohama, Japan, September 7. The Gay and Lesbian Task Force to Change Amnesty International, a world wide coalition formed this year to pressure the organization, issued the following statement.

"We, as representatives of thousands of gay men and lesbians around the world, would like to thank Amnesty International for taking this longneeded step. We offer our deepest thanks to AI sections that worked so hard to achieve this victory, especially the USA, Canada, Ireland, and Norway. The task force has faith that AI will implement this important decision immediately."

To implement its decision, the Gay and Lesbian Task Force is calling on AI to: devote money and resources to researching and pursuing cases of gay and lesbian oppression; initiate a major study documenting gay and lesbian oppression throughout the world; organize major publicity campaigns around this issue; and to work in a mutually beneficial manner with existing international gay and lesbian organizations, such as the International Gay and Lesbian Human Rights Commission, and Queer Planet in the U.S., the International Lesbian & Gay Association(ILGA), with members in 55 countries, and local gay and lesbian groups. 

In Good Health

Before AIDS was discovered, herpes was the sexually transmitted disease that received the most attention in the press. Although not as much is written about it these days, it remains a significant health problem for women. It is important for lesbians as well as straight women to understand the transmission and prevention of this disease.

Herpes is caused by the herpes simplex virus (HSV). There are two types of this virus: HSV-1 occurs 95% of the time on the mucous membranes of the mouth (cold-sores, fever blisters, etc) and 5% of the time on the mucous membranes of genitals. HSV-

2 occurs 95% of the time on the genitals

and 5% on the mouth. A culture must be

done during an outbreak in order to tell

which of the viruses is present.

Genital herpes results in small blisters appearing on the vulva, vagina, anus or cervix. The blisters then break open and become shallow sores that may ooze or bleed. They are usually extremely painful. Symptoms usually appear from within a few days to three weeks after exposure to the virus, although some people do not have symptoms until much later. The first outbreak is usually the worst,

often causing fever, headache or

muscle aches, fatigue, swelling of the

lymph nodes in the groin, vaginal dis-

charge, itching or painful urination.

Since herpes is caused by a virus, infections can recur at any time. The virus lies dormant in the nerve cells and can flare up when a woman is under stress, is ill or run down, or in response to hormone changes (during

menstruation, ovulation or preg-

herpes heals faster and is less severe than previous ones, and the length of time between outbreaks usually increases. Some women may only have one outbreak. The blisters generally occur in the same locations each time, along particular nerve pathways, and a woman may notice "prodromal sensation" (an itching or tingling feeling) that warns her she is about to have a outbreak.

The most likely way to get genital herpes is by direct contact with someone who has an active infection. This can be by unprotected vaginal, analor oral sex. It can also be spread from mouth to genitals by the fingers. A person may be infectious from the time that prodromal symptoms appear until all the sores have completely healed.

Unfortunately, there is no cure for

herpes. Heath care providers sometimes prescribe a drug called Zovirax (acyclovir) to help prevent or shorten outbreaks. Most treatment, however, is directed toward relief of symptoms: ice pack or sitz baths, aloe vera or comfrey compresses, and keeping the genital area clean and dry. It is also thought that taking 500 mg of lysine. an amino acid (available over the counter), every day may help prevent outbreaks. There is evidence that women who have HSV-2 may have an increased risk for cervical cancer. It is recommended that these women have Pap smears done every six months, instead of once a year.

This year, many women's communities throughout the world are celebrating International Women's Day with the theme, 500 Years of Resistance...Through Women's Eyes. The theme is a response to the patriotic fervor surrounding the 500th anniversary of the "discovery," or invasion, of America-depending upon whose point of view you take. Had the women living in the Americas known more about the culture of Columbus, would they have tied up his ship or would they have tied him to the mast and shipped him back home?

International Women's Day can be our opportunity to make the world remember what actually happened to those women in 1492... to Black women in 1592...to women healers and midwives in 1692...to Mexican women in 1792...and to Japanese, Chinese, and Filipina women in 1892.

It can also be an opportunity to honor and draw from the courage and groundwork these women laid in naming and resisting violence, exploitation, and demoralization.

family in a legal sense.

If your partner is physically abusive or threatens physical abuse to you, and you live in Orange County, you can come to Room 248 of the old Courthouse (65 E. Central, Orlando) Monday through Friday to obtain an injunction to either remove your partner from the residence or order them to stay away from the residence or order them to stay away, if they no longer live with you. The office phone numbers are 836-2001 and 836-2044.

We can help you with information and counseling even if you haven't lived with your abuser or if you live in a different county. Our office is extremely nonjudgmental, that is, it is safe to be who you are and not change pronouns when you talk about your abuser.

No one deserves to be abused. Call us if you need help. In emergencies, call the Spouse Abuse hotline, 886-2856, 24 hours a day. All our counselors have nonjudgmental attitudes, and help is available.

Love Is Not Supposed To Hurt

I don't want to think that a woman would hurt a woman; hands that loved me soft could meet my jaw hard as steel. I don't want to think about this at all. can't believe the blood that throbs from my temple or her tears as she realizes what she has done and tries to make it better with her kiss. She's tried before, and it's not better. It gets worse each time she controls me with her power. I suspect this power covers fear. If I am totally under her control; if she can own me, she does not have to fear losing me. I wonder: if she could find herself. would she need to hold me prisoner to keep from losing me? I don't know, but I do know my job is to take care of me, and when I have left, whether she finds herself or not; to remember the steel as well as the softness. I reclaim my own power as I realize kisses do not excuse bruises, and love is not supposed to hurt.

She Speaks Out

Mike Tyson is guilty of rape. While this comes as no surprise to me, it does raise a troubling dilemma. I can't help but think about the similarities in this trial and the William Kennedy Smith trial. And I'm very puzzled by the different outcomes.

When I first heard of Smith's ac-

quittal, I angrily accepted the fact that he'd bought his freedom. But Tyson also had ample financial resources. Tyson's lawyer used the same strategy as Smith's: that the woman had wanted sex and was spurned later. Both attorneys attacked the victims' reputations, a practice so deplorable it ought to be banned from all future rape trials. Both men insisted upon their innocence in the media with righteous indignation. But Mike Tyson is heading for jail, while Smith heads for a medi-

There are some major differences in the victims' backgrounds, but that is irrelevant. A victim is a victim, period. Think of how ludicrous it would be if every victim of every crime were subjected to the vile treatment of rape victims. No one would ever want to come forward if their every past action were to be brought out in a criminal proceeding. Victims shouldn't have to prove their innocence. It's unfortunate that in the American le-

The other major difference was the defendants' education and cultural background. William Kennedy Smith was born with a silver spoon in his mouth, and was taught with which

gal system, criminals have more rights

hand to retrieve it. He answered every question in court like he was supposed to. He wore cheap sports jackets to court and wore a pitiful look on his face. He was a rich kid with all the advantages, who didn't come across as one. Mike Tyson was born an underprivileged black youth. His opportunity came in boxing. He made a lot of money with his fists. But money doesn't buy common sense, and Tyson didn't have much as he came strolling into court to sign autographs dressed in expensive suits. There is a lot to be said for perceptions and image in a trial proceeding. This is unfortunate, as appearance has very little to do with one's guilt or innocence. Tyson looked like a swaggering bully.

I was worried about how a "not guilty" verdict in the Tyson trial would affect women coming forward to press charges when they are raped, especially on the heels of the Smith verdict. But this message is almost as bad as if Tyson were found not guilty. The issue here seems to be not whether a crime is committed, but whether the jury likes the defendant or not. In my opinion, both were guilty; both should have been sentenced to a prison term.


The verdicts are in, and it's just another indication of how unjust our judicial system is.
