A Buchanan Nomination?

Mad in the U.S.A.

GOP spokesmen across the country are dismayed to discover Pat Buchanan has surfaced to be the prominent player in pursuit of the party's presidential nomination. "He's a leader alright," said one spokesman who spoke on condition of anonymity "he's leading us to defeat. You can't help but wonder just whose side he's on.'

Florida GOP Chairman Tom Slade said the prospect of a Buchanan nomination would be a victory for Clinton.

Slade continued that he would not care to see Buchanan win the republican nomination. But Florida republican leaders appear to shy away from expressing dismay over Buchanan's New Hampshire win.

Phil Handy of Winter Park, the man who headed Jeb Bush's failed try at winning the governorship of Florida is the campaign chairman of Lamar Alexander's campaign for the presidency. He expressed the conviction that Alexander must win an early primary to keep himself in the race. Such a win is as important to Handy as to Alexander.

The GLCS Fax line has been kept busy with statements from gay organizations across the nation. These messages remind us of Buchanan's opposition to the rights of gay people. One message read, "let the Democratic

equality and to civil rights. He'll have us denied the right to a job if he has his way," she said.


Much of the nation, not just the republicans, seems to be waiting for Buchanan to trip over his blatant use of prejudice and intolerance. "His message is European is fine, but no blacks, gays, orientals. No trade, no abortion and no say in anything."

Buchanan's campaign for isolationism and militancy

has been stirred by his rhetoric: "All the forces of the old order are going to rally against us," he said. "Do not wait for orders from headquarters. Mount up and ride to the sounds of guns." Many feel this is an appeal to the militia to insurrection and as such it is a dangerous tactic.

Senate Leader and Presidential hopeful Bob Dole declared, "This is a race between the mainstream and the extreme." This was as close as Dole has come to accusing Buchanan of being a racist. But Dole has his alliance with prejudice, too, having declare that he is opposed to civil rights for

Pandering to the bias against any unpopular minority, Buchanan is playing his cards with fear. As the campaign and the rhetoric heat up, most believe he will use the opposition from minorities to bolster his case with





n March 7, 1996, GLAAD will present the first-ever Excellence in Media award to Barbara Walters at the seventh annual Media Awards in New York City.



Federal Appeals Court in Georgia Renders Landmark Ruling for Lesbian Attorney

Wedding Plans Became Basis for Losing Job with State Attorney General ATLANTA — In an important victory for lesbian and gay civil rights, a federal appeals court in Georgia today ruled that a lesbian's relationship with her partner is safeguarded by the Constitution and entitled to the high-

est level of judicial protection.

The ruling came in a case brought by Robin Shahar, who

sued the Attorney General of Georgia, Michael Bowers, when he terminated her employment upon learning of Shahar's plans to enter into a Jewish marriage with another woman. The American Civil Liberties Union, which filed and litigated the case, applauded the decision.

"This careful, respectful ruling affirms the constitu-

tional freedom of all government workers, including lesbian and gay employees, from being fired because of their intimate and personal relationships," said Ruth Harlow, associate director of the ACLU's Lesbian and Gay Rights
