THE QUILT

From all over the United States and some foreign countries they came. Some to view the quilt, others to add theirs. Silk and satin, leather and lace, bears and bunnies, embroidered and crocheted, air brushed and magic markered, the panels were fashioned. A memorial to special people who had fallen to this horrible disease long before their time on this earth should have been up.

To imagine the size of this quilt is hard, at least for me, when I think of fifteen acres. How big is fifteen acres? Maybe another perspective will be better. The panels are three feet by six feet, symbolic to the size of a grave, making The Quilt about 361,000 square feet or, for better understanding, about the size of 12 football fields.

There are 20,064 panels in it with the addition of more than 1000 at its appearance in Washington. It was packaged in 700 boxes weighing 70lbs. each and transported by train from San Francisco to Baltimore. There it was loaded onto eight 48-foot trucks to be transported to Washington.

The rain played havoc with the people from the NAMES Project Organization. On Friday they were unable to lay The Quilt down at all. On Saturday people stood for over three hours to watch how meticulously and reverently The Quilt was protected and laid out.

With plastic the same size as the panels the ground was covered. Then the panels were laid on the plastic. Runners to protect the viewers from the mud and damp grass were laid on all sides of the panels. An aerial shot, with no one in the entire fifteen acres and bordered by the workers dressed in all white was taken. Then some

100,000 people who had stood behind the workers swarmed The Quilt. For the next five hours people viewed The Quilt, trying to find loved ones and friends.

On a personal level The Quilt was as emotional for me as it was for many of the other 250,000 people who viewed it over the weekend. I have several panels on it of special people who have played a long and important part in my life. To view these panels and reflect was very hard for me. Because of all the love that is shown in these panels it is much harder for this writer than to visit a grave site.

Painful, tiring, symbolic, emotional, and amazing were the feelings I experienced after spending a weekend with The Quilt. I was glad that this enabled me and many others to have the closure we so desperately needed and the ability to let go, making it possible to finally get on with our own lives.

This was supposed to be the final showing of The Quilt, but in 1989 they said it would never be shown in its entirety again. The NAMES Project has learned they "... will never say never again." So if the opportunity does ever afford itself again I assure you that it is worth the sixteen hour drive and all the walking.

Hillary Clinton became the first spouse of a major Presidential candidate to appear at a gay function - the annual dinner of the Human Rights Campaign Fund in San Francisco. Hillary joined Geraldine Ferraro in addressing the black-tie event for 650 lesbians and gays - some of San Francisco's finest.

EMRF is a non-profit organization dedicated to the legalization of Gay and Lesbian marriage rights and acts as a national clearinghouse for Gay and Lesbian marriage rights information.

Currently, the primary focus of EMRF is to win the lawsuit filed by Craig Dean and Patrick Gill against the District of Columbia for denying the couple's marriage license application because they are Gay. No state in the Union will legally recognize samesex marriage. It is possible for samesex couples to have a wedding ceremony, however such a ceremony does not create or have legal benefits. Obtaining equal legal recognition, benefits, and protections for all married couples is the goal of EMRF.

Dean and Gill's lawsuit is based on three points. First, the nation's capitol is a unique jurisdiction in that its Human Rights Act prohibits "discrimination by reason of sexual orientation for any reason in all aspects of life."

Second, the District of Columb law is silent as to the genders of persons who wish to be married. Accordingly, EMRF is arguing that there is no legal prohibition against same-sex marriage in Washington, D.C.

Third, we also are arguing that if the court was to interpret D.C. law to prohibit same sex marriage rights it would then be a violation of the couple's constitutional rights under the due process and equal protection clauses. The law is currently on appeal.

NEA Award: Dr. Virginia Uribe has received the 1992 Award for Creative Leadership from the National Education Association, the nation's largest union. Dr. Uribe founded Los Angeles' Project 10, a pioneering education program for lesbian and gay teenagers. Southern Voice, 7/23/92.

The American Nurses Association passed a resolution on June 25, opposing discrimination against gays and lesbians in the military. Thorganization will also consider candidates' positions on discrimination based on sexual orientation when they consider endorsing candidates for public office. Southern Voice, 7/9/92.

LETTERS TO THE EDITOR

Dear LCN,

In her most recent **She Speaks Out**, Patty Sheehan reminds us that a Republicans and the fundamentalists have attacked single mothers and have tried to eliminate the right to choose on the abortion issue. She then warns us the "gays and lesbians won't be far behind." Patty, I hate to tell you this, but the attack on us has already begun.

A quick reading of the 1992 Republican Platform clarifies their position. After expressing their support for the homophobic Boy Scouts of America, the Republicans state that they "oppose efforts by the Democratic Party to include sexual preference as a protected minority receiving preferential status under civil rights statutes at the federal, state and local level. We oppose any legislation or law which legally recognizes same-sex marriages and allows such couples to adopt children or provide foster care." In other words, they view us as second class citizens, unworthy of basic human rights.

Contrast their attitude with those of the Democratic Party and Bill Clinton. The 1992 Democratic Party Platform specifically states that they will "fight to ensure that no Americans suffer discrimination or deprivation of rights on the basis of race, gender, language, national origin, religion, age, disability, sexual orientation, or other characteristics irrelevant to ability."

Bill Clinton's position paper on Issues of Concern to Gays and Lesbians details that he will support a federal gay civil rights bill, issue executive orders to repeal the ban on gays and lesbians in the military and foreign service, crack down on hate crimes, and make the fight against AIDS a national priority.

The choice is yours. Just remember that your choice won't count if you don't vote. As Patty said, there are no excuses for not voting; there are only regrets.



- * the adoption of a platform that reflects a narrow religious agenda and hostility to the diversity of American society and differences of opinion within the party;
- * an extremist position on abortion in the platform without fair debate;
- * the removal of an openly gay campaign official by the religious fundamentalists who dominate the Bush campaign headquarters in Washington, DC.



Kovaleski also said that he favored adding sexual orientation to the federal civil rights act, and would work to lift the military's ban on homosexuality.

Kim Sheppard, a candidate for the state House seat held by Bruce McEwan, echoed that stand. She called for a new code of ethics for politicians. "If you really want change, then get out of your armchairs, get on the streets, knock on doors and get the word out," said Sheppard, a former Orange County prosecutor.

And Cindy Abel, a marketing specialist, spoke about the importance of marketing plans, noting that new businesses should spend at least 15% of their projected sales on marketing.


