Claiming she is "totally consumed with her Gay rights involvement," the former husband of a Lesbian and Gay rights activist is asking a Seminole County judge to restrict visitation rights of the couple's two minor children. Ronni Sanlo, exexecutive director and lobbyist for the Florida Task Force and currently founder and director of the Education Association for Gay and Lesbian Studies (EAGALS), claims the requested family court action may violate First and Fourteenth Amendment rights in regards to her right of free speech and freedom of association.

"My pain is that my beautiful children have become victims of their father's bigotry. I lived in my own closet for 31 difficult years. When I finally emerged, I had my freedom, but little else. . . I lost my babies, my home, my financial security. I had my clothing and my freedom, nothing more.

John Sauls Jr. was divorced from Sanlo Aug. 1, 1979. The divorce was uncontested as to the disposal of property, Sanlo says, and custody of the two children, a girl, 10, and boy, 7, was awarded to Sauls. Sanlo says her willingness to lose custody of the children was based on the liberal visitation policy made part of the agreement. She also claims threats of a bitter court fight based on her homosexuality were made by the children's paternal grandparents, Mr. and Mrs. John Sauls Sr. of Sanford. This fact, she says, and the desire to prevent the children from becoming "pawns", made her consent to the husband's custody.

Sanlo says the divorce decree allowed her two days a week visitation plus alternating holidays and 30 days out-of-state temporary custody. The decree also said weekly visitation "could not interfere with school." Sanlo said the visitation rules became a burden because of the "school stipulation" and the forced attendance of the children to Sunday services at the "Sanford Bible Church", a small, fundamentalist congregation whose building is owned by the senior Sauls.

Sanlo recently asked the court to modify the visitation rules allowing her to have the children every other weekend and also asked for clarification of the holiday rules. Her request was answered with a counter motion asking that the court allow visitation "to the Wife under strict guidelines that will protect the best interests and welfare of the children." Sanlo says this may mean not allowing the youths to visit in her house she shares with her female lover or perhaps not allowing the lover to be present during visits.

In his petition, Sauls claims "the Wife has been active in the Florida Task Force and similar organizations, which activities are confusing to the children and taint the fitness of the wife of the Wife to exercise parental responsibilities."



Ronni Sanlo 'Children victims of. . .bigotry'

Before joining FTF, Sanlo was executive director of Gay Community Services (GCS) of Central Florida, Inc. He also claims "visitation in the house of the Wife develops confusion in the minds and attitudes of the children and causes them to return home with unending questions about sex, morals, religion, and the living arrangements they have viewed ..."

Sanlo claims she has been loving and open in regards to answering the children's questions. She states she has attended parent-teacher conferences for both children on a continuing basis and has supported school plays and other activities, something, she says her ex-husband has failed to do.

Sanlo also says her former husband has told the children not to kiss their mother or her lover, telling them, Sanlo says, "that queers have diseases." Sanlo said the warning apparently came as a reaction to the AIDS problem.

Sanlo said it is possible that the matter could go into binding mediation as part of the court process. If that approach



Suspects await trials in Gay murder cases

Four men are awaiting trial in first degree murder charges involving homosexual men during the past two years. The recent arrest of Calvin Banks, 22, in connection with the Feb. 10 stabbing death of Joseph Kulka was the latest law enforcement success in the five Orange County murder cases (See related story)

Donald William Dufour, 26, of Orlando, is a inmate of death row in Mississippi's state prison. Pending appeal, he will be executed for the murder of two men Oct. 13, 1982, in Jackson, Miss. Dufour is also indicted by an Orange County grand jury for the murder of three men in Orlando. Orange County Sheriff's detectives worked the case.

Dufour is accused in the murders of John Stinson and Edward Wise in their Orange County house. Their bodies were found July 26, 1982, They had been shot and stabbed.

Dufour also stands accused in the southeast Orlando organe grove killing of Zack D. Miller, 26, of Boston, Ga. He had been stabbed to death. Police say that Miller may have picked up Dufour in a local Gay tavern. Miller was murdered Sept. 6

Dufour is also facing a Georgia murder indictment for the shooting of Carl Williams, 22, of Orlando whose bullet-ridden body was found near Woodbine, Ga. in June 1982. Williams and Dufore were allegedly members of a loose-knit gang believed responsible for several robberies and other crimes in the Orlando area during 4982.

Another gang member arrested with Dufour, Robert Taylor, 22, of Orlando, has been sentenced to two life sentences in connection with the Mississippi deaths. He also faces ac-

tive indictments in the thre Orlando murders. Taylor received the life sentence in exchange for his evidence statements in the case. He had been facing the death penalty before turning state's witness.

Tim Hetz, press information officer with State Attorney Robert Eagen's Orlando office said because no statute of limitations exists on the murder charges, the men would be returned to Florida should they ever be released from custody in Mississippi. He said such release was unlikely.

The murder trial of William John Sakosky, 21, of Scranton, Pa., is expected to begin Sept. 12 in Orange County circuit court. He is charged with the bludgeoning death of Paul Carlisle, 25, of Fort Lauderdale, Nov. 3, 1982 at Orlando's Parliament House Resort.

Spokesperson Hetz said Sakosky has been awaiting trial in the Orange County jail after his successful extradition from Pennsylvania earlier this year. Sakosky was arrested by Scranton authorities Nov. 6. He was driving Carlisle's car. Orlando police investigators handled the case.

Calvin Banks will face trial Oct. 25, according to Hetz. Banks reportedly offered a confession in the Kulka murder and may not face a judge or jury. Hetz said that prosecutors are examining the statement and circumstances around the Feb. 10 murder to determine if a capitol murder (death penalty) request is warranted. Banks is also being held in the Orange County Jail in the Orlando Police case.

One murder case continued to elude detectives' solution. No arrests have been made in the murder of Donald Biggers, 46, of Windermere. His body was found in his waterfront house on Lake Butler, May 20, 1981. He died of multiple stab wounds, investigators say.

Spotlight on **Gay Central Florida** Dead man's ring links murder suspect to crime

Calvin Banks, a former Orlando resident, has been charged with the first degree murder of Joseph Kulka, 29, who was found dead in his house at 600 Avalon Blvd. Feb. 13. Banks, was arrested in Fort Lauderdale July 15 after an intensive nationwide search which lasted almost six months. He has been indicted in the case by an Orange County grand jury. He could face the death sentence if convicted of the crime.

Orlando Police detectives credited thorough investigation techniques who providing the link between Kulka and Banks; a custom-designed diamond ring.

Police theorize that Kulka was driving along South Orange Blossom Trail July 11, when he picked up Banks. The two men went to Kulka's modest frame hosue in southeast Orlando for a sexual encounter. Police say Kulka was homosexual and Banks "was a street hustler looking for a quick buck."

When a friend stopped at Kulka's house Feb. 13, she found the door ajar and Kulka's body in the bedroom. He had been stabbed repeatedly and died of his wounds.

Kulka's car, stereo, and jewelry, including the ring were taken from the house, police say, claiming robbery to be the motive for the crime. The car was found Feb. 13 near Lake Eola, perhaps left there to make police suspect male hustlers who frequent the area.


Investigators reportedly questioned some 200 persons, many from the Gay community, in relation to the case. Because Kulka was known to frequent South OBT adult bookstores, police interviewed employees from motels, book stores, and night clubs for two days attempting to find anyone who saw Kulka the day he disappeared. They had no success.

Police also sent flyers to pawn shops in central Florida describing items taken from the murder scene. A break in the case came at the end of February when an Orlando pawn shop owner said he had a ring that matched the artist's drawing police had circulated. Pawn records showed the ring had been hocked by Banks who had listed an Orlando address. A police check found Banks had moved, leaving no good forwarding address.

Banks eluded police despite bulletins citing his connection to the murder and asking for his detention which were sent to all 50 states. Early in July, police reportedly received a call from an informant saying Banks was in Fort Lauderdale. After securing a warrant for his arrest and contacting Fort Lauderdale police, Banks was taken into custody in a motel in that south Florida city. He reportedly did not resist arrest.

Orlando Police Detective Sgt. David Smith was quoted as saying "Gays. . .were playing Russian roulette," when picking up people off the street. "Kulka just picked up the wrong guy. . . it could happen to anyone.'

Before his death, Kulka was employed as a unit supervisor at Sunland Center, a state-run care center for the physically and mentally retarded, where he was considered a "very good" employee.

Joy MCC begins search as Radclyffe resigns

New Direction Managing Editor Rev. Nancy Lila Radclyffe, pastor to Orlando's Joy Metropolitan Community Church (MCC) will bid farewell to the congregation Aug. 21. Radclyffe, who assumed her local duties in February, 1982, has accepted the post of Senior Chaplain for th MCC's Spiritual Life and Clergy Care Center, a program she designed, and will be moving to the Los Angeles area to begin its implementation.

The concept is built on the idea of proving both physical and spiritual rest and revitalization to members of the denomination's clergy. It will be funded out of monetary gifts as well as funds from the Universal Fellowship of MCC. Radclyffe submitted her plans for the program almost two years ago. The plan was fully authorized earlier this year.

"I'm hoping that the program will become preventative in nature instead of rehabilitative. I want members of the clergy to be able to find assistance and comfort before they have problems of either a physical or spiritual nature," Radclyffe said.

Speaking of her 17 months in Orlando, Radclyffe said she felt her direction in "helping the Joy congregation fully assume the responsibility of their church, including the establishment of solid business practices and procedures" was one of the main accomplishments of her tenure.

"With attendance to services averaging 80 persons and with membership in the church at 55 people, Joy has become markedly stable. It appears that the church

is here to stay." The congregation meets for Sunday evening services and Thursday evening bible study at the New Age Community Center, 2500 Curry Ford Road at the corner of South Bumby Ave. Joy MCC is one of 11 similar congregations meeting in Florida.

Radclyffe said she expects Joy MCC to play "a vital role" in the growth of the Gay and Lesbian community as Orlando, matures into a greater city. "I have been in towns with more (Gay) community than this one", she said. "I believe as the city grows larger and more diverse, the size, and especially the quality, of the community will also grow.'

She said a pressing need, yet unanswered in Orlando, is for a more permanent church office space for day-to-day operations. She also said her work load in helping to stabilize the local congregation had given her little time to make contacts with other local churches and their pastors.

A pulpit committee has been formed by the local congregation in order to select a new pastor. Radclyffe said that several candidates have already made contact with the selection committee for consideration. She said she expected the new pastor to join Joy within a month after her departure.

Radclyffe and her lifemate, Kerry Brown, are expected to leave the Orlando area during the last week of August. Brown has been active in lay operations of MCC and is assisting in the marketing of the upcoming television special prepared by MCC entitled "God, Gays, and the Gospel." The one-hour program is expected to be released this Fall.

DAYTONA BEACH - The Blessed Redeemer Metropolitan Community Church, has closed its doors from lack of financial support.

The Rev. Arthur Fleschner and the handful of parishioners who make up the church's nucleus attribute its demise to the transient and "closet" character of the local gay community but predict that MCC will return to Daytona Beach.

Started in Fleschner's apartment a year ago, the Daytona church struggled from the onset with mounting bills and dwindling attendance. The bills increased when the membershp grew to 30, prompting a move to a storefront location.

"I couldn't find a host church to house us. In Orlando we rented space from the Unitarian Church for \$20 a week, but I didn't find the same response here. One minister did go to his board and tried to help us but most said they were full. Some

of their attitudes told me they didn't want me under and circumstances," said Fleschner, who started the MCC in Orlando in 1979.

Ironically, the move spawned by growth in January dealt a severe blow to the church, a member of the 196-strong Universal Fellowship of Metropolitan Community Churches spread across eight countries. About 15 people dropped out, about half of whom couldn't handle meeting openly, Fleschner said.

'In my apartment they were safe, secluded," he said. "When we moved, they were out in the open."

Despite regular offerings from 18 members, the church consistently has been \$50 to \$100 short of the \$89 needed each week to cover expenses for rent, utilities and supplies, he said.

'The decision to close wasn't easy but the financial pressure on thse 18 was so outstanding that the church was becoming a burden rather than joy."

Studds courage and his commitment to stay in office despite calls for his resignation provide a good model for us all.



Being Gay may aid in aging process study claims

Until recently, little was known about older Gay men. Professionals and lay people alike assumed that Gays became increasingly lonely and isolated as they grew older. While some believed that Gay men became sexually aggressive as they aged (particularly with young boys), others believed that they were asexual. Most people, even Gays themselves, assumed that older Gays were sick and unhappy. They were said to hide their homosexuality from others at all costs. And the horror of aging was believed to strike even earlier for Gays, who were considered "old" as early as thirty-five.

A provocative study recently published by the University of Illinois Press, *Gav and Gray: The Older Homosexual Man*, by Dr. Raymond M. Berger, Assistant Professor of Social Work at the University of Illinois,

Scooter's World

is the first major study of aging homosexual men. It is already well on the way to enlightening public attitudes about a long misunderstood minority within a minority.

Berger's startling findings have uprooted these notions. Most older homosexuals live with a lover, or with roommates or family members. Few are socially isolated. Contrary to popular belief, a third of these men had been heterosexually married, and many had children. There were few differences in psychological adjustment between older and younger homosexuals. And older homosexuals were actually more "open" about their preference than younger Gays. They were more widely known to others as Gay and less worried about being "exposed." The majority continued to lead active sex lives, primarily with age peers, and they reported high levels of sexual satisfaction.

Berger presents these findings in his analysis of questionnaire responses from 112 Gay men over the age of forty.

Do homosexual men find it easier than heterosexuals to adjust to aging? Berger carefully explains why this may be true. Unlike their heterosexual counterparts, most Gay men face a crisis of independence early in their adult years. Since they are less likely to rely on traditional family supports, they learn independence skills and also learn to rely on traditional family supports, they learn independence skills and also learn how to cultivate supportive friendship networks. These factors help them to adjust well to the losses of old age. In addition, having accepted an identity which is believed to be "unmanly," they are less traumatized by the loss of virility which accompanies old age. Their enhanced

capacity for male-female role flexibility makes older Gays less likely to be dependent on a "wife" or "husband," and thus better prepared to survive loss of a partner. In fact, further study of older Gays may illuminate adaptational patterns which are useful to older heterosexuals and homosexuals alike.

In addition to examining the advantages of aging for Gay men, Gay and Gray also discusses common psychological problems and describes an emerging network of self help gorups and social services for this group. Berger shows that while older heterosexuals and homosexuals share common needs (the most salient needs of both broups are related to health and finances), the trend for specialized services provided by the Gay community itself is necessitated by a lack of responsiveness on the part of mainstream social service agencies.

With the elimination of serious childhood diseases, most people today reach adulthood in good health and maintain it until about age 30, when a slow, inexorable decline sets in. But recent research presents the intriguing possibility that high-level nutrition may actually slow the aging process and lengthen life. By combining proper diet with regualr exercise, no smoking and limited use of alcohol, many nutrition experts now believe we could add 10 or more healthful years to the average lifespan. And age-related diseases such as cnacer, arteriosclerosis, diabetes and osteoporosis could be postponed, possibly eliminated.

The most important ingredients in the diet may the smallest—the approximately 30 vitamins, minerals, and trace elements needed to sustain life and maintain proper functioning of cells, tissues and organs.

Diet is the ideal way to get one's needed nutrients, but a number of factors interfere with this goal. Habits such as heavy smoking and drinking greatly increase the need for vitamins C and B respectively. Methods of processing, storing, and cooking can strip food of vital nutrients such as bran, vitamin E and magnesium. Excessive use of some vatamins or minerals, like phosphorus, can cause deficiencies in others, such as calcium. And the aging process itself can interfere with absorption of certain substances.

So it is sometimes necessary to supplement diet with vitamin or mineral tablets. All vitamins, minerals and trace elements play an essential role in maintaining good health. But certain nutrients have been shown to have "anti-aging" properties. They improve our ability to resist diseases and may help prevent many of the conditions associated with age, from skin wrinkling to senility. What they may do for you is outlined below.

"Slave" buyers may "own" their purchases until daybreak, Aug. 28. "Slaves" have the right to refuse any request to perform duties not in their best interest.



The Pensacola challenge

Club visitor finds little hospitality in panhandle's **Red Garter nightspot**

NEW DIRECTION roving writer Frank Steiner recently visited the panhandle area of Florida where he found Pensacola club life a little depressing. This is the first of several reports on various Gay and Lesbian entertainment spots through the state. Steiner will go beyond the decoration and music systems in discovering what makes certain clubs more a success or a disappointment. The comments are those of the author and do not reflect the position of New Direction or its publishers. - Editor

If you grumble and complain about this bar or that other in Orlando;" the service is bad," "they're slow," "too many people" or some other minor inconvenience. A visit to The Red Garter in Pensacola, in the panhandle of our state might open your

The greeting at the door was a genuine and friendly welcome. There was a two dollar charge which wasn't bad and the club, itself, was a nice one, though a bit small for the size crowd they attract.

The show was impressive and the disco dance floor was busy. There was a pleasant patio and a few video games as well as a couple of pool tables. The place was shoulder to shoulder in the disc.

As I wandered through the place, I came to settle near one of the pool tables and struck up a conversation with a couple of the locals. About ten minutes later, two uniformed guards, whom I thought at first were police, walked briskly past. One man held a nightstick tightly in his hands, ready for use and he was followed by the second with a metal flashlight that he was holdilng

by the head, again ready to swing. "Must have been some trouble," I thought.

About thirty minutes later, the scene was reported with the guards, once again at the ready and glaring at the customers.

I began to feel a bit uneasy.

After a third repeat of this, I asked two

guys if they knew what was happening. "This is a regular thing," I was told. In the course of the evening, the guards make their regular rounds with the same attitude and arrogance as I had noted, about every thirty minutes.

In milling about the crowd, I was astonished to find out that the guards were actually security that the owner had hired.

I was told that the owner is straight and had an alleged dislike for gays. He did not have apparently a dislike for their money.

The owner's wife works as a bartender at The Red Garter and has refused to hire any other females, in any capacity.

"We used to have nice bartenders and waiters here," stated one of the customers. "We signed a petition with over a

thousand names asking for our old waiters and bartenders back, but the owner laughed and threw it in the garbage," a third spoke up.

"Why don't you go to another bar," I asked

"There isn't one except in Mobile, Ala. which is over a forty-five minute drive and several of our group will drive over there instead of coming here," he said.

During the evening, I had a chance to see what they meant by the actions of the waiters. One of the customers I was talking with ordered a drink costingd \$2.50. He handed the waiter \$3 and told him to keep. the change. The waiter returned the customer the change and said, "If that's all you're going to tip, keep it." He walked off. This was repeated by other waiters.

The bars close at two A.M. and the DJ was making nice prods to get the people out the door.

The crowd was moving out, however it was not fast enough to suit the security and in less than five minutes, they were blowing whistles in the ears of the customers, shouting derogatory remarks and physically grabbing people and shoving them out the doors, causing people to stumble and trip as they left.

One reached for me and I looked at him and said none to softly, "Don't you do it."

Once outside, I continued to talk to many members of the gay community and the concensus was the same throughout.

If a person had the resources, he should open another gay show bar and disco there. The Red Garter would probably go out of business the first week and the new place should make it big.

Gays slow to use new hepatitis vaccination

With an estimated 5,000 deaths a year attributable to hepatitis B and related complications, and about twenty per cent of those thought to be among gay men, few gays have taken-the recently introduced Heptavax vaccine. This was the observation of medical researchers on a panel at the recent Fifth Lesbian and Gay Helath Conference in Denver.

Dr. David Ostrow, Research Director at Howard Brown Memorial Clinic in Chicago headed the panel. In his clinical research, Dr. Ostrow found that gay men who do not have the hepatitis B antibody are at a very great risk for contracting hepatitis, perhaps as high as one chance in three during the next year.

Ostrow says that though age makes no difference in susceptibility to the virus, the highest risk group is gay men who are in their first few years of homosexual activity. Ostrow says that his studies have shown that many men who have been sexually active for a long time have actually developed the antibody and are protected from the disease because they may have had mild cases of the disease without being aware of it. Others, however, may die of the disease, although that is rare. Still others develop symptoms that appear chronically, or they become carriers with no observable illness, but can infect their sex partners.

Dr. Frank Judson of the Denver Metro

Health Clinic said his studies have shown that gay men who engage in oral-anal contact or in passive anal intercourse appear to have the most susceptibility to the disease, probably through the ingestion of fecal material contaminated by blood from small tears in the rectum. Judson said that while male homosexuals are the single most susceiptible group to hepatitis B, with over twice the risk of hospital workers, about 85 per cent of all hepatitis B vaccine administered to date has gone to health workers. Judson says this is so in spite of programs to reduce the cost of the Heptavax innoculations for gay men who want them at his clinic.

Judson said that ironically, many people would rather spend the \$100 to \$150 cost of the vaccination series on tuning their cars. He said such vaccines are "the most cost effective feature in the health care system.'

Dr. Arlene McLean of Merck Sharp and Dohme, the pharmaceutical manufacturer which developed the vaccine, presented comprehensive information on the development of the vaccine, attempting to allay fear that the vaccine, produced from blood serum collected from persons who are active carriers of the disease, may be a hazard for AIDS. Many donors for the vaccine are gay men. Dr. McLean described the technique by which the vaccine is purified. The vaccine is subjected to three separate processes which destroy any known virus. McLean said no other vaccine has even been so thoroughly putified before testing. In addition, McLean said


that testing the first 19,000 recipients of the vaccine, not one persons became seriously ill

McLean said that of 200,000 doses administered, only two gay men from New York have come down with AIDS. It is not considered at all likely they got AIDS from the vaccine. McLean said that follow-up studies are currently underway through one of the blood centers from which the blood products for the vaccine were taken to see if any of the donors get AIDS.

Dr. James Curran of the Center for Disease Control in Atlanta said, "The bottom line is that hepatitis B is a killer. Sexually active gay men should get the vaccine today." Curran said that most deaths

resulting from hepatitis B are due cirrhosis. He thinks that gay men will soc account for half of all liver cancer in th country due to hepatitis B. Curran claime that the Heptavax vaccine is "one of th safest vaccines available."

Curran also said that one study seeme to show a relationship between the vaccir and a lower incidence of AIDS, however said that no such claims are valid based of known facts. The researchers noted with irony that gay men are ignoring or preventive technique for a serious diseas even as they are consumed with concer about AIDS for which there is no know prevention beyond lifestyle changes.



Men and masculinity conference centered on Michigan campus

The Eighth National Conference on Men and Masculinity will be held at the University of Michigan in Ann Arbor from Aug. 11-15, 1983. The conference theme is "Men' Cooperating For A Change: New Roles, Responsibilities, and Rewards New Images and Ideals."

Like its predecessors, this will be a conference of men supporting men who are exploring their options as human beings in solidarity with the women's, gay, and other progressive liberation movements. Unlike earlier conferences, this will be the First

National Conference of the (as yet-unnamed) National Men's Organization. The organization was formally announced at the last national conference in Boston in June 1981.

Between 500 and 1,000 people are expected to attend the five-day event. Among the highlights will be the official vote to name the national organization. A computer teleconference will be started to provide a means for an ongoing national network. Events that have helped make National Men and Masculinity Conferences exciting, growth-producing experiences will be repeated including workshops, playshops, celebrations demonstrations, panels, films, plenary sessions, and offerings from many of the cultural workers in the movement.

Housing will be available for over four hundred people in a dorm reserved for the conference. There will be other housing available in private homes and in hotels.

Survey may spotlight homophobic counselors

Many counselors in the school system are notoriously homophobic. It is nearly impossible for a student who suffers from anxieties of any kind to approach a school counselor, because the reality is that school counselors are not encouraged to maintain confidentiality and they are too wrapped up in paperwork to deal with personal problems of students.

These are strong statements, particularly since many school counselors choose such a career primarily to meet the needs of students from a more personal perspective. But 95% of a counselor's work seems to be "administrivia" paperwork, allowing only 5% of the time to be spent on student's personal needs. Additionally, as was generally agreed upon by nearly 100 counselors at the 1981 Florida Personnel and Guidance Association Conference workshop which dealt with counseling gay kids, many counselors do not respect confidentiality ("...information filters from the counselor's office to the teachers' lounge in a matter of minutes..." - a high school counselor), nor do the nature of the school files and state laws allow for confidentiality. Finally, when asked the number of gay kids the counselors facilitated last school year, many responded, "None. There are no gay kids in my school!"

This project will prove that there are, indeed, gay kids throughout Florida's school system, and that school counselors are not empathetic enough, knowledgeable enough, or sufficiently trained to handle the needs of lesbian and gay students. The project will create a training program for school counselors; providing them with a knowledge of history, legalities, aid in dispelling myths, provide resources, and actually train them to counsel Gay youth in a confidential, non-judgemental manner.

The adjacent questionnaire is needed to prove the first hypothesis: that gay kids do exist. If you are under 25, please fill out the questionnaire and return it to EAGALS, P.O. Box 434, Pierson, FL., 32080. Your name need not appear on the questionnaire. If you wish to be contacted for further participation or for appearances on a video-tape, please indicate.

The survey is important. The entire project, dealing with the issue of homosexuality in the schools, is a first step on the road to social acceptance through education and understanding, by Gays and non-Gays alike. The findings of this study, as well as the publication of the Gay and Lesbian Studies, Inc. (EAGALS.)



The Guinness Book of World Records - that far-out chronicle of the weird, the wacky, the wonderful - has a challenge for you wherever you may live, whatever your life-style, the records that need breaking number in the thousands and often require no extra-



ordinary physical prowess, manual dexterity or mental capacity -JUST DETERMINATION, SPUNK AND PLANNING. Simply follow these guidelines, and group fame may be within your reach!

• Make your quest for fame a group affair. Remember, marathon record-breaking attempts can often be lonely and tiring vigils. A cheering section is essential, especially between the sluggish hours of 3 and 6 a.m.

Beeline Restaurant

BY CURT BOCKES New Direction Staff Writer A few years back, when I was still a "Snowbird," I had Mexican neighbors. I still remember Juanita's steaming tamales, refried beans, tacos, and fried rice. The food couldn't have been more authentic. My favorite place to go for Mexican food since moving to Orlando has become the Beeline Restaurant.

Small and seemingly antiquated, the interior consists of four rows of three booths each, encased on two sides by booths which openly face the interior. These side booths are roofed by sombrero bedecked wooden porches. It provides that "South of the border" flavor. Feel comfortable wearing shorts and flops.

You simply must try the **avocado dip**. Served with a basket of home-fried tortilla chips, it makes a cool and refreshing appetizer. Squeeze a little lemon on the dip and dig in.

I like to get the soft tortilla as-hot and buttered--put a teaspoon or so of the Guacamole dip on them, then role the tortilla. It's a tasty little variation. Even with extra cheese, the refried beans are lacking. I realize there's not a whole lot one can do with beans, but Juanita's weren't as flat. For your entree, go for it! Enchiladas, tacos, chalupas, and burritos. Mix them or have a dinner of one dish. At the Beeline you'll find great Mexican food with that home-cooked flavor. I'm partial to soft-

shell dishes, but the Beeline makes a great taco.

Here's a bit of information which might interest you. The dishes the Beeline puts

out are not highly seasoned. They are not spicey hot, so for those of you with tender

taste buds you can visit the Beeline. If you do like spicey Mexican food, don't despair.

On your table you'll find mild and hot spices. Season your dishes to suit your own taste buds. It makes life so much simpler.

The Beeline is open Tuesday through Saturday from 5:00 P.M. to 10:00 P.M.

Location: 4542 Hoffner Road, just "2/10 of a mile east of Conway."

Only Mexican food is served, so don't take along someone who doesn't care for

it. Beer, including Mexican beer, wine and soft drinks are available. The Beeline is, I

believe, a great, quaint place to go for a good meal. For me, it's almost like return-

ing north for "south of the border" cooking.

Dinnerware Plus offers discount table elegance

New Direction writer Scott Drakes begins a new column with this issue, aiming at finding special shops and services of interest to Gay and Lesbian consumers throughout central Florida. He will be making a special effort to find those businesses offering especially good values to shoppers - The Editor.

Dinnerware Plus is one of the few stores that I can think of which describes what it has to offer with its name. Practically everything one would want for table and service use can be purchased there.

Dinnerware Plus also has an additional advantage, it is located in Orlando's Factory Outlet Mall on Oak Ridge Road. Factory outlets are fast becomming popular in this country, and with good reason. You often still get the quality merchandise with a substantial savings.

Entering Dinnerware Plus, the first thing that is likely to strike your eye is the large display of stemware. Westminister crystal stemware is a real special for six dollars a glass. Normandy and Versailles, both full leaded crystal, are at live dollars per glass. This is about a sixty-five percent savings.

The layout of the store is quite simple with no built in dividers and makes you want to wander around. Each area, however, with its own organization, has a potpourri of designs, styles, colors, shapes, sizes and price for everything.

There are over a hundred different styles of dinner sets available not including stoneware, which is in it's own area. With prices starting at sixty dollars for a twenty piece set to three to four hundred dollars for a forty-five piece set. Quite a number of very nice designs fall between sixty and one hundred dollars for a twenty piece set.

A twenty piece set includes four each of dinner plates, salad plates, cups, saucers, and soup bowls. A forty-five piece set includes eight each of the same and also matching serving platter, vegetable bowl, sugar bowl and lid and a creamer. Anything bought individually, whether adding to your set or replacing a broken piece, can be purchased at forty percent or higher discount.

Stoneware pieces start at about \$2 a piece. These are generally displayed en mass, so you may want to do a bit of digging through to find something special. Stoneware is micro-wave safe, too.

A dinnerware store would not be complete without a selection of serving trays, bon bon trays, platters, serving bowls, and the like. There are also small chip trays and punch bowls available.

Dinnerware Plus could quite possibly be your first and last stop for dinnerware settings if you're in the market. Depending upon your personal tastes, I think you'll find that most of your dining foom needs can be met at this popular store.

Military regulations cloud justice for Gays in service

Although the gay rights movement has been changing the way that gay men and lesbians are treated by the military, (i.e. an honorable discharge instead of an undesirable one), being gay and active duty is still not looked upon with favor by the Joint Chiefs of Staff.

This article is not an attempt at a definitive guide to military law and how it relates to gay men and lesbians, but rather is some advice concerning immediate measures that you should take if you find yourself and your sexuality in question by your command.

The primary bit of advice that you should follow is DON' T TALK. It's just like those police shows on TV, "... anything that you say can and will be used against you..." Regardless of what the questioning authorities tell you, they are not your friend, and talking to them will not make it easier on you. Do not help them do their job. Regardless of what they tell you, you dohave the right to remain silent. You are protected under the 5th Amendment and also Article 31 of the Uniform Code of Mihtary Justice.

If you are considered a suspect or have been formally accused (the questioning authority **should** inform you of this), get a

lawyer. The military will provide you with a military lawyer, or you can request (in most cases) a civilian lawyer (which you will pay for).Refuse to continue the questioning until you have talked to a lawyer and have him/her present during any questioning. The questioning authority may suggest that you talk to your Commanding Officer, your Division Officer, a psychiatrist, a doctor, or the Chaplain, but this is not advisable until you have talked to your lawyer.

Once you have been formally accused of being gay, you have two options to take: 1) fighting the charges or 2) admitting your sexual orientation and taking the discharge. Both of these options have their advantages and disadvantages, and neither of them is an easy decision. Before making a final decision, talk over your options with your lawyer, your friends, your family (if possible) and any one else whom you respect and feel comfortable with.

Of course the best advice is not to get caught, and keep your sex life off the base, but if you find yourself in trouble, remember that you do have rights (even in the military) - so use them.


