Toymaker on North Henry Street sold to CW

Richard E. Gunn of Williamsburg has announced the exchange of the Toymaker of Williamsburg building on North Henry Street to the Foundation for a property owned by CW at the Williamsburg Office Park on Jamestown Road.

The building is on about 1/4 acre of land immediately adjacent to the Governor's Inn and just to the north of the CSX Railroad right-of-way. It has about 80 feet of frontage on Henry St. and is zoned for general business.

As a part of the agreement, Gunn has the right to remain and use the premises for the next two years. According to Richard A. Schreiber, chief business officer, the property will figure in the hotel's future expansion plans.

In 1962, Gunn purchased the business and eventually opened a second major store in Merchants Square. The Toymaker's Merchants Square Store is not affected by the transaction.

Tazewell Club Payroll Deduction plan offered to employees

Open Enrollment is happening now!

Report ALL wages to the VEC

If you receive unemployment compensation benefits, the Virginia Employment Commission (VEC) requires that you report all wages on a weekly basis.

These wages include cash tips, service charges, banquet income, regular wages, commissions, bonuses, back pay, severance pay and any other payments made by an employer. When your initial claim is filed with the VEC, they will explain how to report these wages.
